Statistics

Arrests included: 9 for public intoxication, 8 for violating probation or parole, 5 warrant arrests, 3 for drug influence and/or possessing drug paraphernalia, 2 for shoplifting, 2 for battery on school grounds, 2 for possessing methamphetamine, and 1 each for; possessing an illegal weapon, hit and run, violation of court order, trespassing, indecent exposure, and battery. Probation or parole holds were placed on 3 of these arrests.

Officers investigated 6 traffic collisions, and 1 hit and run traffic collision. Four vehicles were impounded for 30 days due to the drivers being unlicensed or suspended.

Officers took reports of: 12 child neglect, 7 vandalisms, 7 found property, 3 burglaries, 3 suicidal persons, 2 animal bites, 2 thefts, and 1 each of; missing person, child molest, and abandoned vehicle.

Officers assisted the Mendocino Major Crimes Task Force and County of Mendocino Marijuana Eradication Team with service of a search warrant.

Highlights for the Week

On April 26th at about 1:45 AM Ukiah Police responded to Taco Bell, at 1201 North State Street, for a disruptive female at location. Officers learned 45 year old Marcia Sue Stockhoff, of Lake County, was observed by employees sitting below the drive through window panhandling customers for money and cigarettes and refused to leave. Stockhoff then forced open the drive-through window and climbed into the business, took some prepared food, and began eating it inside the closed lobby area. Stockhoff again refused to leave and was behaving irrationally, and began pulling away from officers as they took her into custody. Stockhoff was taken to the County Jail, where she physically resisted the booking officers and grabbed an officer by the arm and caused several scratches. Stockhoff was booked into the County Jail for trespassing, theft, resisting arrest, and battery on a peace officer.

On April 28th at about 12:30 AM Ukiah Police responded to a residence in the 700 block of Waugh Lane for a reported disturbance. Officers contacted 28 year old Joshua Alan Perdue outside the residence, found him to be overly intoxicated, and subsequently arrested him for public intoxication. Officers then contacted 32 year old James Wesley Doyle who was determined to be a visitor at the location, and found him also to be overly intoxicated and arrested him. Doyle was on parole and a charge of violating parole was later added to Doyle's charges. Officers determined Perdue's 6 month old child was present at the location and additionally charged Perdue with child endangerment due to his inability to provide for his child due to his level of intoxication. The child was released to the custody of Child Protective Services.

On April 28th at about 8:55 PM Ukiah Police responded to the area of South Dora Street and Wabash Avenue for a go-cart being driven in the area. Officers

observed 23 year old Nicholas James Lyon driving a small go-cart in the 300 block of Wabash Avenue, noting the go-cart was not equipped with any lighting, and was very low to the ground making it hard to see by other drivers. Lyon stopped the go-cart and exited while placing an open beer can on the ground, and began pushing the go-cart towards the officer. Lyon had been drinking, and was found to be too intoxicated to drive and was arrested for DUI.

On April 29th at about 9:00 PM Ukiah Police stopped a vehicle driven by 38 year old Alfonso Daman Sandoval, in the 300 block of East Gobbi Street. Sandoval had a warrant for his arrest and was driving with a suspended driver's license. The interior of the vehicle smelled of marijuana, and a small amount was found within the vehicle. Sandoval possessed a usable amount of methamphetamine on his person, and a methamphetamine smoking pipe was also located in the vehicle. Sandoval was arrested for possessing methamphetamine and drug paraphernalia, and for driving with a suspended driver's license.

On April 2nd at about 10:30 PM Ukiah Police responded to the Ukiah Valley Medical Center for a suspicious male observed standing outside wearing no clothing. Officers learned a nurse saw 68 year old John William Driggs outside the facility naked, and approached to help thinking he may be patient. While the nurse was covering Driggs with a blanket he made several hip thrusts towards the nurse, and he later told police he wanted to "sexually assault" women. It was determined Driggs was on parole and had recently cut off his GPS ankle monitoring bracelet. Driggs was arrested for indecent exposure and for violating parole.
