### **Patrol Division Weekly Activity Report 5/3/12 to 5/9/12**

### **Statistics**

**Arrests included: 15 for public intoxication, 6 for domestic violence, 4 for drug influence and/or possessing drug paraphernalia, 3 warrant arrests, 3 for fighting on school grounds, 3 for shoplifting, 2 for violating probation or parole, and 1 each for; possessing an illegal weapon, robbery, possessing stolen property, and possessing a weapon on school grounds. Probation or parole holds were placed on 6 of these arrests.**

**Officers investigated 3 traffic collisions, and 2 vehicles were impounded for 30 days due to the drivers being unlicensed or suspended.**

**Officers took reports of: 7 vandalisms, 5 thefts, 4 child neglect, 4 burglaries, 4 found property, 3 abandoned vehicles, 2 suicidal persons, and 1 each of; missing person and domestic violence.**

**Officers assisted the California Highway Patrol with a drug search utilizing the department's K9 team.**

### Highlights for the Week

On May 3<sup>rd</sup> at about 4:05 PM Ukiah Police responded to a residence in the 300 block of South Spring Street regarding a domestic violence incident. The victim reported that during a domestic argument 29 year old Salvador Alfaro grabbed the victim by the throat. Alfaro then pushed the victim down still holding her throat, and held her down refusing to allow the victim to stand up. Alfaro forcefully removed a cellular telephone from the victim's hand causing a scratch to the victim, then threw the phone at a 4 year old child who had heard the struggle and approached. The thrown phone struck the child's foot causing a minor injury. The victim was able to free herself and left the residence and went to a neighbor's house, and Alfaro soon also left. Officers located Alfaro in the 1300 block of South State Street, and arrested him for domestic violence, restrained imprisonment, child endangerment, and for violating probation.

On May 4<sup>th</sup> at about 7:10 PM Ukiah Police responded to the McDonalds at 1310 North State Street regarding a vehicle colliding with part of the building in the drive through. The suspect vehicle was described as black GMC Yukon and had fled the scene on Empire Drive. Officers located the vehicle as it turned onto North Bush Street and it accelerated to about 50 MPH. Officers attempted to stop the vehicle which continued onto Arlington Drive before stopping. The driver, 25 year old Carl Burleson, had been drinking and was found to be too intoxicated to drive. Burleson's vehicle had sustained minor damage from the collision, and he was arrested for DUI and hit and run.

On May 6<sup>th</sup> at about 8:40 AM Ukiah Police responded to a residence in the 200 block of Clara Avenue regarding a domestic violence incident that occurred the night prior. The victim reported 27 year old Jose Huerta Romano had come to the residence intoxicated very early that morning. The two argued and Romano retrieved a kitchen knife and held it to the victim's throat, telling the victim he

planned to kill her. The victim sustained a minor injury to her neck from the knife, and fled the residence once Romano removed the knife. Romano also left the area, and later that afternoon contacted the investigating officer at the Ukiah Police Department. Romano admitted his actions, and was arrested for domestic violence, criminal threats, assault with a deadly weapon, and an outstanding warrant.

On May 7<sup>th</sup> at about 1:25 PM Ukiah Police conducted a probation search at a residence in the 100 block of Laws Avenue. Officers contacted 21 year old Manisha Princess Anguianocan, of Potter Valley, and arrested her for an outstanding warrant. Anguianocan possessed a methamphetamine smoking pipe and numerous Valium pills which she intended to sell. Anguianocan was charged with possessing drug paraphernalia and possessing drugs for sale.

On May 7<sup>th</sup> at about 8:25 PM Ukiah Police responded to a residence in the 200 block of Observatory Avenue for an incorrigible juvenile. Offices learned the 13 year old female juvenile was being defiant with parents and had recently stolen a bicycle. The juvenile was apparently brushing her hair in the event she was arrested, but soon approached the officer and admitted to having stolen a bicycle as her mother had recently taken hers for disciplinary reasons. The juvenile retrieved the bicycle for the officer, and identified the location from where it was stolen. The juvenile was arrested for theft and for possessing stolen property.

On May 8<sup>th</sup> at about 2:55 PM the Ukiah Police School Resource Officer investigated a fight that had just occurred on the Ukiah Campus involving a student and 18 year old Joshua Corey Williams, of Ukiah. Williams was not a student and was found to have entered the campus without legitimate business and had instigated a fight with the student. Williams was arrested for fighting on a school campus and booked into the County Jail.

On May 8<sup>th</sup> at about 8:45 PM Ukiah Police responded to the 100 block of Brush Street for an intoxicated subject. Officers located 44 year old Troy Dennis Jack who was extremely intoxicated and passed out in a seated position. As Jack was taken into custody for public intoxication he physically resisted the officers, then placed his feet against the police car to prevent himself from being put inside. Once in the car Jack kicked at the side windows, then turned and began kicking at the rear window. Jack was further restrained and taken to the County Jail.

On May 9<sup>th</sup> at about 3:30 PM Ukiah Police responded to the Social Services Office at 737 South State Street for a reported assault. Officers learned the victim had been walking on the railroad tracks near Gobbi Street and stopped near a group of people. The victim related 41 year old Augustine David Frease removed sunglasses from the victim's head and placed them on his own head. Frease told the victim he would not be returning the sunglasses, then began beating the victim in the face until the victim lost consciousness. The victim stated he awoke to find his EBT card missing, and walked to Social Services to report the crime. Officers located Frease, who was intoxicated and wearing the victim's sunglasses, in the Safeway parking lot and arrested him for battery with injury and robbery.

On May 9<sup>th</sup> at about 9:50 PM Ukiah Police responded to a residence in the 200 block of Observatory Avenue for a domestic violence incident. Officers located what appeared to be signs of a recent struggle but received no response at the door. Officers checked the residence and located 24 year old Amada Leann Kennedy inside. Kennedy was intoxicated and officers determined she'd been involved in a domestic argument wherein she struck the victim multiple times with a plastic bat causing minor injuries to the victim. Kennedy was arrested for domestic violence, and she requested her medication accompany her to the jail. Officers located a baggie containing what was determined to be ecstasy amongst the medication.
