Patrol Division Weekly Activity Report 5/10/12 to 5/16/12

Statistics

Arrests included: 12 for public intoxication, 4 warrant arrests, 3 for violating probation or parole, 2 for fighting on school grounds, 2 for drug influence and/or possessing drug paraphernalia, 2 for resisting arrest, and 1 each for; possessing an illegal weapon, possessing stolen property, possessing methamphetamine, battery, possessing marijuana on school grounds, vehicle pursuit, shoplifting, personation of another, domestic violence, sexual battery, and possessing a weapon (knife) on school grounds. Probation or parole holds were placed on 6 of these arrests.

Officers investigated 3 traffic collisions, one hit and run traffic collision, and 2 deaths by natural causes. Two vehicles were impounded for 30 days due to the drivers being unlicensed or suspended.

Officers took reports of: 15 vandalism, 7 missing persons, 6 thefts, 5 found property, 3 abandoned vehicles, 2 child neglect, and 1 each of; forgery, battery, counterfeit bill, sexual battery, identity theft, and domestic violence.

Highlights for the Week

On May 11th at about 5:15 PM a Ukiah Police Officer was flagged down in the 1200 block of North State Street. The officer contacted 29 year old Daniel Steven Dalton, who stated he was upset and also admitted having a knife on his person. The officer checked Dalton for weapons and located a cylindrical metal object typically clenched in a subject's fist when punching someone, and known as a "fist pack". Dalton was arrested for possessing an illegal weapon.

On May 10th at about 4:15 PM Ukiah Police received a report of clothes having been stolen from the Shop 'N Wash, at 581 North State Street. The victim reported having left clothing worth approximately \$800.00 in a dryer for about 30 minutes, and returned to find them missing. Officers viewed video footage of the area which depicted a female removing the clothing and leaving the building with them. This evidence with the suspect description was shared with other officers in the event the suspect was contacted or recognized. On May 13th at about 5:25 PM Ukiah Police responded to the 300 block of North Main Street for a dog that had been run over and killed in the roadway. An officer contacted the dog's owner, 40 year old Fianna Sue Johnson, and noticed she resembled the suspect's description. Johnson admitted removing the clothing claiming she had permission to do so and that she had already returned it. Officers located the stolen clothing in Johnson's possession, and determined she was wearing the stolen socks. Johnson was booked into the County Jail for burglary and possessing stolen property.

On May 12th at about 11:50 PM Ukiah Police Officers were dispatched to the St. Mary's Catholic Church, in the 900 block of South Oak Street, for a report of two subjects jumping the fence from the church carrying objects. Due to recent thefts and vandalism in Ukiah, Ukiah Police Officers responded and began to check the area for the suspects. A vehicle was observed leaving the area driving at a high rate of speed.

Ukiah Police Officers attempted to initiate a traffic stop on the vehicle and the driver failed to yield to the officers. The suspects traveled on Freitas Ave. to South State Street at speeds in excess of 60 MPH, failing to stop at the stop sign at Freitas Ave and South State Street. The vehicle turned on Thomas Street and was traveling at speeds around 50 MPH. The vehicle ultimately drove to the west end of Rupe Street where the driver and occupant exited the vehicle and were non complaint with the Officers. While Officers were trying to take the subjects into custody a juvenile female subject tried to intervene with the officer's arrest and failed to follow the Officer's verbal commands to stay back.

The driver of the vehicle was ultimately identified as 18 year old Roy Sanchez, of Ukiah. The passenger was identified as a 17 year old juvenile subject out of Ukiah. The female was identified as a 14 year old juvenile out of Ukiah. Sanchez was booked into Mendocino County Jail for recklessly evading in a vehicle, DUI, unlicensed driver, and resisting or delaying a peace officer in the performance of their duties. The 17 year old juvenile was arrested and booked into Juvenile Hall for recklessly evading. The 14 year old was arrested and booked into the Mendocino County Juvenile Hall for resisting or delaying a police officer in the performance of their duties.

On May 16th at about 9:20 AM Ukiah Police stopped a vehicle in the 1500 block of North Bush Street. The driver had been drinking, and identified herself verbally with a name and date of birth. The officer learned the driver had a suspended driver's license and was on probation, and was arrested. The passenger, 28 year old Joshua Charles Pollard, was overly intoxicated and was arrested for public intoxication. The driver later admitted she had provided her sister's identifying information, believing her sister had a valid driver's license and was not on probation. The driver was correctly identified as 25 year old Melanie Brandi Ilar,

whose driver's license was also suspended and who also was on probation. Ilar was arrested and additionally charged with falsely personating another person.

On May 16th at about 10:45 AM Ukiah Police received a report of domestic violence which occurred 4 days prior. The victim reported on Saturday, May 12th, in the evening she was with her husband in the 1200 block of Airport Park Boulevard, and he struck the victim in the face. Officers then located 33 year old Jorge Alberto Sanchez-Marin, who admitted striking the victim over alleged infidelity. Sanchez-Marin was arrested for domestic violence.
