Patrol Division Weekly Activity Report 5/31/12 to 6/6/12

Statistics

Arrests included: 14 for public intoxication, 6 warrant arrests, 5 for domestic violence, 4 for violating probation or parole, 4 for burglary, 3 for drug influence and/or possessing drug paraphernalia, 2 for shoplifting, 2 for resisting arrest, and 1 each for; possessing methamphetamine, child endangerment, vandalism, possessing marijuana on school grounds, possessing oxycodone, brandishing a weapon, contributing to child delinquency, possessing weapons at school, possessing stolen property, and battery. Probation or parole holds were placed on 5 of these arrests.

Officers investigated 3 traffic collisions, 1 hit and run DUI traffic collision, and 1 death by natural causes. Four vehicles were impounded for 30 days due to the drivers being unlicensed or suspended.

Officers took reports of: 3 child neglect, 2 thefts, 2 missing persons, 2 found property, 2 vandalisms, 2 forgeries, 2 identity thefts, 2 animal bites, and 1 each of; assault with a deadly weapon, court order violation, domestic violence, child endangerment, and burglary.

Officers assisted the Mendocino Major Crimes Task Force with several narcotics investigations, and Child Protective Services with an abuse investigation.

Highlights for the Week

On May 31st at about 7:20 PM Ukiah Police responded to the Wal Mart parking lot, at 1155 Airport Park Boulevard, for a reported fight. Upon officers' arrival one of the suspects began walking away from the scene. The officers stopped and contacted 35 year old John Darian Wahlstrom, who was intoxicated and who smelled strongly of marijuana. Wahlstrom falsely identified himself, and officers found he possessed a baggie containing over 20 grams of marijuana, and two other baggies containing a total of over 10 grams of concentrated cannabis. Wahlstrom was arrested for public intoxication and for possessing concentrated cannabis, and upon learning his real identity officers found there was a non-extraditable warrant from Colorado for his arrest. Wahlstrom was additionally charged with providing false identification and was booked into the County Jail.

On June 1st at about 11:15 PM Ukiah Police responded to the 700 block of South State Street for a subject who had just been shot with a pellet or BB gun from a moving vehicle. The victim explained he was riding his bicycle along State Street when he heard a vehicle slow behind him, then was shot in the back with what he believes was a BB or pellet gun. The victim described the suspect vehicle, and said there were 3 to 4 male juveniles in the car. The victim sustained visible injuries to his back. A short time later another subject reported having seen the suspects in the Safeway lot, but the suspects fled prior to police arrival. On June 4th the Ukiah Police School Resource Officer located the suspect vehicle at the Ukiah High School, and subsequently spoke with its owner, a 17 year old male juvenile high school student. The Ukiah Police Detective Division assumed the investigation, and through further investigation and after numerous interviews, determined the car's owner was in fact involved, and identified three additional suspects. The 17 year old juvenile and a 16 year old male juvenile were arrested later that day, and booked into Juvenile Hall for assault with a dangerous weapon and criminal conspiracy. On June 5th Detectives obtained arrest warrants for the two remaining suspects; 19 year

old Zachary Dionisio Hallock, and 19 year old Derae Montae Williams, both of Ukiah. Hallock was arrested later that day, and Williams was arrested the following day, on June 6th. It was determined all four suspects were in the vehicle at the time the victim was shot, and were involved with later hiding the gun used in the attack. It was also determined the group was responsible for shooting at the windows of vehicles and buildings causing damage to those windows, and additional charges of vandalism are being sought against the group.

On June 2nd at about 2:05 PM Ukiah Police stopped a vehicle being driven by 20 year old Lacey Elayne Devereux, of Daly City, in the 800 block of North State Street. Also in the vehicle was 27 year old Blaine Robert Boyd, of Ukiah, and his 9 year old child. Boyd was found to be on parole in Oregon for marijuana possession, and also had warrants for his arrest from Mendocino County. A search of the vehicle was conducted, and several pieces of aluminum foil and plastic straws used to “smoke” heroin were located within the vehicle. Also located in the vehicle was less than 1 gram of heroin, all of which was within reach of the child. Devereux explained she uses both heroin and oxycodone, and that the contraband inside the vehicle was hers. Devereux was arrested for possessing heroin, drug paraphernalia, and child endangerment.

On June 2nd at about 7:00 PM Ukiah Police responded to the 800 block of North State Street for a subject who had brandished a firearm. The victim reported knowing the suspect as “Marco”, and stated Marco confronted the victim and then raised his shirt to display a handgun in his waistband. Marco then fled in his vehicle and likely went to his residence on Gibson Street. Officers located the suspect vehicle on Gibson Street, and identified the suspect as 29 year old Marco Frederick Moon. While waiting for additional officers to respond, Moon exited his residence with his hands above his head, and he was detained and checked for weapons. While searching Moon’s residence for the pistol, a large tactical style knife inside a

sheath was located which would have resembled a pistol if secreted in a waistband. Also located was a loaded “AK-47” style assault rifle, which was found to have been reported stolen to the Mendocino County Sheriff’s Office. It was determined Moon likely had the knife in his waistband when he lifted his shirt, intending it to resemble a pistol. Moon was arrested for brandishing a weapon in a threatening manner, possession of stolen property, and possessing an assault rifle.

On June 3rd at about 2:10 AM Ukiah Police responded to the 1100 block of South State where a caller was following a hit and run vehicle southbound. Officers contacted the caller at South Dora Street and Jefferson Lane, and learned the suspect vehicle had driven west on Jefferson Lane. Apparently the suspect vehicle, a grey late model Ford Mustang, had tried to drive around the caller’s stopped vehicle at the Talmage Road intersection and struck the bumper while doing so, then continued driving away. Officers located the Mustang in the 300 block of Jefferson Lane and identified the driver as 23 year old David Garcia. There were determined to have been three passengers in the vehicle at the time of the collision, one of whom, 27 year old Carla Antone of Hopland, was extremely intoxicated and was arrested for public drunkenness. Garcia was cooperative with officers, and was found to have been drinking and was arrested for DUI and for hit and run.

On June 4th at about 1:50 AM Ukiah Police received a report of a missing 15 year old female juvenile. Apparently the juvenile was with her parents at a local restaurant about 11:00 PM the evening prior, and the juvenile snuck away and is believed to have left willingly with 28 year old Jorge Gonzalez Alvarez. Officers were given a description of Alvarez’ vehicle, and at about 4:15 AM located the vehicle parked at the Discovery Inn, 1340 North State Street. Officers located the 15 year old juvenile and Alvarez in a room, and determined Alvarez had supplied the juvenile with alcohol. Alvarez was arrested for contributing to the delinquency of a minor.

On June 4th at about 1:30 PM the Ukiah Police School Resource Officer was informed a student had brought a handgun onto campus. Apparently school administrators learned the 16 year old male juvenile student had forgotten he'd left a .22 caliber pistol inside his vehicle, which he parked in the school parking lot. The student's vehicle was searched and ammunition as well as marijuana and a knife were located in the vehicle. The student had apparently hidden the gun at a residence off-campus during lunch, and it was subsequently recovered from its hiding place. The juvenile was arrested for possessing a firearm, a knife, ammunition, and marijuana on school grounds, and for being a minor in possession of a firearm.
