Statistics

Arrests included: 12 for public intoxication, 4 warrant arrests, 4 for resisting arrest, and 1 each for: drug influence and/or possessing drug paraphernalia, shoplifting, possessing methamphetamine, possession of marijuana for sale, possession of methamphetamine for sale, trespassing, violating probation or parole, minor possessing alcohol, assault with a deadly weapon, possessing a dangerous weapon, and providing false identity to law enforcement. Probation or parole holds were placed on 7 of these arrests.

Officers investigated 2 hit and run traffic collisions and 1 DUI traffic collision. One vehicle was impounded for 30 days due to the driver being unlicensed or suspended.

Officers took reports of: 7 vandalisms, 5 thefts, 4 found property, 4 suicidal subjects, 3 burglaries, 2 domestic violence, 2 identity theft, and 1 each of; child neglect, abandoned vehicle, missing person, arson, and assault with a deadly weapon.

Officers assisted the Mendocino County Sheriff's Office with an assault with a firearm and with locating a burglary suspect, and the California Highway Patrol with a vehicle pursuit.

Highlights for the Week

On June 7th at about 1:30 PM Ukiah Police responded to the Motel 6, 1208 South State Street, regarding a guest being 2 hours past check-out and refusing to leave. Officers contacted 25 year old Derrick Devon Hallback, of Lakeland Florida, and found him pouring sand into a bucket inside the room. The room smelled strongly of marijuana, though none was located inside the room. Officers did find empty vacuum bags, a vacuum sealer, packing tape, and an assortment of other items commonly used to package and ship marijuana out of state. A search warrant was obtained for Hallback's vehicle, and inside two large boxes were located. Inside the boxes officers located buckets of sand containing vacuum sealed bags of marijuana totaling over 10 pounds. Also located and seized during this investigation was over \$10,000.00 in US Currency. Hallback was arrested for possession and transportation of marijuana for sale. A second suspect was identified as being involved with Hallback and is being sought at this time.

On June 9th at about 8:15 PM Ukiah Police responded to The Pub at 585 North State Street for a group of intoxicated subjects refusing to leave the bar. Mendocino County Sheriff's Deputies also responded, and upon arrival officers noticed a large group on Clara Avenue, and a female yell "over here". It appeared part of the group may have been challenging the others to a fight. As the officers approached the group one subject threw another to the ground, then four subjects began walking away in different directions. An officer observed 25 year old Octavio Juan Sanchez discard two knives as he walked away. Sanchez was very intoxicated and became belligerent and refused to follow the officer's directions, and was eventually arrested for public intoxication and resisting arrest. The officer was then confronted by 22 year old Gabriel Manuel Hernandez, who was also intoxicated and walking towards the officer with his hands in the air, yelling he wasn't going to cooperate and challenging the officer to hit him. After another officer arrived Hernandez was also arrested for public intoxication and resisting arrest, and was found to be in

violation of his probation. At the same time other officers were attempting to arrest 18 year old Jaime Antonio Zambrano, who was also being non-compliant and refusing to follow commands. Zambrano was eventually arrested for public intoxication and for a warrant issued for his arrest. The fourth subject was identified as 18 year old Marcos Abel Vasquez, who had challenged some of the other group to fight, and was found to be very intoxicated. Vazquez was arrested for public intoxication and challenging to fight. Officers also contacted 21 year old Victoria Louise DeLaCruz pursuant to this investigation, and found she had multiple warrants for her arrest. Sanchez was found to be on parole, and while being booked at the jail, made numerous threats towards several officers and their families. Sanchez was booked into the County Jail for public intoxication, resisting arrest, challenging to fight, destruction of evidence, possessing a dangerous weapon, threatening a police officer, and violating parole. The remaining suspects were booked for their appropriate charges. Other bar patrons reported the group that was arrested had been inside the bar causing a disturbance and challenging others to fight.

On June 11th at about 7:25 PM Ukiah Police responded to the Sun House Park, in the 300 block of South Main Street, for a reported fight. Officers contacted numerous people at the park, and determined 19 year old Anthony Edward Hoaglin approached a group seated at a table. Hoaglin shouted references to a criminal street gang, and then began trying to assault members of the group. Hoaglin punched one subject in the nose, then pulled out a knife and chased numerous members of the group, trying to stab them with the knife. The person who had been punched obtained a baseball bat and swung it at Hoaglin, never hitting him. Hoaglin was located in the park and was very intoxicated. Hoaglin claimed he tried to sell marijuana to the group, and they hit him over the head with an alcohol bottle and robbed him. Hoaglin was arrested and booked into the County Jail for assault with a deadly weapon, criminal threats, and committing gang crimes.

On June 13th at about 8:10 AM Ukiah Police responded to the 400 block of North State Street for a male subject swinging a golf club. Officers located 52 year old Pablo Benitez Mora, who had numerous personal belongings spread about a private lawn. Mora refused to gather his belongings and walked away, heading north. The officer located Mora walking into the courthouse and asked him to come back outside, to which Mora refused then bolted through the metal detector and checkpoint and ran to a courtroom. Mora was trying to enter a courtroom when the officer caught up to him and was able to restrain him, and eventually arrest him with the assistance of a court bailiff. Mora was arrested for resisting arrest, and once at the County Jail he spit onto correctional officers. Mora was additionally charged with battery on a custodial officer.
