Statistics

Arrests included: 9 warrant arrests, 4 for public intoxication, 2 for violating probation or parole, 2 for trespassing, and 1 each for: shoplifting, drug influence and/or possessing drug paraphernalia, possessing methamphetamine, possessing methamphetamine for sale, false report of a crime, false identity to a police officer, possessing an illegal weapon, possessing false identification, display of false license plates, theft, theft of a firearm, and vandalism. Probation or parole holds were placed on 4 of these arrests.

Officers investigated 1 traffic collision, 1 hit and run traffic collision, and 1 DUI hit and run traffic collision. One vehicle was impounded for 30 days due to the driver being unlicensed or suspended.

Officers took reports of: 6 vandalisms, 3 missing persons, 2 found property, 2 animal bite, 2 child endangerment, and 1 each of; domestic violence, transportation of marijuana, rape, counterfeit bill, embezzlement, theft, domestic violence, and battery.

Highlights for the Week

On August 10th at about 7:20 PM Ukiah Police responded to a residence on Lorraine Street regarding a reported hit and run traffic collision. Officers were told 52 year old Clinton Lee Stanley, of Willits, had struck a parked vehicle while driving his grey Ford pick-up, and fled the scene. Stanley was located with his vehicle in the 3000 block of South State Street, and was found to have been drinking. Stanley was determined to be too intoxicated to drive, and was placed under arrest for DUI and hit and run. Stanley was on probation and prohibited from driving after drinking, and was additionally charged with violating probation.

On August 11th at about 1:35 AM a caller contacted the Ukiah Police Department, and reported shots being fired inside a residence in the 600 block of South Orchard Avenue. Officers contacted the residents who had been sleeping, and ultimately determined the incident had been falsely reported. Using information obtained during the call officers eventually identified the caller as 19 year old Anthony Michael Glen Granados, whom they located at about 4:15 AM in the 700 block of Myron Place. Granados was extremely intoxicated, and was holding a telephone in his hand which he refused to provide to officers. Granados resisted the officers as they placed him into custody, and eventually retrieved the telephone from him and confirmed the 911 call had come from the phone. Granados was arrested for falsely reporting an emergency, resisting arrest, and public intoxication.

On August 11th at about 9:50 AM Ukiah Police responded to a motel room in the 400 block of South State Street, for a reported domestic disturbance. Officers contacted two subjects in the room, and ultimately located a third, 21 year old Daniel Sanchez, hiding inside the bathroom. Sanchez provided a different name and incorrect identifying information, but was ultimately identified and arrested for an outstanding warrant, and charged with providing false identity to law enforcement and for violating probation.

On August 12th at about 2:40 AM a Ukiah Police Officer noticed two subjects walking along the back of Rite Aid, at 680 South State Street. The subjects suddenly started running and were seen discarding various items as they ran. A perimeter was quickly established with the assistance of the Mendocino County Sheriff's Office, and one of the subjects was soon located near State and Gobbi Streets. The subject was identified as 19 year old Alexander Preston Galindo, who was on parole and in possession of a folding knife. Galindo had been observed

discarding a bag near Rite Aid, which was found to contain a woodened handled “shank” with a sharpened metal tip. Galindo was arrested for possessing a dangerous weapon and for violating parole.

On August 13th at about 1:05 AM Ukiah Police contacted a male subject seated in a vehicle in the 1100 block of South Dora Street. The vehicle’s stereo was missing and there was a screwdriver on the floor, but it was ultimately learned the vehicle belonged to the subject seated in it and no theft had occurred. The subject stated he had just driven the vehicle and he had been drinking, but was determined to not be intoxicated. The subject possessed 4 types of identification in the name of 25 year old Martin Neftali Juarez Zuniga, one being an INS card, one a California ID card and another a California driver’s license. The numbers on the California ID’s were different, though in the same name, and an automated computer check revealed the numbers were assigned to different people, neither resembling Zuniga, and one being a female. Zuniga admitted all the identification was false, and that he used them solely for employment purposes. Zuniga was arrested for possessing false or forged identification.

On August 14th at about 1:40 AM Ukiah Police stopped a Honda bearing license plates registered to a Mitsubishi, in the 1100 block of Mulberry Street. The officer noticed the steering column was damaged and wires exposed indicating the vehicle was potentially stolen. The driver, 28 year old John Edward Knight, was taken into custody while officers further investigated the vehicle. A VIN check of the vehicle revealed it was registered in Maine, and that the registration was expired, but that the vehicle had not been reported stolen. Knight’s driver’s license was found to be suspended, and prescription medication was located within the vehicle. Knight was arrested for possessing a controlled substance without a prescription, driving with a suspended drivers license, false display of registration tags, and false display of license plates.
