Statistics

Arrests included: 7 warrant arrests, 6 for public intoxication, 3 for drug influence and/or possessing drug paraphernalia, 3 for domestic violence, 2 for violating probation or parole, 2 for theft, and 1 each for: possessing methamphetamine, possessing methamphetamine for sale, possessing an illegal weapon, resisting arrest, defrauding an innkeeper, violation of sex registrant requirements, battery, and shoplifting. Probation or parole holds were placed on 6 of these arrests.

Officers investigated 2 hit and run traffic collisions, 1 traffic collision, and 1 injury traffic collision. One vehicle was impounded for 30 days due to the driver being unlicensed or suspended.

Officers took reports of: 11 child endangerment, 5 thefts, 3 vandalisms, 3 found property, 2 domestic violence, 2 burglaries, and 1 each of; missing person, growth of marijuana, counterfeit bill, stalking, stolen vehicle, child molest, suicidal subject, abandoned vehicle, defrauding an innkeeper, assault with a dangerous weapon, violating court order, and robbery.

Officers assisted Child Protective Services with several child abuse investigations, and the Mendocino Major Crimes Task Force with several narcotics investigations.

Highlights for the Week

On August 19th at about 12:45 AM Ukiah Police responded to the Kwik Pik Market at 795 East Perkins Street for a window that had been damaged. Officers contacted a 14 year old male juvenile and 16 year old male juvenile near the store, and found the 14 year old was on probation, and had a large knife concealed in his clothing. The 14 juvenile was arrested for illegally possessing a weapon, and violating probation, and booked into the Juvenile Hall.

On August 20th at about 8:20 AM Ukiah Police responded to a residence in the 700 block of McPeak Street regarding a domestic violence incident. Officers ultimately contacted 39 year old Robert David Loucks and 45 year old Lisa Ann Davis, and learned Loucks had committed a domestic battery the day prior, and he was arrested for it. Davis was found in possession of several ecstasy tablets, and hydrocodone pills, and was arrested for possessing a controlled substance and a narcotic.

On August 22nd at about 6:05 PM Ukiah Police responded to a residence in the 500 block of West Mill Street regarding a domestic violence incident. Officers contacted the victim and 49 year old Michael Joseph Weathers, and learned both had been involved in a domestic violence incident which included throwing items at one another. Weathers had apparently punched the victim in the face and caused bleeding, and was arrested for domestic battery. A restraining order was obtained restraining Weathers from the victim.

On August 21st at about 7:30 PM Ukiah Police responded to the lobby of the Police Department, at 300 Seminary Avenue, regarding a subject under the influence of methamphetamine. Officers contacted 33 year old Michael Marvin Beers, who stated he'd used more methamphetamine than usual two days prior and was having difficulty "coming down". Beers hadn't slept in several days and felt

jail was the best place for him, and he was concerned about a reptile like creature that could change into other animal forms. Beers was evaluated and determined to be under the influence of methamphetamine, and was arrested for drug influence and booked into the County Jail.

On August 23rd at about 12:55 AM Ukiah Police observed subjects carrying a couch near the 900 block of North State Street. As the officer approached the subjects had dropped the couch and ran away. Other officers located one of the subjects, a 14 year old male juvenile, running on Elm Street, and later located 28 year old Justin Michael Settles hiding behind a business just to the north. The subjects claimed they had seen the couch behind a business for several days and decided it would be okay to take it. The subjects claimed they were taking the couch to a residence to replace a bed, and that it was cooler to carry the couch at night, than in the day. The subjects claimed they ran because they realized carrying a couch at night didn't look good, and they got scared. Both subjects were arrested for appropriation of property, theft, and conspiracy, and Settles was additionally charged with public intoxication.
