Statistics

Arrests included: 8 for public intoxication, 4 for violating probation or parole, 2 for drug influence and/or possessing drug paraphernalia, 2 for domestic violence, 2 for shoplifting, 2 for marijuana cultivation, and 1 each for: possessing methamphetamine, possessing a narcotic, hit and run, arrest warrant, battery, and possessing stolen property. Probation or parole holds were placed on 2 of these arrests.

Officers investigated 1 hit and run traffic collision, and 1 injury traffic collision. One vehicle was impounded for 30 days due to the driver being unlicensed or suspended.

Officers took reports of: 8 found property, 4 thefts, 4 burglaries, 2 vandalisms, 2 marijuana sales, 2 suicidal subjects, and 1 each of; missing person, child neglect, animal bite, identity theft, and forgery.

Highlights for the Week

On August 22nd at about 2:00 PM Ukiah Police stopped a vehicle in the 100 block of Oak Knoll Road. The driver had no identification, and was identified as 32 year old William Jackson IV, of Mill Valley. Jackson displayed symptoms of being under the influence of a controlled substance, and was eventually arrested for having used drugs recently. A passenger in the vehicle, 22 year old Francisco Enrique Gonzalez, of Ukiah, was found to have a warrant for his arrest for violating parole and was taken into custody. Another passenger, 23 year old Elizabeth Anne Dockins, of Ukiah, also displayed symptoms of recent drug use and provided officers a false name. Dockins was found in possession of approximately 6 ounces of methamphetamine, and was arrested for drug influence, possessing and transporting methamphetamine for sale, and several arrest warrants for violating parole and traffic violations.

On August 27th members of the Ukiah Police Department were preparing to serve a search warrant at the home of 39 year old Jesus Martinez, in the 600 block of Walnut Avenue. Martinez was suspected of growing marijuana both inside and outdoors at the location, and was known to be involved with a criminal street gang. Assisting the Ukiah Police Department with this investigation were members of the Mendocino Major Crimes Task Force, County of Mendocino Marijuana Eradication Team, Federal Bureau of Investigations Safe Streets Task Force, and the California Department of Corrections Special Services Unit.

At about 8:25 AM Martinez was observed driving a vehicle in the 800 block of North Bush Street, and Ukiah Police Officers attempted to stop him. Martinez refused to yield to the police vehicles' lights and sirens, and continued until reaching his residence where he stopped and was taken into custody. Inside the vehicle Martinez was driving was his 2 year old grandchild.

A search of Martinez' residence was conducted and over 80 growing marijuana plants were located and seized from inside and from the backyard. Marijuana trimmings, and items used to manicure and package marijuana were also located and seized. Contacted inside the residence was 18 year old Angela Leticia DeLaCruz.

Martinez and DeLaCruz were arrested for marijuana cultivation and criminal conspiracy, and Martinez was additionally charged with vehicular evasion and child endangerment. Martinez' grandchild was released to the custody of Child Protective Services.
