Statistics

Arrests included: 7 warrant arrests, 6 for public intoxication, 4 for domestic violence, 4 for drug influence and/or possessing drug paraphernalia, 3 for fighting on school grounds, 2 for burglary, and 1 each for: false identity to law enforcement, possessing an illegal weapon, brandishing a firearm, violating probation or parole, resisting arrest, and possessing a knife on school grounds. Probation or parole holds were placed on 3 of these arrests.

Officers investigated 3 traffic collisions, 1 hit and run traffic collision, and one death. One vehicle was impounded for 30 days due to the driver being unlicensed or suspended.

Officers took reports of: 8 thefts, 7 found property, 3 burglaries, 2 suicidal subjects, 2 stolen vehicles, 2 assaults with a dangerous weapon, 2 batteries, 2 child neglect, and 1 each of; animal bite, recovered stolen vehicle, vandalism, annoying telephone calls, domestic violence, missing person, vehicle tampering, and child molest.

Highlights for the Week

On August 31st at about 8:50 PM Ukiah Police stopped a vehicle being driven by 21 year old Yod Rivera, of Fairfax, in the 300 block of South Main Street. Also in the vehicle was a female adult, and a 2 year old child. Rivera had been drinking, and was found too intoxicated to drive and was arrested for DUI. Rivera was also charged with child endangerment.

On September 1st at about 7:35 PM Ukiah Police responded to the Vagabond Inn, at 601 Talmage Road, for a reported domestic violence incident. Officers learned that witnesses had observed the victim and 40 year old Brian Scott Wieden, of Willits, in an argument and that Wieden struck the victim several times in the head. Wieden was located intoxicated at a near-by wedding reception, and was uncooperative with officers during the investigation. Wieden was arrested for domestic violence and for violating probation, and was booked into the County Jail.

On September 2nd at about 7:55 PM Ukiah Police responded to a residence in the 200 block of Norton Street regarding a neighbor dispute. It was reported that the two neighbors had engaged in an argument in their respective front yards, and that the suspect apparently entered his residence and returned with a handgun. The suspect reportedly pointed the gun at his neighbor and made threatening statements, which was observed by a witness who contacted police. The suspect had re-entered his home, and refused requests from officers to exit and speak with them.

A perimeter was established around the residence and communication with the suspect, identified as 52 year old Mark Daniel Williams, was established, but Williams continued to refuse to exit his residence and cooperate with officers. Additional officers responded to the scene including officers from the California Highway Patrol and Mendocino County Sheriff's Office, and the Ukiah Police SWAT Team. Suddenly Williams walked out of his residence unarmed, and was

quickly taken into custody. A search warrant was subsequently served at Williams' residence, and firearms were located and taken from inside. Williams was booked into the Mendocino County Jail for criminal threats and brandishing a firearm.

On September 5th at about 12:05 AM Ukiah Police responded to a residence in the 600 block of North State Street for a disturbance and domestic violence incident. Officers arrived and could hear 41 year old Shelley Daniel inside the residence, yelling and throwing and breaking items. Officers determined Daniel had bitten the victim twice during a domestic argument, causing moderate injuries. Officers found Daniel had injured herself during the tantrum, and had the Ukiah Fire Department respond to treat her minor injuries. Daniel continued to scream and remained agitated, and was arrested for domestic violence and booked into the County Jail.

On September 5th at about 1:50 AM a Ukiah Police Officer was inside Safeway, at 653 South State Street, attempting to have a meal break. The officer observed a subject seated and sleeping at a table, who suddenly lifted his head and began screaming and yelling. Safeway employees asked the officer to have the subject leave the store, and as the officer contacted the subject he got up and refused to cooperate with the officer. The officer requested another officer respond and continued to attempt to try and speak with the subject, who walked further into the store. The subject, 37 year old David Michael Gouse, then ran from responding officers but was eventually apprehended and taken into custody. Gouse was booked into the County Jail for resisting arrest.
