### **Patrol Division Weekly Activity Report 9/27/12 to 10/3/12**

### **Statistics**

Arrests included: 5 for public intoxication, 5 for domestic violence, 4 for fighting on school grounds, 4 warrant arrests, 3 for violating probation or parole, 3 for drug influence and/or possessing drug paraphernalia, 2 for possessing stolen property, 2 for false identity to law enforcement, 2 for possessing an illegal weapon, 2 for shoplifting, and 1 each for: burglary, attempted theft, possessing a weapon at school, threats, and assault with a dangerous weapon. Probation or parole holds were placed on 4 of these arrests.

Officers investigated 4 traffic collisions, 3 hit and run traffic collisions, and 1 injury traffic collision. Two vehicles were impounded for 30 days due to the drivers being suspended or unlicensed.

Officers took reports of: 8 thefts, 6 found property, 3 vandalisms, 3 missing persons, 2 domestic violence, 2 located missing persons, 2 burglaries, 2 city code violations, and 1 each of; stolen vehicle recovery, animal bite, prowling, battery, transporting marijuana, child neglect, and identity theft.

Officers assisted the Ukiah Fire Department with a structure fire, and the K9 unit assisted the California Highway Patrol search for a vehicle theft suspect.

### **Highlights for the Week**

On September 27<sup>th</sup> at about 2:10 AM Ukiah Police stopped a vehicle being driven by 26 year old Jonathan David Brittian, of Ukiah, in the 600 block of Joseph Street. Brittian displayed symptoms of recent drug use, and a search of his vehicle revealed several baggies of methamphetamine and a methamphetamine smoking pipe concealed within. Brittian was arrested for possession and transportation of methamphetamine, and for possessing drug paraphernalia.

On September 27<sup>th</sup> at about 4:15 AM Ukiah Police were notified of a suspicious male subject looking into vehicles in the 1100 block of South Dora Street. The subject was reportedly riding a bicycle and was last seen going into an apartment complex in the 700 block of South Dora Street. Officers saw a subject walking inside a particular apartment where persons commonly involved with criminal activity are often located, and which wanted criminals often flee police exiting a bedroom window. Officers observed a bicycle parked near this apartment, and subsequently contacted the occupants. Officers located 19 year old Austin Jay-Lee Shealor, of Ukiah, hiding in the apartment, and found dark clothing and a flashlight also hidden near Shealor. Officers found Shealor was under the influence of methamphetamine and that he possessed several hypodermic syringes, used to inject the drug, and a credit card in somebody else's name. Shealor was arrested for drug influence, possessing drug paraphernalia, and prowling. Later that evening the investigating officer determined the credit card had been stolen and that Shealor had made attempts to use the credit card. Shealor was additionally charged with possessing stolen property and identity theft, and because Shealor had recently bailed out of jail from charges of Shealor conspiring with others and using a stolen credit card to purchase a television and other items at Wal Mart, Shealor was also charged with commission of felony with pending felony charges.

On September 27<sup>th</sup> at about 11:10 PM Ukiah Police noticed a subject inhabiting a vehicle within city limits, which is prohibited by the city code. The subject was identified as 33 year old Alfred Carpenter Childs, of Minneapolis, Minnesota, who had warrant for his arrest from Dakota County for arson, assault and child endangerment. Childs had a cane in his vehicle, which upon further inspection was found to be a "cane sword" with an approximate 2' blade. Childs was arrested for the warrant and for possessing an illegal weapon.

On September 30<sup>th</sup> at about 4:40 PM Ukiah Police responded to Oak Manor Park at 500 Oak Manor Drive for a subject waving a large stick and behaving erratically. Officers contacted 47 year old Francisco Javier Cornejo Zamora, who was intoxicated and immediately confrontational. Zamora had items scattered about the park, including an open alcohol container and large stick. Zamora possessed an opened box cutter in his pocket, and a cylindrical object commonly placed into one's fist to harden the blow. As Zamora was being taken into custody he tried to pull away, and refused to walk with officers or enter the patrol car. Zamora was charged with public intoxication, possessing illegal weapons, and resisting arrest.

On October 2<sup>nd</sup> at about 8:55 AM Ukiah Police responded to the intersection of South Oak and West Perkins Street for a 2 vehicle traffic collision. Officers spoke with the drivers of both vehicles and numerous witnesses, and learned a 78 year old female was driving a blue 1997 Ford Thunderbird northbound on Oak Street. The driver proceeded through the Perkins Street intersection and struck a white 2000 Toyota Corolla being driven westbound by a 65 year old female. The collision caused the Toyota to spin around and change directions of travel, and it began proceeding eastbound. The driver apparently pressed the accelerator rather than the brake pedal, and witnesses report seeing the Toyota travelling at a high rate of speed and seemingly out of control as it continued the wrong way on Perkins Street. The vehicle was seen colliding with a street sign, then crossing into the building at 215 West Perkins Street, then crossing again and colliding with the building at 102 South School. The vehicle then proceeded south, again at a seemingly high rate of speed, on School Street until being stopped by the driver at West Church Street. Neither driver was injured. The Ford received moderate damage to its front end, and the Toyota received major damage to all sides of the vehicle and was towed from the scene.

On October 2<sup>nd</sup> at about 10:30 AM Ukiah Police responded to Wells Fargo Bank at 747 South State Street for a subject trying to cash a stolen check. Officers learned 24 year old Brandon James Smith and 28 year old John Edward Knight had entered the bank together, and Knight had attempted to cash a check that had been stolen from an unlocked vehicle the day prior. Knight had recently been arrested by Ukiah Police for possessing a stolen check. Smith had a warrant for his arrest and was taken into custody, and Knight was arrested for burglary and possessing stolen property.

On September 3<sup>rd</sup> at about 7:00 PM Ukiah Police responded to the 600 block of Marshall Street for a male lying on the ground in the parking lot, and bleeding from the face. Officers learned the victim had left prior to their arrival, but located him near the railroad tracks near East Gobbi Street. The 56 year old victim reported that 50 year old Dena Darlene Morris had wanted to have sex with the victim, and when he refused she struck him in the face with a brandy bottle and sprayed water on him. The victim sustained several lacerations to his face and was treated at the scene by Ukiah Fire Paramedics. Morris was not present, but was located when officers returned to the same area at about 9:40 PM. Morris stated the victim fell, and she sprayed him with water because he was bleeding. The victim was also present and confirmed Morris had hit him, and Morris was arrested for assault with a dangerous weapon.
