Patrol Division Weekly Activity Report 10/4/12 to 10/10/12

Statistics

Arrests included: 5 warrant arrests, 4 for public intoxication, 4 for possessing marijuana for sale, 3 for possessing methamphetamine for sale, 3 for drug influence and/or possessing drug paraphernalia, 2 for possessing a narcotic, 2 for possessing methamphetamine, 2 for domestic violence, 2 for violating probation or parole, and 1 each for: burglary, resisting arrest, battery on medical personnel, and attempted battery on medical personnel. Probation or parole holds were placed on 3 of these arrests.

Officers investigated 5 traffic collisions and 1 hit and run traffic collision. Three vehicles were impounded for 30 days due to the drivers being suspended or unlicensed.

Officers took reports of: 8 thefts, 4 found property, 3 domestic violence, 2 marijuana cultivation, 2 assault with a dangerous weapon, 2 suicidal subjects, and 1 each of; vandalism, burglary, child neglect, embezzlement, abandoned vehicle, and identity theft.

Officers assisted the Mendocino Major Crimes Task Force with several narcotics investigations and a marijuana cultivation investigation, and the K9 unit assisted the California Highway Patrol with a vehicle search.

Highlights for the Week

On October 5th at about 3:25 PM Ukiah Police went to a residence in the 200 block of Ford Street where they had earlier observed marijuana plants growing in the backyard. Officers saw the plants had been cut down and found the marijuana had been hung to dry in a shed and inside the residence, and in the presence of the residents' 2 year old child. It was determined the marijuana was being grown and cultivated for commercial purposes, and approximately 50 pounds of drying marijuana was seized. The resident, 29 year old Joshua Lee Goates, of Arizona, was charged with possessing and cultivating marijuana for sale, child endangerment, and for violating probation. Charges are also being sought against his wife.

On October 5th at about 7:40 PM Ukiah Police responded to 550 Talmage Road for a report of a U-Haul truck being unloaded of suspected marijuana. The location is a commercial building containing several individual units typically used to service vehicles. The officers did not see the U-Haul, but noticed the very strong odor of marijuana from one of the units. At about that time officers contacted a subject identified as 33 year old Karol Alvarado Valencia, of Fort Bragg, as he exited the unit. Valencia was detained and a second subject, identified as 34 year old Laureano Alvarado Valencia, of Fort Bragg, exited the building then upon seeing the officer began retreating inside. Officers observed the U-Haul inside the unit, and a large amount of marijuana hanging from the ceiling to dry. Officers followed Laureano inside as he yelled to other subjects and began running. Laureano was stopped but broke free from the officer and attempted to continue running a short distance but was again soon captured. Two additional subjects ran out the back door and were pursued by a single officer until the subjects reached large blackberry bushes and had to stop. Emergency assistance was requested, and the two additional suspects identified as 23 year old Miguel Angel DeLoSantos-Bernardin, of Reno Nevada, and 28 year old Santiago Jauregui-Valencia, of Baytown Texas, were successfully detained. Officers found the U-Haul was still nearly loaded with marijuana, and approximately 200 pounds of marijuana was ultimately seized from the vehicle and from within the unit. Karol Alvarado Valencia was arrested for criminal conspiracy and possessing marijuana for sale, as were the remaining three subjects who were also charged with resisting arrest.

On October 6th at about 2:05 AM Ukiah Police stopped a vehicle being driven by 24 year old Ernesto Silva Gutierrez, of Boonville, in the 500 block of South State Street. Gutierrez was driving without a driver's license, and had been drinking. Gutierrez was found to be too intoxicated to drive and was arrested for DUI. Gutierrez possessed about 1 gram of cocaine, and was additionally charged with possessing a narcotic.

On October 6th at about 10:25 AM Ukiah Police responded to the Ukiah Valley Medical Center Emergency Room at 275 Hospital Drive, for a combative patient. Officers learned 31 year old Kristopher Paul Malone, of Arcata, was being discharged from care and had requested additional medication. When Malone was denied more medication, he became angry and charged at the medical staff who moved, and Malone missed and struck the wall with his body. Malone continued to throw a tantrum by yelling and throwing items around. Malone was arrested for attempted battery on medical staff and booked into the County Jail.

On October 6th at about 7:00 PM Ukiah Police responded to the Ukiah Valley Medical Center Emergency Room at 275 Hospital Drive for an intoxicated combative patient. Officers found medical staff holding down 26 year old Tess Nichelle Antonetti, who was screaming and yelling. Officers learned while staff was treating Antonetti she removed her IV, kicked one staff member in the shoulder, and swung her arm at the face of another member who blocked her attack. Antonetti was arrested for public intoxication and battery on medical staff.

On October 7th at about 11:15 PM Ukiah Police responded to a residential complex in the 400 block of East Gobbi Street, for a suspicious male. Officers learned residents reported hearing a cat screaming in distress inside one of the bathrooms, and the manager located 30 year old Tyler Dwight Waggoner, of Rocklin, inside the bathroom watching a kitten hang from one of the wall-mounted safety bars. Waggoner appeared intoxicated and left the building, and was soon located by an officer. Waggoner was clearly intoxicated and was belligerent and argumentative with the officer, and was arrested for public intoxication.

On October 8th at about 2:15 PM Ukiah Police responded to the area near the railroad tracks near East Gobbi, for a reported fight. Officer observed 27 year old Alva Thomas Reeves, of Covelo, throw a jacket at his sister nearly striking her. Reeves had a warrant for domestic violence from Lake County, and was arrested. Officers contacted numerous other people, and

found 21 year old Robert Bruce Campbell who had minor injuries and ripped clothing indicating he'd been involved in a fight. Campbell was on parole and intoxicated, and was arrested for public intoxication and violating parole.

On October 10th at about 7:50 AM Ukiah Police Officers assisted agents and officers with the Mendocino Major Crimes Task Force, County of Mendocino Marijuana Eradication Team, Mendocino County Probation, and California Fish and Game with the service of a search warrant in the 1700 block of Low Gap Road. Upon arrival a male subject fled an exterior building and was pursued, but evaded capture. A loaded pistol was discovered on the ground believed to have been discarded by the suspect as he ran from officers. Located on the property were 12 outdoor growing marijuana plants, and indications approximately 80 more plants had been recently harvested. Located inside the structure was over 100 pounds of partially manicured marijuana, approximately 95 pounds of manicured marijuana, and items used to weigh and process marijuana. Located inside his residence on the property was 43 year old Celso Ceja, who stated the structure on the property containing the marijuana was utilized by his cousin, 43 year old Miguel Ceja Lopez. Several firearms were located inside the residence, including a pistol magazine which corresponded to the discarded handgun located earlier. Ceja was arrested for maintaining a location for drug distribution and for possessing firearms in the commission of a felony. The investigation continued to a residence in the 1600 block of Woodlawn Terrace, where 25 marijuana plants were being grown inside. The occupants indicated the residence was owned by Miguel Ceja Lopez, who allowed them to live there rent free if they posted their medical marijuana recommendation. Miguel Lopez is currently being sought for the cultivation and possession of marijuana for sale.

On October 10th at about 2:25 PM Ukiah Police responded to a traffic collision on South State Street near Thomas Street. Witnesses reported seeing the driver of an involved vehicle hide a small bag inside a nearby dumpster, immediately following the collision. Officers located the bag inside the dumpster, and found it contained a methamphetamine smoking pipe, a scale, and approximately one gram of methamphetamine. The driver, identified as 34 year old Matthew David Hooper, was arrested for transporting and possessing methamphetamine for sale.
