Statistics

Arrests included: 9 for public intoxication, 4 warrant arrests, 4 for drug influence and/or possessing drug paraphernalia, 3 for domestic violence, 3 for violating probation or parole, 3 for possessing methamphetamine, 2 for possessing marijuana at school, and 1 each for: shoplifting, possessing a narcotic, prowling, and possessing marijuana for sale. Probation or parole holds were placed on 1 of these arrests.

Officers investigated 1 traffic collision, and 2 hit and run traffic collisions. One vehicle was impounded for 30 days due to the driver being suspended or unlicensed.

Officers took reports of: 12 vandalism, 8 found property, 6 thefts, 3 child neglect, 2 suicidal subjects, 2 missing persons, 2 counterfeit bills, and 1 each of; animal bite, stolen vehicle, identity theft robbery, forgery, and arson.

Ukiah Police Officers assisted the California Highway Patrol with a subject fleeing the scene of a traffic accident, and the K-9's assisted with vehicle searches.

Highlights for the Week

On October 20th at about 10:10 PM Ukiah Police stopped a vehicle being driven by 44 year old Donna Rae Ellard, of Redwood Valley, in the 400 block of East Gobbi Street. Also in the vehicle was 50 year old Christopher Lee Ackerman, of Ukiah, who was displaying symptoms of having recently used a controlled substance. A search of the vehicle was conducted, and officers located less than one gram of methamphetamine, numerous syringes, and other items commonly used to inject illegal drugs. Ellard and Ackerman were arrested for possessing methamphetamine and drug paraphernalia.

On October 21st at about 2:00 AM Ukiah Police stopped a vehicle being driven by 57 year old Monty Eugene Daniels, of Ukiah, in the 300 block of North Main Street. The vehicle smelled of marijuana, and marijuana was subsequently located within the vehicle. Daniels was found to possess numerous Oxycodone tablets, and was arrested for possessing a narcotic. A passenger in the vehicle, 29 year old Amanda Jean Cox, of Ukiah, was found in possession of several methamphetamine smoking pipes, and was arrested for possessing drug paraphernalia.

On October 21st at about 9:15 PM Ukiah Police stopped a vehicle being driven by 35 year old Davette Hayes, of Covelo, in the 400 block of North State Street. The vehicle smelled strongly of marijuana, and a search of the vehicle revealed over 35 grams of marijuana, and less than one gram of methamphetamine. Hayes had provided officers with a false name, but was soon identified and found to have three outstanding warrants for her arrest, and that her driver's license was suspended. Hayes was arrested for possessing methamphetamine, driving on a suspended driver's license, providing false identity to law enforcement, and the warrants.

On October 22nd at about 7:35 AM Ukiah Police responded to a residence in the 200 block of Freitas Avenue for a suspicious subject. The victim explained about an hour prior she had discovered some jewelry and keys were missing from her vehicle. The victim had returned to her residence, and observed a subject in the yard area, walk under the window, and jump a fence and leave the area. Another officer had located 29 year old

Benjamin Franklin Hoff, of Ukiah, nearby in the 100 block of West Gobbi Street, as he matched the reported suspect description. Hoff denied having been in the yard, and displayed symptoms of recent drug usage. The victim was transported to Hoff's location and positively identified him and placed him under citizen's arrest for prowling. Hoff was also charged with drug influence, and the missing jewelry and keys were located in Hoff's possession. Hoff was additionally charged with possessing stolen property.
