Statistics

Arrests included: 6 for public intoxication, 6 for domestic violence, 5 warrant arrests, 3 for violating probation or parole, 3 for possessing methamphetamine, 2 for drug influence and/or possessing drug paraphernalia, 2 for manufacturing a controlled substance, 2 for stolen vehicle, and 1 each for: vandalism, burglary, possessing marijuana inside a vehicle, failing to yield to law enforcement, and possessing a weapon (knife) on school grounds. Probation or parole holds were placed on 2 of these arrests.

Officers investigated 1 traffic collision, 1 hit and run traffic collision, and a death by apparent natural causes. One vehicle was impounded for 30 days due to the driver being suspended or unlicensed.

Officers took reports of: 7 found property, 7 thefts, 5 child neglect, 4 vandalisms, 2 stolen vehicle, 2 burglaries, 2 domestic violence, and 1 each of; animal bite, transportation of marijuana, child molest, abandoned vehicle, identity theft, and battery.

Officers assisted the Mendocino County Sheriff's Office locating a wanted subject.

Highlights for the Week

On October 31st at about 3:35 PM Ukiah Police responded to the 200 block of South State Street for a reported disturbance. Apparently a male subject was disrupting the Halloween festivities wherein the downtown merchants host trick or treaters. Officers were alerted by numerous citizens and directed to the 100 block of South School Street, where officers contacted 57 year old Daniel Raymond Nicholas, of Hayward. Nicholas was intoxicated and was arrested for public intoxication and booked into the County Jail.

On November 1st at about 2:35 PM Ukiah Police responded to a residence in the 700 block of South Oak Street for a domestic violence incident. Officers learned the juvenile victim and 16 year old male juvenile suspect began arguing after visiting their newly born child at the hospital. Once at the residence the arguing continued, and the male juvenile pulled the victim's hair, and then later struck the victim in the face with his elbow. There had apparently been prior incidents of domestic violence between the two. The male juvenile was not at the location, but was located the following morning by officers at his residence in the 800 block of Waugh Lane. The 16 year old male juvenile was arrested for domestic violence, and a protective order restraining him from the victim was subsequently obtained.

On November 2nd at about 4:10 PM Ukiah Police responded to the 200 block of East Clay Street for a vehicle burglary. Officers learned the victim had parked his vehicle outside a business, and was inside the building when his car alarm was activated. The victim found a side window had been broken out of the vehicle, and clothing, CD's, and other items worth over \$800.00 had been stolen from his vehicle. There are two buildings in this area which contain exterior security surveillance cameras, and a sign displayed on one of the buildings in plain view and near the victim's vehicle, which read the area is watched by surveillance cameras. Officers viewed surveillance footage which depicted the entire incident, and showed the suspect vehicle park near the victim's vehicle and the driver subsequently break out the victim's window and steal from the victim's vehicle. The investigating officer shared the vehicle description with other officers, and the vehicle was located in the 400 block of Clara Avenue at about 1:45 the following morning. Officers could see some of the stolen items inside the vehicle, and soon contacted 49 year old Tommy Dwaine Cargile, of Santa Rosa, who was sleeping in a tent in the backyard of a residence. Officers determined Cargile was the driver of the suspect vehicle, and noticed additional stolen items inside the tent. Officers also located in

the tent, a methamphetamine pipe and a small baggie of methamphetamine. Cargile was arrested for burglary, possessing stolen property, theft with prior theft convictions, possessing methamphetamine, and drug paraphernalia.

On November 3rd at about 11:10 AM Ukiah Police contacted 31 year old Joseph Lee Allen, of Ukiah, in the 1000 block of South State Street. Allen displayed symptoms of drug influence, and admitted recently using methamphetamine. Allen was arrested for being under the influence of a controlled substance, and was found to possess a methamphetamine smoking pipe. A subsequent search of Allen's motel room revealed numerous hypodermic syringes and other items commonly associated with injecting illicit drugs, as well as two baggies of methamphetamine and several syringes which contained liquid methamphetamine. Allen was additionally charged with possessing methamphetamine. While assisting the investigating officer, another officer was advised by a passer-by of a man lying in front of a building to the south of the location. The officer located 31 year old Robert Lee Lawrence, of Crescent City, who appeared to be sleeping in front of a business in the 1100 block of South State Street. Lawrence was intoxicated and was arrested for public intoxication.

On November 3rd at about 3:55 PM Ukiah Police attempted to stop 34 year old Billy Ray Watson, of Hopland, in the 100 block Oak Manor Drive. Watson refused to stop his vehicle, and drove onto Yosemite Drive passing numerous safe opportunities to stop his vehicle. The officer followed Watson at a safe speed with emergency lighting and siren activated, and saw Watson look into his rear view mirror then waive at the officer. Watson continued onto El Rio Court and into a driveway where he stopped, and began to exit the vehicle. The officer instructed Watson to remain in the vehicle and Watson complied. Watson was driving with a suspended driver's license, and was arrested for that and for failing to yield to an emergency vehicle.

On November 3rd at about 11:55 PM Ukiah Police stopped a vehicle being driven by 46 year old Trinidad Hernandez Gonzalez, of Talmage, in the 1500 block of South State Street. Gonzalez had been drinking, and was found to be too intoxicated to drive. As the officer began to place Gonzalez into custody, he began physically resisting and trying to pull his arms away. After struggling with Gonzalez, officers took him to the ground where he was able to free one of his hands and tuck it under his body. After further struggle officers were able to get Gonzalez

into custody without further incident. Gonzalez was on probation and prohibited from driving after drinking, and was arrested for DUI, violating probation and resisting arrest.

On November 4th at about 1:00 AM Ukiah Police contacted 36 year old James Nathaniel Langton, of Ukiah, in the 500 block of North State Street. Langton had a warrant for his arrest, and was found to possess less than a gram of methamphetamine, and a morphine tablet. Langton was arrested for the warrant, for possessing a controlled substance and for possessing a narcotic.

On November 4th at about 3:00 AM Ukiah Police responded to a residence in the 700 block of South State Street for a domestic violence incident. Officers learned 24 year old Sergio Suri Jimenez, of Ukiah, had come home intoxicated at about 1:00 AM. Jimenez apparently collapsed on the living room floor, and the victim began removing his clothing to allow him to "sleep it off". Jimenez awoke, began vomiting, started talking "gibberish" then yelled and cussed at the victim. Jimenez grabbed at the victim, put her into a headlock which she escaped, then Jimenez slapped her several times. Jimenez then collapsed onto the couch and appeared to pass out again. The victim notified her parents, who responded and the victim's father confronted Jimenez, who had awoken again, about hitting the victim. Jimenez panicked and fled the residence, but was soon located by officers lying underneath a vehicle. Jimenez had an unexplained abrasion to the side of his head. Jimenez was arrested for domestic violence, and a protective order was obtained restraining Jimenez from the victim.

On November 5th at about 10:30 PM Ukiah Police stopped a vehicle being driven by 25 year old Paul Anthony Cabeza, of Whittier, in the 1700 block of North State Street. Also in the vehicle was 22 year old Anthony Joseph Novellino, of Torrance. Cabeza stated the two were headed to Garberville for a couple of days. Novellino was found to possess a small amount of marijuana, as well as a form of concentrated cannabis known as "hash". Within the center console was another form of concentrated cannabis known as "honey oil", and a container of butane. Upon further inspection, officers located several glass tubes stuffed with marijuana, empty glass tubes, glass dishes with marijuana residue, and over 150 butane canisters. These items are commonly used to manufacture marijuana into "honey oil". Cabeza and Novellino were arrested for the manufacture of controlled substances, and criminal conspiracy.

On November 6th at about 6:55 PM Ukiah Police responded to the convenience store at 295 West Mill Street for vandalism to the front door. Officers learned a patron had selected a food item and was heating it in a microwave. The store clerk informed the patron the food item had to be purchased prior to being heated as it was being bought with food stamps, which prohibit the purchase of warmed food. The patron became angry and yelled profanities at the clerk, then threw the food item against the door. The patron then kicked the glass door pane in the door as he was leaving, causing it to break. The officer was able to view the incident on the store's surveillance footage, and obtained a description of the suspect. Officers soon located 19 year old Daniel Ray Holmes, of Ukiah, who matched the description, in the Sun House Park at 431 South Main Street. Holmes claimed the clerk yelled at him for the heating the food, and denied throwing the food item or kicking the door even after being told he'd been seen on security footage doing so. Holmes had been drinking in violation of his probation, and was arrested for vandalism and for violating probation.
