Statistics

Arrests included: 5 for public intoxication, 4 for shoplifting, and 1 each for: drug influence and/or possessing drug paraphernalia, violating probation or parole, domestic violence, possessing marijuana on school grounds, possessing marijuana for sale, and possessing counterfeit currency. Probation or parole holds were placed on 3 of these arrests.

Officers investigated 3 traffic collisions, 1 DUI traffic collision, and a death by apparent natural causes. Two vehicles were impounded for 30 days due to the drivers being suspended or unlicensed.

Officers took reports of: 7 found property, 7 vandalisms, 3 recovered stolen vehicles, 2 animal bites, 2 thefts, 2 stolen vehicles, 2 abandoned vehicles, and 1 each of; assault with a dangerous weapon, domestic violence, transportation of marijuana, and identity theft.

Officers assisted the California Highway Patrol with a stabbing investigation on state property, and a traffic collision.

Highlights for the Week

On November 3rd at about 12:45 PM Ukiah Police responded to the area of Talmage Road and Airport Park Boulevard for a driver reportedly being seen drinking beer while driving. The caller also reported seeing the vehicle being driven unsafely; it veered off the road, then stopped past the limit line at a posted stop sign nearly blocking the traffic lane. The officer located the vehicle as it parked in the Friedman Bros lot at 1255 Airport Park Boulevard. The driver was identified as 39 year old William Jesus Zubia, of Yuba City, who was driving with a suspended driver's license. An opened beer was located inside the vehicle, but Zubia was determined not to be intoxicated. Zubia possessed a methamphetamine smoking pipe which contained a usable amount of methamphetamine. Zubia was arrested for possessing methamphetamine and drug paraphernalia and for driving with a suspended driver's license.

On November 9th at about 2:00 PM Ukiah Police responded to the area of the railroad tracks near Perkins Street for a male subject reportedly acting bizarre. The subject was seen without a shirt in cold, rainy weather, and was acting paranoid, talking to himself, and making quick, jerky body movements. Officers identified the subject as 40 year old Ernest Allen Choate, of Ukiah, who stated he was on parole and admitted to using methamphetamine. Choate stated he wasn't wearing a shirt because he was "working on his tan", and was arrested for drug influence and for violating parole.

On November 10th at about 4:10 PM Ukiah Police responded to the 1000 and 1100 block of West Perkins Street for a subject staggering and falling down. Officers contacted 25 year old Bradley Scott Hall, of Redwood Valley, who was staggering after his loose dog and was intoxicated. Hall was arrested for public intoxication and booked into the County Jail.

On November 10th at about 5:10 PM Ukiah Police responded to Kohl's at 437 North Orchard Avenue for a shoplifter. The female suspect had apparently fled the location in a vehicle, and officers learned store personnel had seen the suspect concealing clothing inside a large purse, and then leave the store with boots concealed under her jacket. When confronted outside by employees, the suspect placed the boots on the ground but refused to stop and drove away. Another officer located and stopped the suspect vehicle in the 700 block of South Dora Street, and identified the suspect as 21 year old Samantha Lee Green. Store personnel confirmed Green was the suspect, and stolen clothing valued at around \$400.00 was located in

Green's possession. Green also possessed a usable amount of methamphetamine, and methadone and hydrocodone tablets. Green was arrested for shoplifting, possessing methamphetamine, and possessing narcotics.

On November 10th at about 7:40 PM Ukiah Police responded to the Shell at 1105 South State Street for a hit and run traffic collision. Officers learned the suspect vehicle had collided with one of the concrete poles which protect the gas pumps. The driver was seen examining the damage to his vehicle then entering the store where he was observed to be intoxicated. The driver then left the scene, but the vehicle was soon located and stopped by officers in the 1500 block of Talmage Court. The driver, identified as 40 year old Francisco Gonzalez Gonzalez had been drinking, and was found too intoxicated to drive and was arrested for DUI.

On November 11th at about 5:10 PM Ukiah Police responded the Ukiah Valley Medical Center Emergency Room for an intoxicated subject causing a disturbance and harassing staff. Apparently 57 year old Michael James Donahe had been transported to the ER by ambulance earlier in the day due to extreme intoxication. Donahe was arrested for public intoxication and booked into the County Jail.

On November 12th at about 10:30 PM a Ukiah Police Officer observed two males walking in the parking lot at the Super 8 Motel at 693 South Orchard Avenue. The males were each carrying large garbage bags, and one subject was carrying a vacuum sealer. Upon seeing the officer the subjects quickened their pace. Believing the subjects were carrying a large amount of marijuana and intended to use a motel room to package it, the officer attempted to contact the subjects. One of the subjects slowed to speak with the officer, but the other subject suddenly ran with the officer in foot pursuit. The subject jumped over the fence onto the highway which he ran across and was able to get away. The second subject, later identified as 26 year old Ryan Tierney Murphy, of Ukiah, had tried to enter a vehicle and flee and was physically detained by a witnessing citizen who struggled with the suspect until the officer returned. Both subjects had discarded their respective garbage bags which were found to contain over 10 pounds of marijuana. Murphy had discarded the vacuum sealer, and empty sealer bags were located near-by, and additional packaging material was located inside Murphy's room. Murphy was arrested for possessing marijuana for sale, concealing or destroying evidence, and violating probation. The outstanding suspect is believed to be known as "Chris" and may be from Santa Cruz, and is described as a thin white male in his mid-20's

about 5'10" tall with light colored hair worn in dreadlocks, wearing a grey sweatshirt and dark pants.

On November 13th at about 9:50 AM Ukiah Police stopped a vehicle in the 900 block of North State Street, and identified the passenger as 29 year old Victor Jose Lopez. The officer determined Lopez was on parole, and found him to possess nine \$20.00 bills that were determined to be counterfeit. Lopez was arrested for possessing false currency and for violating parole.

On November 14th at about 2:30 PM Ukiah Police stopped a vehicle being driven by 26 year old Richard Domingo Flores, of Redwood Valley, in the 600 block of Myron Street. Flores was not licensed to drive a vehicle, and was on parole. Flores was wearing gang related clothing, and a passenger in the vehicle was a known gang member. Flores denied having parole terms which prohibited gang clothing or associating with gang members, which was determined to be untrue by speaking with his parole agent. Flores was arrested for driving without a license and for violating parole.
