Patrol Division Weekly Activity Report 11/15/12 to 11/21/12

Statistics

Arrests included: 10 for public intoxication, 4 warrant arrests, 3 for domestic violence, 3 for transporting marijuana for sale, 2 for drug influence and/or possessing drug paraphernalia, 2 for fighting on school grounds, 2 for grand theft, and 1 each for: violating probation or parole, possessing marijuana on school grounds, threats, stolen vehicle, possessing methamphetamine for sale, possessing methamphetamine, child endangerment, and burglary. Probation or parole holds were placed on 5 of these arrests.

Officers investigated 4 traffic collisions, 1 injury traffic collision, and 1 hit and run traffic collision. Six vehicles were impounded for 30 days due to the drivers being suspended or unlicensed.

Officers took reports of: 8 found property, 5 transportation of marijuana, 4 vandalisms, 3 thefts, 2 abandoned vehicles, 2 suicidal subjects, 2 child neglect, and 1 each of; animal bite, forgery, burglary, annoying telephone calls, and identity theft.

Highlights for the Week

On November 6th at about 4:50 PM Ukiah Police responded to the corner of Airport Park Boulevard and Talmage Road for an intoxicated male lying in the bushes. Officers contacted 36 year old Christopher Hanan Pastore, of Santa Cruz, who was intoxicated and stated he'd been in the bushes since the night prior. Pastore had a small amount of marijuana and wasn't aware of the time of day. Pastore was arrested for public intoxication.

On November 11th at about 2:00 AM Ukiah Policed stopped a vehicle being driven by 23 year old Ashley Nichole Brito, of Moses Lake, Washington, in the 100 block of Pomeroy Avenue. Brito had been drinking, and was found to be too intoxicated to drive and was arrested for DUI.

On November 15th at about 3:00 PM Ukiah Police stopped a vehicle being driven by 45 year old Aurelio Ortiz Acosta, of Ukiah, in the 600 block of South State Street. Acosta was on probation, and in the trunk of his vehicle officers located approximately 1 pound of marijuana in several separate packages. Acosta was arrested for transporting marijuana and violating probation.

On November 16th at about 1:10 PM Ukiah Police responded to the Safeway parking lot, at 653South State Street, for young children unattended inside a vehicle. Officers contacted witnesses who reported seeing a vehicle drive fast through the parking lot, park near the front of the store, and the woman driver exit the vehicle leaving the driver's door open. The witnesses saw the woman screaming and jump up and down on the sidewalk, and then enter the store where the witnesses heard the woman continue to scream. The witnesses saw there were two small children, later determined to be 2 and 4 years of age, left unattended inside the vehicle with the driver's door open and in the crowded and busy parking lot. The woman remained inside the store for about 5 minutes before returning to her vehicle and children. The woman was identified as 27 year old Amy Lynn Henry, of Ukiah, and she was arrested for child endangerment.

On November 17th at about 3:30 AM Ukiah Police responded to the Forest Club, at 239 North State Street, for a combative male subject being detained. Officers learned 50 year old Evan Matt Morris, of Ukiah, had entered the bar with a closed knife in his hand which was

raised over his head, and yelled aggressively at employees. The employees were able to disarm and detain Morris, and added that Morris had earlier called the bar numerous times, threatening to kill the employees with a shotgun. Morris was treated for minor injuries sustained during the scuffle with employees, and was arrested for criminal threats.

On November 17th at about 1:20 PM Ukiah Police stopped a vehicle in the 500 block of Talmage Road. The vehicle was a Ford however displayed license plates registered to a Nissan. The driver had no identification, and stated she was from Montana and provided a name and date of birth. The driver was extremely nervous, and was suspected of providing a false name, however continued to insist the name provided was her. A search of the vehicle revealed a drivers license identifying the driver as 37 year old Bambi Jeanne Segna, of Butte, Montana. The vehicle was found to have been stolen approximately 3 months prior in Montana. Segna was wanted in Montana, and was arrested for the stolen vehicle, personating another, theft with prior convictions, driving with a suspended driver's license and the Montana warrants.

On November 17th at about 8:40 PM Ukiah Police responded to The Pub, at 585 North State Street, for a subject making threats. Officers learned the bouncers observed 32 year old Philip Charles Vanorden, of Petaluma, and another subject become involved in an argument, and the bouncers directed Vanorden to leave. Vanorden became angrier and angrier and yelled louder and louder as he exited, and the bouncer heard Vanorden say to another patron, "I'm about to stab that bouncer". Vanorden was intoxicated and was arrested for public intoxication.

On November 17th at about 8:20 PM Ukiah Police responded to the 100 block of Ford Street for a traffic collision. Officers located a van facing a utility pole, and the driver was driving the van backward and forward as if to get around the pole, but was unable to. Officers learned witnesses had observed the van driving slowly on Ford Street, and that it stopped several times for no reason before colliding with the pole. The driver was identified as 57 year old Patricia Lyn Greenfield, of Ukiah, who had been driving with a suspended driver's license. Greenfield was very intoxicated, and had difficulty standing unassisted. Greenfield was arrested for DUI, driving with a suspended driver's license, and for violating probation.

On November 18th at about 10:20 PM Ukiah Police were at the Discovery Inn, 1340 North State Street, conducting an investigation related to stolen property. Officers subsequently contacted 37 year old Steven Lynn Simpson inside one of the rooms. A search of the room

revealed several grams of methamphetamine in numerous separate packages, marijuana also packaged for sale, methamphetamine smoking pipes, and other items associated with the sales of drugs. Simpson was arrested for possessing methamphetamine and marijuana for sale, and for possessing drug paraphernalia.

On November 18th at about 3:15 PM Ukiah Police responded to a business in the 200 block of North State Street for a suspicious subject. Officers learned a male inside the business had been talking nonsensically, repeatedly attempted to take the caller's property, and was possibly intoxicated. Officers contacted 30 year old Tom Austin Cummings, of Portland, Oregon, and found him behaving strangely and to be intoxicated. Cummings was arrested and was found to possess marijuana, and a powdery substance that appeared to be an illegal drug but was not positively identified. Cummings was arrested for public intoxication, and the substance was sent to the California Department of Justice for further analysis.

On November 19th at about 2:35 AM Ukiah Police responded to a residence in the 1200 block of South State Street for a prowler. Officers learned the resident heard a subject forcefully enter the gate into the front yard, then saw the subject try to open the front door to the residence. The resident called police, who located the suspect hiding in a nearby business' bathroom. The suspect, 29 year old Benjamin Franklin Hoff, was under the influence of methamphetamine, and physically resisted officers while being taken into custody. Hoff was arrested for prowling, attempted burglary, and resisting arrest.

On November 19th at about 1:50 PM Ukiah Police received a call of a theft of metal shelving that had just occurred from behind Big Lots, at 225 South Orchard Avenue. Officers received a suspect vehicle description, which was eventually located at the metal recycling center on Taylor Drive. Officers identified the suspects as 53 year old Alfred Adrian Dominiak, and 22 year old Joshua Kyle Shank. The suspects had apparently taken about \$5000.00 worth of metal shelving from behind Big Lots, which the store had just received, and which was still wrapped in shipping material. Dominiak and Shank were arrested for grand theft and conspiracy.
