### **Patrol Division Weekly Activity Report 11/29/12 to 12/5/12**

### **Statistics**

**Arrests included: 7 for public intoxication, 5 warrant arrests, 4 for domestic violence, 4 for possessing stolen property, 3 for drug influence and/or possessing drug paraphernalia, and 1 each for: assault with a dangerous weapon, burglary, elder abuse, possessing an illegal weapon (concealed knife), and battery. Probation or parole holds were placed on 2 of these arrests.**

**Officers investigated 3 traffic collisions, 2 injury traffic collisions, and 1 DUI traffic collision. One vehicle was impounded for 30 days due to the driver being suspended or unlicensed.**

**Officers took reports of: 4 thefts, 3 found property, 3 missing persons, 2 for robbery, 2 for stolen vehicle, and 1 each of; suicidal subject, animal bite, child abuse, burglary, battery, stalking, attempted murder, annoying a child, domestic violence, and child endangerment.**

**Officers assisted the Mendocino County Sheriff's Office with an injury traffic accident, a suspicious person, and an alarm call, and the Ukiah Police Detective Bureau with service of a search and arrest warrant.**

### Highlights for the Week

On November 30<sup>th</sup> at about 1:50 AM Ukiah Police observed a male subject sleeping near the entrance doors to Lucky's, at 504 East Perkins Street. Officers noticed an open container of alcohol near the subject, and were able to determine he was very intoxicated. The subject provided the officer with a name and date of birth, which matched a wristband issued by the Ukiah Valley Medical Center the subject was wearing on his wrist. Officers arrested the subject for public intoxication, and soon determined the subject had provided the name of his brother to both the officer, and previously to UVMC where had had obtained care. Officers identified the subject as 30 year old Robert Lee Lawrence, of Crescent City, who admitted providing his brother's name, who was in prison. Officers charged Lawrence with falsely personating another, and informed UVMC of the information.

On December 1<sup>st</sup> at about 4:05 PM a Ukiah Police Officer was at Wal Mart, at 1155 Airport Park Boulevard, and noticed 55 year old Curtis Roy Daniels, of San Francisco, who had two no-bail warrants for his arrest. The officer arrested Daniels, and found he had approximately a gram of cocaine in his pocket. Daniels was arrested for the outstanding warrants, and for possessing cocaine.

On December 2<sup>nd</sup> at about 1:10 AM, the Ukiah Police Department received a call from an employee at Sunny's Donuts, 1260 S. State Street; regarding an armed robbery that had just occurred at the store. The employee reported to UPD Officer's that two white male adults approximately 5'10" each in height and one 180lbs and the other 215lbs wearing black and white hooded sweatshirts and black masks entered the store while the sole employee was baking. One suspect had a knife and demanded the money from the cash register. The employee handed over the money and both suspects then left with an undisclosed amount of cash in an unknown direction of travel. The employee was not hurt or injured in the robbery. The area was checked for the suspects but they were not located.

On December 2nd at about 9:30 PM Ukiah Police responded to the 200 block of East Perkins Street for a male reporting to have been shot. Officers found the 19 year old male victim sitting on the sidewalk, leaning against a building, with a gunshot wound to his upper body. The victim reported he had been seated in his vehicle in the area of Clara and Mason Streets, when a subject known to him pointed a handgun at the victim while a second suspect

tried to remove items from the victim's vehicle. The suspect then shot the victim, who fled in his vehicle to Perkins Street, where he summoned police. The victim sustained major injury in the shooting, and was transported to the Ukiah Valley Medical Center, and later to an out-of-the-area hospital for treatment.

Assisting the Ukiah Police Department investigating this incident were members of the Mendocino County Sheriff's Office and California Highway Patrol.

On December 2nd at about 10:20 PM Law Enforcement Officers were in the area of Clara and Mason Streets conducting an investigation related to an earlier reported shooting. Officers were contacted by a subject who reported having been robbed approximately 1 hour earlier, on Hamilton Street.

The 21 year old male victim reported he was returning from grocery shopping, and was approached by two subjects with raised fists, demanding money. The victim struggled with the two suspects, who were able to hold the victim down and remove some of the victim's possessions from his pocket.

The suspects are described as black male adults, one approximately 6'1" tall, the other approximately 5'8" tall, both wearing dark hooded sweatshirts and last seen walking south on Hospital Drive.

Ukiah Police are investigating a shooting which occurred in this general area of Ukiah, but have not yet determined if the two incidents are related. This incident remains under investigation, and anybody with information is asked to call the Ukiah Police Department at 707-463-6262.

On December 2nd, 2012, Ukiah Police Officers responded to a shooting alleged to have occurred near Mason and Clara Streets, wherein the victim was shot by a male subject known to the victim. Over the following 2 days Ukiah Police Detectives identified the suspect as 20 year old Markeese Mondale Brantley, formerly of Fort Meyers, Florida. The investigation revealed the 19 year old victim had met Brantley numerous times in the past, at or near Brantley's residence in the 600 block of North State Street, for the purpose of selling Brantley marijuana. On the night of the shooting, Brantley and the victim arranged to meet near Brantley's residence allegedly to settle a debt. The victim was seated in his vehicle when Brantley and an

unidentified male approached, and Brantley pointed a handgun at the victim and made a statement indicating he would shoot and kill the victim. While Brantley held the victim at gunpoint, the second male suspect began searching and rummaging through the victim's vehicle. The victim suddenly accelerated in reverse in an attempt to get away, and Brantley shot him once in the arm as he was doing so. The victim drove himself to the Perkins Street area where he telephoned for help, and was subsequently contacted by police and fire personnel.

On December 4th at about 7:15 PM Ukiah Police Officers and Detectives served a search and arrest warrant at the residence in the 600 block of North State Street, and arrested Brantley at the location. Detectives interviewed Brantley, and he was booked into the Mendocino County Jail for attempted murder, assault with a firearm, robbery, and criminal conspiracy. The weapon used in this incident was not recovered.

The victim in this case has undergone surgery for a severe injury to his arm, and is reported to be in stable condition.

The second suspect is currently being sought.

This case remains under investigation, and anybody with information is asked to call the Ukiah Police Department at 707-463-6262.
