Patrol Division Weekly Activity Report 12/13/12 to 12/19/12

Statistics

Arrests included: 6 for public intoxication, 5 warrant arrests, 4 for fighting on school grounds, 4 for drug influence and/or possessing drug paraphernalia, 3 for possessing methamphetamine for sale, and 1 each for: violating probation, resisting arrest, possessing methamphetamine, and domestic violence. Probation or parole holds were placed on 2 of these arrests.

Officers investigated 4 traffic collisions, 1 injury traffic collisions, and 1 death by apparent natural causes. Two vehicles were impounded for 30 days due to the drivers being suspended or unlicensed.

Officers took reports of: 3 thefts, 3 found property, 2 child neglect, 2 vandalism, 2 missing persons, and 1 each of; burglary, forgery, rape, stolen vehicle, suicidal subject, and stolen vehicle recovery.

Officers assisted the Mendocino Major Crimes Task Force with several narcotics investigations, and area schools with school and facility safety.

Highlights for the Week

On December 11th at about 11:50 PM Ukiah Police responded to the 100 block of East Standley Street for a traffic collision. Officers found a 2012 Kia Optima had collided with a building causing damage to both the building and the front of the vehicle. The vehicle's driver's door was open but was unoccupied and the driver had fled. While on scene, Ukiah Police received a call from 23 year old Justin Gene Williams, of Willits, who was reporting the rented vehicle stolen. Officers contacted Williams near-by, in the 300 block of North Main Street, and Williams stated he'd been at a residence all night when the rented vehicle was stolen. Williams then stated he'd met a male subject inside a near-by bar known to Williams only by first name, and that the subject invited him to smoke marijuana. Williams was too intoxicated to drive, and the subject drove the vehicle and crashed it, and fled. Williams continued to provide inconsistent statements, and had recent injuries likely sustained in the collision. Williams was observed by witnesses immediately following the collision, and other evidence was observed and collected indicating Williams had been driving the vehicle at the time of collision. Williams was intoxicated and was arrested for DUI, hit and run, and violating probation.

On December 13th at about 2:05 AM Ukiah Police responded to a residence in the 700 block of Waugh Lane regarding an unknown subject knocking on the door. Officers found 33 year old Grant Edward Goodman leaning against the front door, and saw he was missing one shoe and was very intoxicated. Goodman claimed he was trying to get into his hotel room, though there are no hotels in the immediate area. Goodman was arrested for public intoxication.

On December 13th at about 6:20 PM Ukiah Police responded to a residence in the 1000 block of Alice Avenue for a domestic argument. The arriving officer heard a male threatening violence, and heard a female plead not to be hurt. The officer requested emergency assistance, and soon contacted 32 year old Travis Gerald Fitch. Officers determined the female victim had been physically assaulted, and found a small amount of methamphetamine inside the residence. Fitch was arrested for domestic violence and for possessing methamphetamine.

On December 13th at about 10:00 PM Ukiah Police responded to the Wal Mart parking lot, at 1155 Airport Park Boulevard, regarding three suspicious subjects associated with a parked vehicle. It was reported the subjects were seen walking back and forth from the vehicle

separately, and possibly looking into other parked vehicles. Officers contacted the subjects inside their vehicle, identified as 40 year old Rolando Rafael Torres, 28 year old Bryan Vincent Broussard, and 30 year old Robert Gregory Tabarez, all of Sacramento. Torres was found to be on probation in Tehama County, and was found to possess a methamphetamine smoking pipe and was arrested. Broussard was found to be under the influence of methamphetamine and was also arrested. Tabarez was found to have a warrant from Tehama County and was also arrested. Officers located a drinking cup in some bushes near the vehicle, which seemed to have been discarded by one of the subjects. Inside the cup officers located several ounces of methamphetamine. All three subjects were additionally charged with possessing and transporting methamphetamine for sale, and for criminal conspiracy.

On December 17th at about 1:05 PM Ukiah Police responded to the Pear Tree Center at 545 East Perkins Street, for an intoxicated subject being detained by Pear Tree Center's Security. 65 year old Thomas Arthur Boettcher, of Fort Bragg, was found to be very intoxicated and was arrested for public intoxication.
