Statistics

Arrests included: 7 for public intoxication, 7 warrant arrests, 2 for domestic violence, 2 for possessing methamphetamine, and 1 each for: failing to register as a sex registrant, shoplifting, possessing a narcotic, violating probation, transportation of marijuana, and resisting arrest. Probation or parole holds were placed on 4 of these arrests.

Officers investigated 2 traffic collisions, 1 injury traffic collision, and 1 death by apparent natural causes. Two vehicles were impounded for 30 days due to the drivers being suspended or unlicensed.

Officers took reports of: 5 found property, 3 thefts, 3 child neglect, 2 vandalism, 2 domestic violence, and 1 each of; burglary, child abuse, identity theft, missing person, barking dog, and animal bite.

Officers assisted the Ukiah Fire Department with a structure fire.

Highlights for the Week

On December 28th at about 8:40 PM Ukiah Police responded to a residence within the Ukiah City Limits for a domestic disturbance. Officers learned the suspect, identified as 40 years old Michael Paul Jones, had been outside the victim's residence and trying to enter, and refused to leave. Jones then forcefully entered the victim's residence by kicking in the front door and approached the victim aggressively and in a threatening manner. Jones made verbal threats of violence towards the victim, and the victim was able to flee the residence but sustained a minor injury from Jones as he tried to keep the victim from leaving. Jones had fled the residence prior to the officers' arrival, and was not located. An Emergency Protective Order was granted prohibiting Jones from contacting the victim, and a Be On the Look Out was broadcast for Jones' arrest.

On December 31st in the evening hours Ukiah Police Officers proceeded to a location in Ukiah and were following up on an investigative lead regarding the location of Jones. Officer learned they had just missed the suspect and that he had left the location a short time before. Officers did arrest a 63 male at the location for possessing drugs and for violating probation.

On January 1st at about 6:50 AM Ukiah Police Officers responded to the victim's residence, and upon arrival observed a subject believed to be Jones running towards a creek area. A perimeter was established but Jones again was not located. Jones had reportedly been knocking on the victim's windows, and it was discovered Jones had manipulated the exterior lighting around the residence, and there were indications Jones had attempted to covertly enter the residence.

On January 2nd at about 12:40 PM Ukiah Police received information that Jones was seen walking in the Observatory Avenue area. This area was checked by officers but Jones was not located.

Michael Paul Jones is a 40 year old white male, approximately 5'9" tall with a thin build, and a shaved head. Jones was last seen wearing a long sleeved dark shirt and dark jeans, and may be wearing a knit watchman's style cap and carrying a backpack.

Jones is being sought for burglary, criminal threats, domestic violence, vandalism, stalking, prowling, and for violating his probation. The Ukiah Police department is asking anybody with knowledge of Jones' whereabouts to call the Ukiah Police department at 463-6262.



On December 29th at about 6:05 PM Ukiah Police responded to the Forest Club, at 239 North State Street, for two subjects in an altercation in front of the bar. Officers contacted 21 year old Leatris Kaman Maurice Caradine, of Ukiah, who was on probation and prohibited from drinking or possessing alcohol. Caradine was believed to have been involved in the altercation, and he attempted to flee from the officers. Caradine ran a short distance and was captured and brought to the ground, where he continued to struggle and resisted being taken into custody. Caradine was arrested and was found to possess alcohol in addition to having consumed it. Caradine was booked into the County Jail for resisting arrest and violating probation. The other subject involved in the altercation, 21 year old David Lee Russell, of Redwood Valley, was located in the 300 block of North Main Street and was arrested for public intoxication.

On December 29th at about 11:00 PM Ukiah Police observed a vehicle parked at the Todd Grove Park, in violation of the park's closing hours. As the officer approached the vehicle a subject quickly exited the passenger door, and walked quickly away from the vehicle. A second responding officer later noticed the subject walking near Walnut Avenue and Live Oak Drive, and noticed he appeared to be trying to avoid detection. The officer subsequently contacted 19 year old Luis Alberto Delgadillo, of Ukiah, in the 600 block of Live Oak Drive. Delgadillo had been drinking in violation of his probation, and was arrested for violating probation. The officer with the vehicle smelled marijuana within the vehicle, and was speaking with 19 year old Justine Nicole Hunter, of Calpella, who was seated in the driver's seat. Hunter was found to possess several grams of cocaine, and was arrested for possessing cocaine.

On December 31st at about 2:05 PM Ukiah Police stopped a vehicle being driven by 36 year old Leonardo Alvarez, of Ukiah, in the 100 block of Tedford Avenue. The interior of the vehicle smelled strongly of marijuana, and Alvarez stated he possessed "personal use" marijuana. The officer located a duffle bag in the vehicle, which he found contained about 4 pounds of marijuana in approximate 1 pound packages. Alvarez was arrested for possessing and transporting marijuana for sale.

On December 31st at about 4:00 PM Ukiah Police responded to the 100 block of Mason Street for an altercation between two males. One of the subjects was then reported to have left in a vehicle, which was observed turning onto Perkins Street. The vehicle was stopped in the 100 block of North Main Street, and the driver, 42 year old Timothy Jon Dobler, of Ukiah, had an injury to his face as if he'd just been in a fight. Dobler initially provided officers a false name, and he was found to possess several hypodermic syringes and less than one gram of methamphetamine. Dobler was arrested for possession of methamphetamine.
