### Patrol Division Weekly Activity Report 4/11/13 to 4/17/13

### Statistics

Arrests included: 9 for public intoxication, 8 warrant arrests, 7 for shoplifting, 5 for drug influence and/or possessing drug paraphernalia, 3 for battery, 2 for domestic violence, 2 for providing false names, 2 for possessing methamphetamine, and 1 each for: violating probation or parole, possessing a narcotic, use of inhalants, possessing marijuana, trespassing, and threats. Probation or parole holds were placed on 2 of these arrests.

Officers investigated 1 traffic collision, 1 injury traffic collision, and 2 deaths by apparent natural causes. One vehicle was impounded for 30 days due to the driver being unlicensed or suspended.

Officers took reports of: 3 thefts, 2 child neglect, 2 found property, 2 vandalism, 2 abandoned vehicles, 2 animal bite, 2 missing persons, and 1 each of; stolen vehicle recovery, domestic violence, and battery with significant injury.

Officers assisted the Mendocino County Sheriff's Office with a domestic violence investigation and a vehicle pursuit.

### Highlights for the Week

On April 9<sup>th</sup> at about 6:25 AM Ukiah Police responded to the Sunrise Motel, at 650 South State Street, for a reported disturbance. Officers contacted numerous subjects, one of whom was identified as 27 year old Ashley Lynne Espinosa, of Perris, California. Espinosa had a felony warrant for her arrest from Santa Clara County, and was arrested. 13-0861

On April 11<sup>th</sup> at about 3:35 PM Ukiah Police responded to a residence in the 600 block of Leslie Street for an unresponsive female. Officers found the front door open and keys still in the lock, and located 60 year old Christina Helayne Gomez laying on the couch. Officers noticed several aerosol cans in the vicinity of Gomez, and determined she had been inhaling or "huffing" the contents. Gomez was arrested for use of inhalants. 13-0886

On April 12<sup>th</sup> at about 1:25 AM Ukiah Police observed a vehicle traveling on South Dora Street and proceed through two intersections without stopping. The vehicle turned onto Washington Avenue and traveled into the oncoming lane, and was stopped in the 400 block of Washington Avenue. The driver, 48 year old Kevin Patrick Brogan, of Ukiah, had been drinking. Brogan was found too intoxicated to drive and was arrested for DUI. Brogan had less than one gram of cocaine in his pocket, and was additionally charged with possessing a narcotic. 13-0892

On April 12<sup>th</sup> at about 9:40 AM Ukiah Police responded to a residence in the 100 block of West Mill Street for a domestic argument. Officers determined there had been no physical violence, but that one of the parties, 54 year old Ralph Monroe Boggs, of Richmond, had a warrant for violating his parole. Boggs was arrested for the warrant and booked into the County Jail. 13-0894

On April 14<sup>th</sup> at about 4:30 PM Ukiah Police responded to Kohl's, at 437 North Orchard Avenue, for a shoplifter. The suspect had fled from store employees, but was soon contacted and returned to the store. The 17 year old male juvenile suspect from Lucerne was observed concealing merchandise valued at over \$10.00 within his clothing, and left the store without paying. The juvenile was arrested for shoplifting and later released with a citation to a guardian. 13-0915

On April 15<sup>th</sup> at about 1:00 AM Ukiah Police were patrolling the area around Wal Mart and Jack in the Box, in the 1100 block of Airport Park Boulevard, and contacted a group of subjects in the parking lot. One of the subjects, 23 year old Paul Stephen Golyer, of Arizona, had warrants for his arrest from Mendocino and Marin Counties. Golyer was taken into custody and booked into the County Jail. 13-0919

On April 15<sup>th</sup> at about 3:10 PM Ukiah Police responded to the intersection of Orchard Avenue and Gobbi Street for a traffic accident involving a bicyclist. Officers found the bicyclist, a 25 year old male from Ukiah, laying in the intersection and he had suffered serious injuries. Officers learned the bicyclist had been traveling south on Orchard Avenue and a blue Toyota Prius was traveling east on Gobbi Street, and the two collided in the intersection. The bicyclist was taken to Ukiah Valley Medical Center for treatment. Several witnesses were interviewed and the cause of the collision is being determined. 13-0921

On April 15<sup>th</sup> at about 5:15 PM Ukiah Police responded to the 100 block of Norton Street for a male assaulting a female. Officers learned the suspect had been pepper spayed and left the area, and he was soon located and detained by responding officers in the 500 block of North State Street. The victim relayed she had been in the area of Shop 'N Wash when she was confronted by the male suspect, whom she did not know. The suspect, later identified as 41 year old Kevin Litzin, of Ukiah, appeared very drunk and yelled something to the victim about wanting something returned to him. The victim walked away from Litzin, who followed after the victim and eventually punched her in the side of her body while continuing to yell at her and behave irrationally. An unidentified female passerby who apparently witnessed this confrontation stopped and confronted Litzin, and sprayed him with pepper spray. Litzin left the victim alone and walked away, and the passerby left as well. The victim was uninjured, and placed Litzin under citizen's arrest for battery. Litzin was taken into custody and also charged with violating probation, and booked into the County Jail. 13-0923

On April 16<sup>th</sup> at about 1:50 PM Ukiah Police responded to Kohl's, at 437 North Orchard Avenue, regarding a shoplifter. Officers learned 22 year old Artemio Jimenez, of Clearlake, was observed concealing merchandise in his clothing, and left the store without paying. Jimenez was arrested for shoplifting. 13-0924
