### Statistics

Arrests included: 8 for public intoxication, 7 for shoplifting, 3 for possessing methamphetamine, 2 for domestic violence, and 1 each for: drug influence and/or possessing drug paraphernalia, warrant arrest, driving unlicensed, possessing an illegal weapon, elder abuse, burglary, and vandalism. Probation or parole holds were placed on 2 of these arrests.

Officers investigated 1 traffic collision, 1 injury traffic collision, and 2 deaths by apparent natural causes. One vehicle was impounded for 30 days due to the driver being unlicensed or suspended.

Officers took reports of: 7 found property, 5 thefts, 3 domestic violence, 2 vandalisms, 2 frauds, 2 threats, and 1 each of; animal bite, annoying telephone calls, child neglect, and battery with significant injury.

Officers assisted the Mendocino County Sheriff's Office with a fight call involving weapons, the Detective Bureau with a theft investigation, and the Mendocino Major Crimes Task Force with service of a narcotics related search warrant.

### Highlights for the Week

On April 17<sup>th</sup> at about 10:45 PM Ukiah Police contacted 38 year old Anita Christine Jimenez, of Ukiah, in the 600 block of Marshall Street. Jimenez displayed symptoms of recent drug use, and she was found to be under the influence of methamphetamine and arrested. A search of Jimenez' vehicle revealed a methamphetamine smoking pipe and less than one gram of methamphetamine. Jimenez was additionally charged with possessing drug paraphernalia and possessing methamphetamine. 13-0943

On April 18<sup>th</sup> at about 12:50 AM Ukiah Police responded to the Ukiah Valley Medical Center, at 275 Hospital Drive, for a reported assault. Officers contacted the victim who was being treated for a laceration to her mouth which would require sutures. The victim explained she confronted one of her roommates, 20 year old Daniel Kevin Pierce, regarding his being loud and playing music while she was trying to sleep. The two later had another confrontation, and Pierce punched the victim in the mouth then pushed her to the ground, and held his fist back as if to strike the victim again. The victim was injured and as she left the residence to obtain a ride to the hospital, her other roommates who had been present during the assault, laughed at the victim. Pierce was contacted later that evening and admitted pushing the victim down, but denied hitting her. Pierce was arrested for battery with significant injury and booked into the County Jail. 13-0945

On April 18<sup>th</sup> at about 3:50 AM Ukiah Police stopped a vehicle being driven by 55 year old Kevin Richard Hawkins, of Cloverdale, in the 1100 block of South State Street. There was marijuana found in Hawkins' vehicle, and a further search revealed less than one gram of methamphetamine and a pipe used to smoke the drug. Hawkins was arrested for possessing methamphetamine and drug paraphernalia. 13-0946

On April 18<sup>th</sup> at about 10:50 AM Ukiah Police stopped a vehicle being driven by 29 year old Jorge Gonzalez Alvarez, of Ukiah, in the 500 block of Ford Street. Alvarez had warrants for his arrest for contributing to a minor and was arrested. Alvarez' passenger was found to be on probation for stalking, and a search of the vehicle was conducted. Near where Alvarez was seated in the vehicle officers found two separate packages of methamphetamine weighing over 1 gram. Alvarez displayed symptoms of having used methamphetamine recently, and was

driving with a suspended driver's license. Alvarez was charged with possessing methamphetamine and driving unlicensed. Alvarez' passenger was released. 13-0949

On April 18<sup>th</sup> at about 8:00 PM Ukiah Police responded to the Wal Mart parking lot, at 1155 Airport Park Boulevard, for a subject trying to fight several others and allowing his dog to run loose. Officers contacted 32 year old Mark Joseph Weatherly, of Fort Bragg, who was yelling at others aggressively while trying to control his agitated dog. Weatherly was found to be intoxicated and was arrested for public drunkenness, and his dog was released to the care of Mendocino County Animal Control. 13-0953

On April 20<sup>th</sup> at about 1:30 PM Ukiah Police responded to 425 East Gobbi Street for a fight in the parking lot. Officers located three subjects who appeared to have been fighting, one of whom was identified as 26 year old Shannon Albert Roy Kidd, of Ukiah. Kidd was seen making furtive movements to his pants pocket, which officers found contained marijuana and a large railroad spike. Kidd was arrested for possessing a concealed stabbing weapon. 13-0965

On April 20<sup>th</sup> at about 7:05 PM Ukiah Police responded to a residential care home within the city of Ukiah regarding problems with an employee. Officers learned 40 year old Sandra Lariza Gonzalez, of Ukiah, was seen involved in a physical confrontation with a resident and may have been attacked by the resident, who suffers a medical condition. Gonzalez, however, smelled of alcohol, and officers determined Gonzalez had been drinking and had a significant blood alcohol level. Several bottles of alcohol were also located hidden within the facility and in Gonzalez' possession. Gonzalez was arrested for elder abuse. 13-0967

On April 20<sup>th</sup> at about 11:50 PM Ukiah Police stopped a vehicle being driven by 40 year old Danielle Ann Asbury, of Clearlake, in the 100 block of Scott Street. Asbury had been drinking, and was found too intoxicated to drive and was arrested for DUI. 13-0970

On April 23<sup>rd</sup> at about 12:10 AM Ukiah Police responded to the Pear Tree Center, at 502 East Perkins Street, for a Sonoma Sweeper employee reporting the tires to his sweeper vehicle had been slashed. Officers learned the employee was driving the sweeper in the lot and was being taunted by a subject, who at one point threw a cigarette at the sweeper vehicle. The employee later parked the sweeper and was in another area of the lot and saw the subject slash

two of the sweeper's tires. Officers located the suspect, identified as 58 year old David Charles Guisti, of Fort Bragg, near JC Penney's. Guisti had a large knife used to damage the tires, concealed on his person, and was arrested for possessing a dangerous weapon and for vandalism. 13-0982

On April 24<sup>th</sup> at about 5:35 AM Ukiah Police responded to the World Gym, at 203 South Main Street, for an intoxicated subject harassing female patrons. Officers learned 39 year old Wayne Ryan Campbell had contacted the females as they arrived to the location, asking them to go to the bushes with him. Campbell was intoxicated and was in violation of his parole by drinking. Campbell was arrested for public intoxication and the parole violation. 13-0991

On April 24<sup>th</sup> at about 9:05 PM Ukiah Police responded to Kohl's, at 437 North Orchard Avenue, for a shoplifter. Officers learned 21 year old Lois Kayleen Erich, of Chico, was observed inside the store, then leave the store with a pair of shoes without paying. Erich was arrested for shoplifting. 13-1001
