### **Statistics**

**Arrests included: 10 for public intoxication, 5 warrant arrests, 4 for domestic violence, 2 for burglary, and 1 each for: drug influence and/or possessing drug paraphernalia, violating probation, possessing an inhalant, battery, shoplifting, possessing marijuana, possessing marijuana at school, resisting arrest, and prohibited possession of a stun gun. Probation or parole holds were placed on 2 of these arrests.**

**Officers investigated 1 traffic collision. One vehicle was impounded for 30 days due to the driver being unlicensed or suspended.**

**Officers took reports of: 5 found property, 5 thefts, 3 burglary, 2 abandoned vehicle, 2 identity theft, and 1 each of; assault, child neglect, animal bite, elder abuse, suicidal subject, brandishing a weapon, vandalism, shoplifting, and annoying a child.**

### **Highlights for the Week**

On May 15<sup>th</sup> at about 10:20 PM Ukiah Police responded to the 200 block of Ford Street for a reported fight. Officers contacted several people including 40 year old Billy Joe Rickman, of Philo, who was on PCRS probation. Rickman had a syringe in his possession, and was found to have used drugs recently and was arrested for being under the influence of a controlled substance. 13-1228

On May 16<sup>th</sup> at about 7:20 PM Ukiah Police responded to a residence in the 600 block of Leslie Street for a welfare check of a subject believed to be under the influence of a controlled substance. Officers contacted 60 year old Helayne Gomez Hutchinson, and found she had been inhaling the contents of "Dust Off". Officer found several empty and partially used cans of "Dust Off", and arrested Gomez Hutchinson for possessing an inhalant. 13-1235

On May 16<sup>th</sup> at about 10:40 PM Ukiah Police contacted several subjects who were yelling, in the 1200 block of Airport Park Boulevard. One of the subjects, 35 year old Allan Lee Haverkamp, of Texas, was agitated and had been drinking, and was arrested for public intoxication. 13-1237

Marfil was arrested for being under the influence of a controlled substance and for possessing methamphetamine. Marfil was also charged with driving on a suspended driver's license. 13-1251
