### **Statistics**

**Arrests included: 7 warrant arrests, 6 for domestic violence, 5 for public intoxication, 3 for violating probation, 2 for shoplifting, and 1 each for: drug influence and/or possessing drug paraphernalia, resisting arrest, providing false identity, and trespassing. Probation or parole holds were placed on 2 of these arrests.**

**Officers investigated 1 traffic collision, 1 hit and run traffic collision, and 1 DUI traffic collision. Two vehicles were impounded for 30 days due to the drivers being unlicensed or suspended.**

**Officers took reports of: 5 child neglect, 3 thefts, 3 vandalisms, 2 found property, 2 burglary, 2 identity theft, 2 missing persons, 2 animal bite, and 1 each of; grand theft, threats, violating a court order, and annoying a child.**

### **Highlights for the Week**

On May 24<sup>th</sup> at about 12:45 AM Ukiah Police stopped 38 year old Odessa Corrine Oneil, of Ukiah, in the 10 block of Betty Street. Oneil had warrants for her arrest and was placed into custody, and was found to possess pepper spray. As a convicted felon Oneil is prohibited from possessing pepper spray and was charged and booked into the County Jail. 13-1298

On May 24<sup>th</sup> at about 10:10 PM Ukiah Police responded to Wal Mart, at 1155 Airport Park Boulevard, for a shoplifter. The officer learned 32 year old Maria Isabel Marfil, of Ukiah, was observed by store employees concealing clothing, valued at over \$50.00, inside her purse then leave the store without paying. Marfil was contacted outside the store with 22 year old Joshua Jordan Keys, who activated the security scanner upon exiting the store. Keys denied stealing anything from the store, but was found with a stolen wallet in his pants pocket which he claimed to have forgotten to pay for. Keys and Marfil were arrested for shoplifting, and a search of Marfil's purse revealed two hypodermic syringes, one of which was found to contain liquid methamphetamine. Marfil was also charged with possessing a controlled substance. 13-1307

On May 25<sup>th</sup> at about 10:05 PM Ukiah Police responded to the apartment complex at 875 South Oak Street for a hit and run traffic collision. Officers learned witnesses observed 31 year old Thang Van, of Newark, back his 2011 Toyota Camry out of a parking stall and collide with a portion of the building. Van then fled into an apartment, where he was located by officers. Van had been drinking, and was found to be too intoxicated to drive and was arrested for DUI and hit and run. 13-1315

On May 26<sup>th</sup> at about 5:20 PM Ukiah Police responded to a residence in the 600 block of Leslie Street for a domestic disturbance. Officers learned 42 year old Shawn Johnson had apparently stolen the victim's cellular telephone several days prior, and since had sent the victim text messages with it to another of the victim's phones. Johnson texted the victim he would return the victim's phone in exchange for a ring he had given the victim, then texted he would return the phone in exchange for sex, and also texted he would physically harm the victim. At about 8:20 PM Johnson was located and arrested in the 4900 block of North State Street, and was found in possession of the victim's cell phone. Johnson was charged with threats, and for violating a domestic violence court order allowing for only peaceful contact between Johnson and the victim. 13-1319

On May 26<sup>th</sup> at about 8:10 PM Ukiah Police responded to a residence in the 700 block of South State Street for a domestic violence incident. Officers learned 37 year old Davis Ruiz Chavez had been drinking, and became engaged in an argument with the victim. Chavez dragged the victim by her hair to the stove and threatened to burn her, and destroyed the victim's phone when she attempted to call for help. Chavez was arrested for domestic violence, threats, and preventing a victim from contacting 9-1-1. A restraining order was obtained preventing Chavez from contacting the victim. 13-1320

On May 26<sup>th</sup> at about 8:55 PM Ukiah Police responded to a residence in the 600 block of West Standley Street for a vehicle that had collided with the house. Officers found 53 year old Joan Ellen Rainville, of Ukiah, in the backyard of the residence near a 2008 Toyota Camry, which had been driven through a fence and into the side of the residence causing an interior wall to crack and move inward. Officers determined the room in the area of the house which had been run into was occupied at the time of the collision, although no occupants were injured. Rainville denied driving the vehicle at the time of the collision and claimed it had been her mother who was driving. Witnesses observed Rainville, who had been drinking, driving the vehicle and she was arrested for DUI. Rainville was on probation for a previous drunk driving incident, her driver's license was suspended, and she was prohibited from driving a vehicle without an ignition interlock device. Rainville was also charged with violating her probation, driving with a suspended driver's license, and without an interlock. 13-1321

On May 28<sup>th</sup> at about 9:20 AM Ukiah Police responded to McDonald's, at 115 North Orchard Avenue, for a disturbance. Officers learned 34 year old Scotty Lee Willis had entered the restaurant with two dirty soda cups, and attempted to fill the cups with soda. The restaurant manager stopped Willis, who became irate and yelled, calling the employee derogatory names. Willis was asked and told numerous times to leave the restaurant, but refused to do so. Willis was located near-by and was with 24 year old Kelisha Alvarez. Willis was placed under citizen's arrest for trespassing and was taken into custody. Alvarez became agitated and demanded she be given cigarettes Willis had in his possession. Alvarez then charged past the arresting officers, against their direction, reaching for the cigarettes, and had to be physically held back. Alvarez was arrested for interfering with law enforcement, and later kicked one of the officers in the leg. Alvarez was also charged with battery upon a peace officer. 13-1329

On May 28<sup>th</sup> at about 12:30 PM Ukiah Police responded to the bus stop in the 100 block of North Orchard Avenue for a male subject who had reportedly pointed a firearm at the caller and pulled the trigger. Officers located the suspect, 25 year old Steven Matthew Rich, and soon located the weapon which was determined to be an empty BB pistol. The caller declined prosecution, and Rich was arrested for being too intoxicated to care for his own safety. 13-1332

On May 29<sup>th</sup> at about 11:55 PM Ukiah Police stopped a vehicle being driven by 43 year old Daniel Joseph Lopes, of San Francisco, in the 100 block of KUKI Lane. Lopes was driving with a suspended driver's license, and had a warrant for his arrest from Glendale, for a previous DUI. Lopez had been drinking, and was found to be too intoxicated to drive and was arrested for DUI, and charged with driving with a suspended driver's license. 13-1344

On May 30<sup>th</sup> at about 12:15 AM Ukiah Police responded to a residence in the 100 block of Leslie Street for a physical domestic violence incident in progress. A Ukiah Police Sergeant responded while requesting back-up from the Mendocino County Sheriff's Office as the other on-duty UPD officers were on other matters and unavailable. The UPD Sergeant arrived by himself and observed a female run out of residence, and a male following with an angered demeanor and with his fists clenched. The sergeant stopped the male, identified as 54 year old Tony Allan Paul, and detained him. The Sergeant learned Paul and the victim had been drinking, and after becoming involved in an argument Paul shoved food into the victim's face. Paul threatened to harm the victim, and kicked furniture over causing damage to the walls. The victim was outside and had telephoned 9-1-1, and Paul took the phone and smashed it into the ground. The victim re-entered the residence and closed and locked the door, and Paul kicked the door down causing it to dislodge from its frame and land inside the residence. Paul followed the victim out of the house until being stopped by the sergeant. Paul was arrested for domestic violence, vandalism, and disrupting a 9-1-1 call, and a restraining order was obtained prohibiting Paul from contacting the victim. 13-1345
