Patrol Division Weekly Activity Report 6/13/13 to 6/19/13

Statistics

Arrests included: 5 for public intoxication, 5 for drug influence and/or possessing drug paraphernalia, 4 warrant arrests, 4 for shoplifting, 2 for domestic violence, and 1 each for: violating probation, indecent exposure, vandalism, possessing methamphetamine, battery and trespassing. Probation or parole holds were placed on 2 of these arrests.

Officers investigated 2 traffic collisions, 2 hit and run traffic collisions, and 1 injury traffic collision. Two vehicles were impounded for 30 days due to the drivers being unlicensed or suspended.

Officers took reports of: 5 found property, 5 thefts, 4 burglary, 3 animal bites, 3 identity theft, 2 suicidal subjects, 2 arsons, 2 child neglect, and 1 each of; threats, abandoned vehicle, stolen vehicle, domestic violence, vandalism, and missing person.

Officers assisted State Parole with locating a parolee at large, and the Sonoma County Sheriff's Office with a narcotics related investigation.

Highlights for the Week

On June 9th at about 5:20 AM Ukiah Police responded to Jack in the Box, at 1115 Airport Park Boulevard, for a suspicious male subject wearing a ski mask. Officers located a subject wearing a ski mask standing in the outside dining area, and identified him as 23 year old Travis Joseph Humphrey. Officers spoke with employees who'd witnessed Humphrey outside the store, exposing his genitals to them. Humphrey was too intoxicated to care from himself and was arrested. On June 10th at about 7:45 PM Humphrey was causing a disturbance at Safeway, at 653 South State Street, and was warned for panhandling and allowed to leave. At about 11:30 PM Ukiah Police responded to Wal Mart, at 1155 Airport Park Boulevard, as Humphrey was observed removing branches from a tree in the parking lot. Humphrey had also thrown an item in front of a moving vehicle, and then stood in front of the vehicle preventing the driver from leaving. Humphrey was again intoxicated and was arrested. On June 16th at about 2:10 PM Ukiah Police responded to the Quik Stop, at 1105 Airport Park Boulevard, for Humphrey causing a disturbance. Officers learned Humphrey had entered the store and began harassing customers. The store employee recognized Humphrey and remembered he had previously urinated inside the store. Humphrey was uncooperative when asked to leave by the employee, but eventually did so. Humphrey then reportedly approached a female customer in the nearby parking lot, and made sexually related comments to her while trying to hold onto her wrists. Humphrey was contacted by officers and refused to cooperate, and had to be physically detained. Humphrey was arrested for trespassing and battery, and after being placed into the patrol car began kicking the partition and windows and had to be further restrained. 13-1503

On June 10th at about 10:55 AM Ukiah Police stopped a vehicle being driven by 24 year old Leonard Avalos Castro, in the 100 block of Laws Avenue. Castro did not have a driver's license, and a search of his vehicle revealed several baggies of methamphetamine concealed within the vehicle. A subsequent search of Castro's residence revealed additional methamphetamine, and a large amount of cash. Castro was arrested for driving unlicensed, and for possessing and transporting methamphetamine for sale. 13-1443

On June 11th at about 5:10 PM Ukiah Police responded to a residence in the 600 block of North Orchard Avenue for a report of a male subject who'd entered the residence and attacked the occupant. Officers learned from the victim that a neighbor, 48 year old Wayne Edward Griffin, had entered the residence through the front door and encountered the victim in the

hallway. Griffin yelled at the victim and attacked him, punching the victim and forcing him to the ground. Griffin was eventually pulled away from the victim by another subject, and had fled the area. The victim was treated at the Ukiah Valley Medical Center for moderate injuries sustained during the attack. The victim stated the attack was unprovoked and did not know why Griffin had done so. On June 14th at about 2:45 PM Griffin was spotted driving a vehicle in the 300 block of North Orchard Avenue. Griffin was stopped and arrested for trespassing and battery with significant injury. 13-1458

On June 13th at about 4:05 PM Ukiah Police Officers were contacted by a citizen in the 700 block of Waugh Lane reporting a suspicious male subject in the bushes, near the railroad tracks. Officers learned a man wearing only socks was observed by an adult and a child, and that he appeared to be masturbating. Officers searched the area and eventually located 43 year old Douglas Clark Holcomb, hidden amongst the bushes. Holcomb was laying down wearing only socks and had his hands on his genitals. Holcomb admitted to having used methamphetamine several hours prior and had been masturbating in the bushes since. A check of Holcomb's belongings revealed less than one gram of methamphetamine, and Holcomb was arrested for possessing a controlled substance, being under the influence, indecent exposure, and annoying children. 13-1481

On June 13th at about 7:10 PM Ukiah Police responded to the Food Maxx parking lot, at 1235 Airport Park Boulevard, for vandalism to a vehicle. Officers learned the victim had been backing her car out of a parking space when a subject suddenly punched the rear of her vehicle. The victim saw 25 year old Alberto Vincent Acosta standing at the rear of her vehicle, and determined he had dented her vehicle by punching it, claiming the victim had nearly struck him. A witness observed the incident and stated Acosta was not in danger of being struck, and the punching of the vehicle was unwarranted. Acosta admitted he'd punched the vehicle and that he had not been struck by it. Acosta's mother intervened and tried to tell the officers that the vehicle had struck Acosta. Officers arrested Acosta for vandalism and violation of probation. 13-1482

On June 16th at about 12:50 AM Ukiah Police were notified an intoxicated subject had been refused the sale of alcohol in Safeway, and was seen driving away in a vehicle. Officers soon located the vehicle and stopped it in the 200 block of East Gobbi Street. The driver, 33

year old William Shelton Jones, of Clearlake, had been drinking, and was found to be too intoxicated to drive. Jones was arrested for DUI. 13-1499

On June 16th at about 6:40 AM Ukiah Police responded to the area of Myron Place and Ford Street for a subject looking into vehicles. Officers contacted 20 year old Jaime Nieto Gonzalez, who exhibited symptoms of recent drug use. Gonzalez was found to possess less than one gram of methamphetamine, and was arrested for being under the influence and for possessing methamphetamine. 13-1500

On June 17th at about 2:30 AM Ukiah Police stopped a vehicle in the 900 block of Low Gap Road. Officers contacted 33 year old Jose Alfred Martinez, who was a passenger in the vehicle. Martinez had warrants for his arrest from Sacramento County, for domestic violence and for violating probation. Martinez was arrested and was found to possess less than one gram of methamphetamine. 13-1510
