Statistics

Arrests included: 6 for public intoxication, 3 for shoplifting, 3 warrant arrests, 3 for domestic violence, and 1 each for: drug influence and/or possessing drug paraphernalia, possessing methamphetamine, threats, burglary, possessing a narcotic, stolen vehicle, assault with a deadly weapon, suspended license, arson, and battery. Probation or parole holds were placed on 2 of these arrests.

Officers investigated 1 traffic collision and two deaths by apparent natural causes. Two vehicles were impounded for 30 days due to the drivers being unlicensed or suspended.

Officers took reports of: 4 found property, 4 domestic violence, 3 thefts, 3 marijuana cultivation, 2 suicidal subjects, and 1 each of; threats, stolen vehicle, vandalism, violation of restraining order, sodomy, robbery, identity theft, and fraud.

Officers assisted the Mendocino Major Crimes Task force with several narcotics investigations.

Highlights for the Week

On June 15th at about 8:25 PM Ukiah Police responded to a room at the Super 8 Motel, at 693 South Orchard Avenue, for a disturbance involving a mother and her son. Officers contacted 56 year old Robin Christina Goodnough and 25 year old Joshua Ernest Goodnough, both of whom had been drinking to excess. Robin and Joshua were arrested for public intoxication. 13-1497

On June 20th at about 11:30 AM Ukiah Police responded to Wal Mart, at 1155 Airport Park Boulevard, for a disturbance. Officers were contacted by store employees, who stated a subject confronted one of the employees inside the store, and threatened to stab the employee. The suspect, 19 year old Michael Lewis Mabery of Upper Lake, was located near-by and was arrested for threats. 13-1541

On June 22nd at about 1:45 AM Ukiah Police stopped a vehicle being driven by 34 year old Amanda Slade, of Ukiah, in the 100 block of East Smith Street. Slade had been drinking and was found to be too intoxicated to drive, and was arrested for DUI. Her passenger, 39 year old Ole Spencer Stribling, was told he could leave but instead became belligerent and began yelling profanities at the officers. Stribling had been drinking and nearly fell upon exiting the vehicle, was arrested for public intoxication. 13-1559

On June 23rd at about 7:15 PM Ukiah Police responded to the 1300 block of South State Street for a subject passed out along the street. Officer contacted 43 year old Dennis John Dunsing, of Fort Bragg, who was arrested for public intoxication. 13-1569

On June 22nd at about 12:00 PM Ukiah Police responded to the area of the Safeway parking lot, at 653 South State Street, for a suspicious male seen entering parked vehicles. The officer located the suspect nearby on Porzio Lane, and saw he was looking through a large bag or various items. The officer determined the suspect, identified as 27 year old Andrew Jeffrey Gitchel, of Albion, had several cell phones, a wallet, and some other various items in his possession. The officer was able to determine Gitchel was seen reaching into several partially open vehicles' windows unlocking the doors, and removing items from the vehicles. The officer later determined Gitchel possessed items taken from other vehicles within the City over a period

of 2 days and was involved with thefts from retail stores. Gitchel was arrested for burglary and for possessing stolen property. 13-1562

On June 24th at about 11:25 AM Ukiah Police investigated a child abuse incident, wherein a 1 year old child sustained injuries over the past several weeks, noticed after being in the care of 21 year old Elevterio Montalvo-Perez. The injuries consisted of a burn and some bruising, and appeared inconsistent with his explanations of how the child was injured. The child's mother also reported injuries sustained during a domestic argument with Montalvo-Perez. At about 6:00 PM Montalvo-Perez was located and arrested for child abuse, and for domestic violence. 13-1575

On June 24th at about 5:05 PM Ukiah Police responded to the area of the 800 block of Grove Avenue for a suspicious subject selling magazine subscriptions without a business permit. Officers located the subject near Willow and Springs Streets, and learned there were numerous other individuals in the area also selling magazines, and that the group was transported and dropped off in Ukiah from out of the area. The subject was identified as 22 year old Raymart Santiago Ramirez, of Santa Maria, who had a warrant from Santa Barbara County for violating parole and was arrested. 13-1582

On June 25th at about 10:00 AM Ukiah Police responded to a room at the Super 8 Motel, at 693 South Orchard Avenue, for a domestic violence incident. Officers contacted the victim and 20 year old Morgan Nicolette Marita, of Clearlake Oaks. Officers learned the couple had been in a fight over their infant child, during which time Marita pushed and hit the victim, and also hit herself. Marita was arrested for domestic violence. 13-1586

On June 25th at about 5:40 PM Ukiah Police were notified of a stabbing which had occurred in the 500 block of South Dora Street. The caller reported having witnessed the stabbing and was transporting the victim to the Ukiah Valley Medical Center for treatment. Responding officers found the victim being treated for a stab wound to the upper extremities which would require sutures.

Officers learned the victim had been stabbed by a subject known only to him as "Blaine", who was apparently angered upon learning the victim was outside Blaine's girlfriend's residence.

Apparently Blaine traveled to the location and confronted the victim outside the residence with a large knife displayed, demanding the victim leave, and stabbed the victim at least once during an ensuing scuffle. The caller had arrived to pick up the victim at about this time, and witnessed the altercation and saw the suspect flee in a vehicle. The caller followed the suspect briefly, and then transported the victim to the hospital.

An officer responded to the location of the stabbing, hoping to contact the girlfriend to further identify the suspect. The officer found the suspect had returned to the residence, and he was quickly taken into custody and arrested. The suspect, identified as 62 year old Robert Blaine Bennett, admitted to confronting and stabbing the victim. The knife used by Bennett was recovered, and Bennett was booked into the County Jail for brandishing a weapon, and assault with a deadly weapon. 13-1592

On June 25th at about 11:30 PM Ukiah Police contacted a subject walking and waiving a stick in the 200 block of Mason Street. The subject was identified as 34 year old Bruce Eugene Bates, of Laytonville, who displayed symptoms of recent drug use. Bates was found to be under the influence of a controlled substance and was arrested. 13-1593
