### Patrol Division Weekly Activity Report 7/11/13 to 7/17/13

### Statistics

**Arrests included: 8 for public intoxication, 6 warrant arrests, 4 for drug influence and/or possessing drug paraphernalia, 3 for prowling, 2 for shoplifting, 2 for resisting arrest, 2 for driving with a suspended driver's license, and 1 each for: providing a false name to law enforcement, violating court order, and possessing pepper spray by a convicted felon. Probation or parole holds were placed on 4 of these arrests.**

**Officers investigated 3 traffic collisions and 4 deaths by apparent natural causes. Three vehicles were impounded for 30 days due to the drivers being unlicensed or suspended.**

**Officers took reports of: 7 thefts, 5 vandalisms, 4 child neglect, 4 found property, 3 suicidal subjects, 2 burglaries, 2 rapes, 2 animal bites, 2 domestic violence, and 1 each of; stolen vehicle, violation of restraining order, abandoned vehicle, missing person, explosive device, recovered stolen vehicle, child abuse, elder abuse and fraud.**

**Officers assisted the Mendocino Major Crimes Task force with several narcotics investigations, and Mental Health with several walk-aways.**

### Highlights for the Week

Between July 8<sup>th</sup> and July 11<sup>th</sup> the Ukiah Police Department investigated several domestic violence incidents between 30 year old Benjamin Franklin Hoff, and a 23 year old victim. The incidents involved physical violence consisting of Hoff pushing and shoving the victim, and also violating a domestic violence restraining order prohibiting Hoff from contacting the victim. Hoff had fled following each incident, and Ukiah Police had issued a Be On the LookOut for the arrest of Hoff. On July 12<sup>th</sup> at about 10:45 AM Hoff again violated the restraining order, and was reported to be in the 200 block of Norton Street. Officers responded and spotted Hoff hiding behind an electrical box in the area. Hoff immediately fled on foot and officers gave chase. Hoff jumped several fences in the area of Norton and Main Streets with officers in foot pursuit, and he was eventually captured in the back lot of a building in the 500 block of South State Street. Hoff was arrested for multiple counts of domestic violence and restraining order violations, and resisting arrest. 13-1765

On July 12<sup>th</sup> at about 10:05 PM Ukiah Police responded to the area of the 100 block of South State Street near Perry Street for a fight involving numerous gang members. Upon arriving officers saw numerous subjects run away, and located three subjects hiding in the backyard of a residence in the 100 block of Rupe Street. Officers found 20 year old Jose Carlos Arreola was in possession of a switchblade knife, and he was arrested for prowling and illegal weapons possession. Another of the subjects, 19 year old Roy Medina Sanchez, had been drinking in violation of his probation, and was arrested for violating that probation and prowling. A third subject, a 14 year old male juvenile, was arrested for prowling and booked into Juvenile Hall. 13-1769

On July 13<sup>th</sup> at about 7:30 AM Ukiah Police responded to the 300 block of North Main Street for a reported explosive device. Officers found a suspicious cylindrical device nearly a foot long and about 1" in diameter, and consistent with a homemade or modified firework. The device had apparently been located inside a larger metal cylinder, consistent with some kind of improvised explosive device. The Sonoma County Sheriff's Bomb Squad was contacted and responded, and safely detonated the device in place. 13-1774

On July 17<sup>th</sup> at about 7:30 AM Ukiah Police responded to a residence in the 1000 block of South Street for a domestic disturbance. Officers learned 23 year old Fabian Reyes Rosales

had come to the residence in violation of a domestic violence restraining order, prohibiting him from contacting the victim. When Rosales refused to leave an argument ensued. Rosales was found to possess a canister of pepper spray, and as a convicted felon was prohibited from doing so. Rosales was arrested for violating a domestic violence restraining order, and prohibited possession of pepper spray. 13-1815

On July 17<sup>th</sup> at about 9:05 PM Ukiah Police responded to the Ukiah Valley Medical Center at 275 Hospital Drive, for an intoxicated subject that had been earlier transported there for extreme intoxication. The subject, 31 year old Erik Wayne Mohan, of Santa Barbara, was arrested for public intoxication. 13-1831
