Statistics

Arrests included: 6 warrant arrests, 5 for public intoxication, 5 for domestic violence, 4 for drug influence and/or possessing drug paraphernalia, 3 for vandalism, 2 for burglary, 2 for possessing methamphetamine, and 1 each for: resisting arrest, providing a false name to law enforcement, possessing heroin for sale, possessing methamphetamine for sale, possessing a narcotic, possessing an illegal weapon, trespassing, and identity theft. Probation or parole holds were placed on 2 of these arrests.

Officers investigated 1 traffic collision and 1 hit and run traffic collision. Two vehicles were impounded for 30 days due to the drivers being unlicensed or suspended.

Officers took reports of: 11 vandalism, 6 found property, 4 thefts, 2 burglaries, 2 identity theft, 2 abandoned vehicles, and 1 each of; suicidal subject, stolen vehicle, missing person, counterfeit bill, assault with a dangerous weapon, battery, and fraud.

Highlights for the Week

On July 16th at about 3:50 PM Ukiah Police investigated a reported child abuse. Officers learned the suspect, 48 year old William Williams, was suspected of pouring gasoline into a 2 year old's child seat. The child also had visible marks and bruising apparently sustained while in Williams' care and custody, and were believed to have come from being struck with a belt and buckle. Williams was arrested for child abuse. 13-1811

On 07/18/2013 at about 1137 PM, A Ukiah Police Department Officer conducted a traffic stop on a red 1989 GMC Sierra traveling northbound in the 800 block of S. State St. The Driver, Jessie Bridges (age 31 of Cottage Grove, Or) was found to be driving on a suspended drivers license and under the influence of a controlled substance. The passenger, Carrie Heth (age 26 also of Cottage Grove, Or) was found to be in possession of heroin and drug paraphernalia. Upon further investigation Officers were able to determine that both were staying in a local motel and obtained a search warrant for the motel room in which additional drug paraphernalia, methamphetamine, scales, packaging, a Glock .40 cal handgun, and a police baton were seized. Both were later booked into the Mendocino County Jail.

On July 19th at about 1:45 AM Ukiah Police responded to the 100 block of Ford Street regarding a possible domestic disturbance. Officers located two subjects in the area and attempted to contact them. One of the subjects, 28 year old Sterling Edward Guillory, of Santa Rosa, suddenly began running away with the officer in foot pursuit. Guillory ran down Joseph Street and jumped a fence into a private yard. Several citizens reported seeing Guillory run through nearby yards, and the officer then saw a citizen running after Guillory on Clara Avenue. Guillory was soon apprehended and arrested for resisting arrest. Officers determined Guillory had been in an altercation with another male subject, and his girlfriend had been yelling loudly at them. Guillory said he ran because he believed he was going to be arrested, and that he was going to make the police work for it. 13-1849

On July 20th at about 3:05 AM Ukiah Police responded to Safeway, at 653 South State Street, for a suspicious subject who had been inside the store for an extended period of time selecting items, but apparently not going to purchase them. Officers contacted 21 year old Aaryan Devon Kekoa Fischer, of Ukiah, who displayed symptoms of having used methamphetamine recently. Fischer admitted to recent drug use, and had provided the officer with false identifying information. As the officer began to arrest Fischer, he suddenly ran across State Street and towards the Ukiah Theater with the officer in foot pursuit. The officer caught up to Fischer and after a brief struggle was able to take Fischer into custody. Fischer had numerous hydrocodone tablets in his possession, and was charged with possessing a narcotic, being under the influence of a controlled substance, providing false identity, and resisting arrest. 13-1859

On July 1st, 2013, Ukiah Police Officers investigated the burglary of a residence in the 800 block of Waugh Lane. Officers learned the victims had allowed a couple to reside with them in their residence recently, though they only knew the male subject by his nickname. Several days prior the victims arrived home and had difficulty unlocking their front door. Once they were able to enter they encountered their guests, who stated they'd had friends over and believed the friends had stolen items from the victim's residence. The guests then hurriedly left. The victims determined numerous items had been taken from their residence, including electronics and firearms. The following day one of the guests contacted the victim and returned some of the stolen property, including a firearm and some electronics.

Later in the month of July officers were re-contacted by the victims and told the suspect had returned additional stolen property, though there were additional electronics and a firearm still outstanding. Officers were able to use the description and nickname provided to eventually identify the suspect as 23 year old Andrew John Martinez, who was a convicted felon and had a warrant for his arrest for violating his Post Community Release Supervision (formerly parole). An armed and dangerous “Be On the LookOut” for Martinez was broadcast.

On July 20th at about 2:00 PM Officers determined Martinez was inside a residence in the 500 block of Donner Court. With assistance from the Mendocino County Sheriff’s Office and California Highway Patrol, a perimeter was established around the location as was communication with the occupants. Martinez initially refused to exit the residence, but by 2:45 PM Martinez was taken into custody outside without incident.

A search warrant was served at the residence and located amongst Martinez’ belongings was the outstanding firearm and missing electronics. Officers also found indications of drugs sales including a large amount of money, as well as an assortment of other electronic devices, a sawed off rifle with a modified hand grip, an assortment of ammunition, jewelry, a shortened barrel from another firearm, illegal fireworks, and growing marijuana plants. Martinez was charged with grand theft of a firearm, burglary, possessing stolen property, possession of a firearm by a convicted felon, possession of a shortened rifle, and violating his supervised release.

On July 22nd at about 5:30 PM Ukiah Police responded to the area near Wal Mart at 1155 Airport Park Boulevard, for a fight. Officers located 23 year old Jacob Warren Hopkins, of Washington, who had a small amount of blood on his face and hands though he denied having been in a fight. Hopkins was arrested for public intoxication, and began striking the interior of the police vehicle once placed inside. Hopkins was further secured and booked into jail. 13-1887

On July 24th at about 3:35 AM Ukiah Police responded to the 300 block of West Church Street for a theft from a vehicle. While searching the area for suspects, officers contacted 36 year old Daniel William Saia, of Redwood Valley, in the 200 block of Church Street. Saia was found to possess “paint pens” typically used by taggers for graffiti, and also to have two warrants for his arrest. Saia was taken into custody, and a further search his belongings revealed

a hypodermic syringe, hydrocodone tablets, and numerous pages of practice “taggings” and graffiti. Upon further investigation officers were able to determine Saia was responsible for numerous previously reported graffiti cases in the Ukiah area. Saia was charged with felony vandalism, possessing a narcotic, possessing graffiti instruments, and warrants for violating probation and drug influence. 13-1906
