### Patrol Division Weekly Activity Report 7/25/13 to 7/31/13

### Statistics

Arrests included: 7 warrant arrests, 4 for domestic violence, 4 for transporting marijuana, 3 for public intoxication, 3 for drug influence and/or possessing drug paraphernalia, 3 for vandalism, 2 for possessing methamphetamine, 2 for shoplifting, and 1 each for: burglary, resisting arrest, possessing methamphetamine for sale, and possessing a narcotic. Probation or parole holds were placed on 4 of these arrests.

Officers investigated 1 death by apparent natural causes.

Officers took reports of: 7 thefts, 7 found property, 5 vandalisms, 3 burglaries, 3 battery, 3 missing persons, 2 animal bites, and 1 each of; suicidal subject, elder abuse, transportation of marijuana, and domestic violence.

Officers assisted the Ukiah Police Detective Bureau with a fraud investigation, the Mendocino County Sheriff's Office with a probation search and a missing person investigation, the Ukiah Valley Medical Center with a walk-away, the Mental Health Department with a walk-away, Adult Protective Services with an elder abuse investigation, and conducted a cyber-bullying presentation.

### Highlights for the Week

On July 25th at about 8:45 AM Ukiah Police responded to a room at the Regency Inn, at 1070 South State Street, for an unresponsive male subject. Officers learned hotel staff had discovered the subject unconscious on the bed, and were unable to wake him. Officers recognized the subject as 23 year old Francisco Enrique Gonzalez, who had a warrant for his arrest from the California Department of Corrections for violating parole. Officers were able to awaken Gonzalez and took him into custody for the warrant. Officers noticed a small amount of methamphetamine and a methamphetamine smoking pipe atop a table inside the room, alongside a handgun which was determined to be loaded. Gonzalez was in possession of a small scale commonly used in the sales of drugs, and additional methamphetamine, items consistent with drug sales, and over half an ounce of marijuana were located inside the room. Gonzalez was charged with possessing methamphetamine for sale, being armed in the commission of a felony, prohibited possession of a firearm and ammunition by a convicted felon, possessing drug paraphernalia, and violating parole. 13-1913

On July 25<sup>th</sup> at about 11:15 AM Ukiah Police responded to a residence in the 600 block of North State Street at the request of Child Protective Services. Officers contacted 20 year old Anna SylviaRomero Wright, who was suspected of being under the influence of a controlled substance. Wright was found to have used methamphetamine recently, and was arrested for drug influence. Wright's infant daughter was released to the care of Child Protective Services. 13-1918

On July 25<sup>th</sup> at about 10:00 PM Ukiah Police responded to the Qwik Stop, at 1105 Airport Park Boulevard, for a male passed out in the bathroom with a syringe. Upon arrival the officers learned the suspect had left and was seen walking across the Wal Mart parking lot. Officers contacted 23 year old Andrew Scott Greshle, who threw an item into the bushes upon seeing the officer. The item was located and was determined to be the bottom of a soda can with a black tarry substance on it, which was identified as heroin. Greshle had a syringe and other items used to inject heroin, and was arrested for possessing a narcotic and drug paraphernalia. 13-1924

On July 25<sup>th</sup> at about 11:50 PM Ukiah Police responded to the Motel 6, at 1208 South State Street, regarding a loud disturbance. An officer contacted 33 year old Reyes Estrada

Gutierrez, of Los Angeles, in the parking lot. Gutierrez had been removing the seat from a parked motorcycle which he said belonged to him, although there was no registration or other documentation indicating ownership. Gutierrez was found to possess two baggies of methamphetamine, weighing over 1 gram combined. Gutierrez was arrested for possession of methamphetamine. 13-1926

On July 26<sup>th</sup> at about 12:55 AM Ukiah Police responded to the 1200 block of North Pine Street for subjects who had broken out the windows of an MTA covered bus stop. Responding officers located 5 subjects in Vinewood Park, two of whom matched the reported description of the suspects. A witness was contacted who positively identified 19 year old Logan Andrew Rymel and 29 year old Mason Allan McGee, both of Ukiah, as the suspects that had used rocks to break out the windows. Rymel and McGee were arrested for felony vandalism due to the extent of damage to the bus stop. 13-1927

On July 26th at about 3:10 AM Ukiah Police responded to a residence in the 500 block of Baywood Court for a woman heard screaming for help. Arriving officers heard a woman in distress and yelling "STOP", and immediately entered the residence. The officers announced their presence and yelled for the occupants to show themselves, and they were soon met by 32 year old Jedi Wolfe-Hunnicutt. Officers noticed blood on Hunnicutt, and he appeared disoriented and displayed slight difficulty in following the officers' command. Hunnicutt was placed into handcuffs for safety, and officers then located a 29 year old woman in the residence who immediately requested a protective order.

After interviewing both subjects and examining the scene, officers determined the two had been drinking earlier that evening. During a subsequent argument, Hunnicutt apparently grabbed and held the victim by her throat, eventually restricting her breathing. The victim was able to finally get Hunnicutt to release her, and both sustained visible injuries during the scuffle. As the aggressor Hunnicutt was arrested for domestic violence, and he was on probation for sales of marijuana and was charged with violating that probation. A protective order was obtained prohibiting Hunnicutt from contacting the victim. 13-1928

On July 26<sup>th</sup> at about 6:20 PM Ukiah Police responded to the 200 block of East Gobbi Street for two subjects involved in an altercation, with one waiving a knife. Officers were on the railroad tracks and were approached by the subject reported to have the knife. The subject, 43 year old Francisco Cornejo-Zamora, was non-responsive to the officers, and then pulled away as he was being checked for weapons. Zamora swung towards an officer, and struggled until being taken into custody. Zamora was arrested for resisting arrest. 13-1932

On July 28<sup>th</sup> at about 1:25 AM Ukiah Police responded to the 600 block of South Orchard Avenue for a cellular 911 hang up. Officers located and contacted two subjects, one of whom had a cellular telephone and concluded she had "pocket dialed" 911. The other subject, 22 year old James Scott Morris, displayed symptoms of drug influence, and was eventually arrested for having used methamphetamine recently. Morris was additionally charged with violating probation and parole. 13-1943

On July 29<sup>th</sup> at about 10:30 AM Ukiah Police responded to Wal Mart, at 1155 Airport Park Boulevard, for a shoplifter. The officer learned 34 year old Taylor Loyd Wright, of Branscomb, was observed in the store selecting cosmetics, and removing the packaging. Wright left the store with the concealed cosmetics without paying, and was detained by store employees. Wright was arrested for shoplifting, and for violating probation. 13-1951

On July 30<sup>th</sup> at about 12:30 AM Ukiah Police stopped a vehicle in the 200 block of Low Gap Road. The officer immediately smelled marijuana from within the vehicle, and noticed several live marijuana plants in the back seat area of the vehicle. A further search of the vehicle revealed over ½ pound of processed marijuana, a large amount of US currency, and a metal tire iron underneath a seat. Officers arrested 28 year old Alexander Collaco, of Oakland, and 42 year old Sean Manuel Molina, of Stockton, for transportation of marijuana. Molina was also charged with possessing an illegal weapon. 13-1960
