### Patrol Division Weekly Activity Report 8/1/13 to 8/7/13

### Statistics

**Arrests included: 10 for public intoxication, 7 for domestic violence, 5 warrant arrests, 3 for possessing methamphetamine, 2 for shoplifting, 2 for resisting arrest, 2 for violating probation or parole, and 1 each for: burglary, possessing a dangerous weapon, possession of firearm by a felon, and trespassing . Probation or parole holds were placed on 3 of these arrests.**

**Officers investigated 3 traffic collisions and 2 deaths by apparent natural causes. One vehicle was impounded for 30 days due to the driver being unlicensed or suspended.**

**Officers took reports of: 11 found property, 6 child neglect, 5 vandalisms, 4 domestic violence, 4 animal bites, 2 burglaries, 2 elder abuse, and 1 each of; theft, battery, abandoned vehicle, robbery, forgery, assault with a dangerous weapon, and violating a court order.**

**Officers assisted the Mendocino County Sheriff's Office twice with subjects who fled from a traffic stop, and the California Highway Patrol with a rollover vehicle accident.**

### Highlights for the Week

On August 1st at about 9:55 PM Ukiah Police contacted 36 year old Daniel William Saia, of Redwood Valley, in the 300 block of North Orchard Avenue. Saia had been recently released from custody on his own recognizance from a recent arrest for felony vandalism and drug charges, and was subject to search. Saia was found to possess a methamphetamine smoking pipe, less than a gram of methamphetamine, prescription medication, and he had used methamphetamine recently. Saia was arrested for possessing methamphetamine and drug paraphernalia, possessing a prescription controlled substance, and for drug influence. 13-1993

On August 2nd at about 11:30 PM Ukiah Police contacted a subject who appeared to be prowling around the rear of the Observatory Surgery Center, at 271 Observatory Avenue. The subject provided what was later determined to be a false name, and was found in possession of metal knuckles and was arrested. The subject was identified as 23 year old Jacob James Francisco Corona, who was on probation and had 2 warrants for his arrest. Corona was arrested for prowling, providing false identity, possessing a dangerous weapon, violating probation and the arrest warrants. 13-2002

On August 3<sup>rd</sup> at about 1:40 AM Ukiah Police stopped a vehicle being driven by 26 year old Gerardo Rodriguez-Torres, of Windsor, in the 600 block of South State Street. Rodriguez had been drinking, and was found to be too intoxicated to drive and was arrested for DUI. 13-2003

On August 3rd at about 4:45 PM Ukiah Police stopped a vehicle being driven by 45 year old Juan Miguel Gonzalez Padilla, of Vallejo, in the 300 block of Washington Avenue. The officer noticed a rifle case within the vehicle, and Padilla explained he had a hunting rifle. The officer noticed Padilla shuffling his feet and suspected Padilla was trying to kick something under the driver's seat. Padilla admitted there was a handgun under the seat, and the officer located a 9mm pistol under the driver's seat and a loaded magazine nearby. The officer located an unloaded hunting rifle within the vehicle, and ammunition for the rifle in the rear compartment. Padilla had been previously convicted of a felony, and prohibited from possessing firearms or ammunition. Padilla was arrested for possessing a concealed weapon and possession of firearms and ammunition by a convicted felon. 13-2008

On August 4th at about 1:40 AM Ukiah Police responded to the parking lot of Curry's Furniture, at 245 East Standley Street, for vandalism that had just occurred. Arriving officers learned the suspect was seen writing graffiti on the business's delivery van, and also on various locations within the nearby Perkins Street Grill. The suspect was located in the area, and identified as 39 year old Zachary Anthony Tendick, of Studio City. Officers spoke with witnesses and determined Tendick had vandalized several walls in the men's restroom at the Perkins Street Grill, several tables, a menu, as well as the Curry's Furniture vehicle. Tendick was arrested for felony vandalism, and became belligerent and uncooperative and remained so with County Jail staff. 13-2012

On August 6<sup>th</sup> at about 12:25 AM Ukiah Police responded to the Express Mart, at 390 East Gobbi Street, for a theft of alcohol. The officer was able to view the surveillance video and observed the suspect stealing beer, and noted the suspect's description. At about 2:30 AM Ukiah Police responded to a disturbance with glass breaking in the 500 block of Leslie Street. Arriving officers observed 19 year old Diamante Charles McCain, of Willits, trying to hide underneath a parked vehicle. The officers recognized McCain as the suspect seen on video stealing beer earlier, and the store clerk later confirmed McCain was the suspect. McCain was found to be responsible for the reported disturbance as well. McCain was intoxicated and was arrested for burglary, theft, and public intoxication. 13-2030

On August 6<sup>th</sup> at about 7:10 PM Ukiah Police responded to the 100 block of Low Gap Road for subjects drinking alcohol in a parked vehicle. A Mendocino County Sheriff's Deputy arrived moments before the Ukiah Police Officer, and saw the reported vehicle drive west on Low Gap Road, then turn onto North Oak Street and park on the sidewalk. The driver was contacted as he exited the vehicle, and immediately denied he had been driving. The driver, who was later identified as 29 year old Noe Miguel Angel Luz-Rodriguez, of Fort Bragg, had been drinking, and was found to be too intoxicated to drive. Rodriguez physically resisted being taken into custody and tried to free himself and pull away from the arresting officers. Rodriguez was eventually controlled after a struggle, and was placed into handcuffs. Rodriguez had identification in another name, and after researching both names Rodriguez was found to be unlicensed and on probation in Mendocino County. Rodriguez was charged with DUI, resisting arrest, driving without a license, and violating probation. 13-2038

On August 6<sup>th</sup> at about 7:55 PM Ukiah Police responded to the Sunhouse Park, at 435 South Main Street, for an intoxicated male who was asking minors to drink with him and making rude and obscene statements. The subject was later located in the 500 block of South Main Street, and identified as 51 year old Eric Roy Lincoln, of Covelo. Lincoln was on probation and prohibited from drinking, and was arrested for public intoxication and violating probation. 13-2039

On August 7<sup>th</sup> at about 10:10 PM Ukiah Police responded to the Yokayo School, at 790 South Dora Street, for an alarm. As responding officers were walking towards the campus, a female was seen running from the buildings and into the field area. The officers gave chase and the female was soon joined by a male, and both turned and continued to run from officers ignoring commands to stop. The two subjects were eventually captured near the school, and were identified as a 16 year old male juvenile from Redwood Valley, and a 15 year old female juvenile from Ukiah. It was determined the two juveniles had been smoking marijuana at the location, and were arrested for resisting law enforcement. 13-2060
