### **Statistics**

**Arrests included: 9 for public intoxication, 7 warrant arrests, 2 for possessing methamphetamine 2 for shoplifting, 2 for violating probation or parole, 2 for robbery, and 1 each for: domestic violence, burglary, indecent exposure, theft, possessing stolen property, stolen vehicle, and being under the influence of a controlled substance and/or possessing drug paraphernalia. Probation or parole holds were placed on 2 of these arrests.**

**Officers investigated 1 death by apparent natural causes, and 1 vehicle was impounded for 30 days due to the driver being unlicensed or suspended.**

**Officers took reports of: 9 thefts, 9 vandalisms, 7 found property, 3 child neglect, 3 abandoned vehicles, and 1 each of; burglary, animal bite, domestic violence, forgery, assault with a dangerous weapon, stolen vehicle, stolen vehicle recovery, fraud, sexual battery, negligent firearm discharge, suicidal subject, and violating a court order.**

### **Highlights for the Week**

On August 5<sup>th</sup> at about 11:00 AM Ukiah Police responded to a room at the Super 8 Motel, at 693 South Orchard Avenue, for a reported robbery. The victim reported he had recently come to the area looking for artistic talent, and to open an art gallery. The victim claimed having met two subjects in a bar, identified as 43 year old Cory Eugene English and 31 year old Thomas James Kitchen, and has maintained a social relationship with the two for the past several weeks. English and Kitchen were with the victim inside the victim's room, and suddenly demanded the money the victim had intended to use to open an art gallery. The victim gave the subjects the money, and they proceeded to go through the victim's belongings until the victim fled the room. The victim contacted the police and the suspects fled the location in a vehicle.

On August 9<sup>th</sup> at about 11:30 AM Ukiah Police spotted English in a vehicle, and subsequently stopped him in the 100 block of South Main Street. English was taken into custody and arrested for robbery, and a search of the vehicle revealed a stun gun amongst English's possessions. English is a convicted felon and prohibited from possessing such weapons, and was additionally charged with possession of a stun gun by a felon. The passenger in the vehicle, 24 year old Shayla Dawn Guerrero, of Covelo, had 3 warrants for her arrest for drugs, DUI, and violating probation, and was taken into custody. Guerrero had less than a gram of methamphetamine and a methamphetamine smoking pipe in her possession, and was also charged with possessing a controlled substance and drug paraphernalia.

On August 11<sup>th</sup> at about 10:50 AM Ukiah Police responded to the Ukiah Valley Medical Center, at 275 Hospital Drive, for a domestic violence incident. The victim had significant bleeding injuries to her face, and reported getting into an argument with Thomas Kitchen about her cellular telephone. The victim followed Kitchen from North Main Street to another part of town, and back to the 300 block of North Main Street, trying to obtain her phone from Kitchen. The victim report Kitchen punched her in the face repeatedly until she lost consciousness, and she was transported to the hospital by a friend. An emergency protective order was obtained prohibiting Kitchen from contacting the victim. At about 4:30 PM Mendocino County Sheriff's Deputies located and arrested Kitchen on East Road in Redwood Valley, and transported him to the Ukiah Police Department. Kitchen was interviewed regarding both crimes, and was charged with robbery and domestic violence, and with possessing drug paraphernalia after a methamphetamine smoking pipe was located in his pants pocket. 13-2022/13-2097

On August 8<sup>th</sup> at about 9:55 AM Ukiah Police responded to the 800 block of Maple Avenue regarding indecent exposure, with the suspect still in the area. Arriving officers located the suspect, identified as 20 year old Corey Scott Rupp, and he explained he'd been urinating in public and thought somebody had seen him. Two witnesses reported seeing Rupp walking back and forth in the area, and crossing the street several times, with his penis exposed and actively masturbating. Rupp admitted to the behavior, and was arrested for indecent exposure. 13-2068

On August 12<sup>th</sup> at about 12:20 PM Ukiah Police stopped a vehicle in the 300 block of North Oak Street for running a stop sign. During the stop the officer was advised by dispatch the vehicle was stolen out of Reno, Nevada. The driver, a 15 year old male from Reno was also reported missing, and was taken into custody for driving a stolen vehicle. 13-2110

On August 13<sup>th</sup> at about 10:00 PM Ukiah Police responded to the Home Depot at 350 North Orchard Avenue, for a subject pounding on the windows. Officers contacted 25 year old Thomas Raymond Holland, of North Carolina, who exhibited symptoms of alcohol and drug use, and claimed people had been chasing him. Holland was arrested for public intoxication. 13-2126
