Statistics

Arrests included: 8 warrant arrests, 5 for public intoxication, 4 for burglary, 4 for being under the influence of a controlled substance and/or possessing drug paraphernalia, 2 for possessing marijuana on school grounds, and 1 each for: violating probation or parole, shoplifting, possessing methamphetamine, domestic violence, possessing stolen property, and battery with serious injury. Probation or parole holds were placed on 2 of these arrests.

Officers investigated 2 traffic collisions, 2 hit and run traffic collisions, and 1 death by apparent natural causes. Four vehicles were impounded for 30 days due to the drivers being unlicensed or suspended.

Officers took reports of: 8 found property, 7 thefts, 6 child neglect, 6 burglaries, 2 violation of court order, and 1 each of; vandalism, animal bite, domestic violence, stolen vehicle, city code violation, transportation of marijuana, rape, counterfeit bill, and identity theft.

Officers assisted the Mendocino County Sheriff's Office with service of an arrest warrant, and staff at the Ukiah Valley Medical Center with facility security training.

Highlights for the Week

On August 6th at about 1:00 PM the Ukiah Police Department received a report that four subjects had passed counterfeit checks, which had been written on the account of a fictitious business, and cashed at the business at 390 East Gobbi Street on July 20th. On August 16th at about 2:10 PM Ukiah Police responded to 390 East Gobbi Street as one of the suspects had returned and was attempting to cash more checks. Officers questioned the suspect who identified himself verbally. Officers found the suspect had identification in two different names, both different than the name he had earlier provided, and a credit card in yet another name. The suspect then identified himself as 42 year old Luis Alvarado, of Los Angeles, and officers determined Alvarado had used yet another identity when cashing checks on July 20. The checks Alvarado had in his possession currently were from different businesses, both local and out of the area, and all believed to be counterfeit and with fictitious business names. Alvarado was arrested for burglary, forgery, possessing and using false identifications, providing false identity to law enforcement, and for warrants from Kings and Solano Counties for traffic and fraud charges. 13-2033

On August 16th at about 3:15 PM Ukiah Police responded to the Super 8 Motel, at 693 South Orchard Avenue, for two males and a female involved in a physical altercation. Officers contacted 36 year old James Thomas Boylan, of Pennsylvania, and determined he had been involved with an altercation with another male who believed Boylan was acting inappropriately with the males' girlfriend. Boylan displayed symptoms of having used methamphetamine recently, and a search of his belongings revealed two methamphetamine smoking pipes, less than a gram of methamphetamine, and pepper spray. Boylan is a convicted felon and prohibited from possessing such weapons, and was arrested and also charged with possessing methamphetamine and drug paraphernalia. 13-2154

On August 18th at about 2:15 AM a Ukiah Police Officer was driving in the 500 block of South State Street, and was flagged down by a subject reporting a female had just been punched and knocked out by a male. The officer contacted two males near-by, one of whom was identified as 27 year old Samuel Christopher Anderson, of Ukiah, and a male and female victim. The female victim was unconscious and an ambulance was requested.

The officer learned the male and female victims were walking on the sidewalk and were passed by a group of male subjects including Anderson, one of whom made a derogatory statement towards the victims. The female victim and Anderson became involved in a verbal argument, and the male victim attempted to intervene. Anderson punched the male victim on the side of the head, and then punched the female in the face causing her to fall and lose consciousness.

The female was transported to the Ukiah Valley Medical Center and subsequently received sutures for lacerations to her face and head, and was found to have suffered a concussion. Anderson was arrested and booked into the County Jail for battery with serious injury. 13-2167

On August 18th at about 8:35 AM Ukiah Police received a report of a female acting suspiciously in the 900 block of South State Street, and had just left in a vehicle. Mendocino County Sheriff's Deputies located the vehicle in the 600 block of South State Street, and the driver was identified as 52 year old Tammy Leona Hiatt-Hayward, of Cloverdale. Hiatt was driving with a suspended driver's license, and she was found to have used methamphetamine recently and was arrested. 13-2169

On August 18th at about 9:45 PM Ukiah Police responded to Safeway, at 653 South State Street, for a bicycle theft. Officers learned the victim had parked his bicycle inside the store, and upon finishing shopping 15 minutes later discovered the bicycle was stolen. The security video was viewed and depicted a male subject on a bicycle in front of the store, loitering and looking into the store at the parked bicycle. Another male subject then arrives and takes the suspect's bicycle, and the suspect enters the store and leaves with the parked bicycle. The officer noted the suspect's description and through further investigation determined the stolen bicycle and suspect may be located at a residence in the 800 block of Waugh Lane. At about 11:00 PM Ukiah Police Officers performed a probation search at the residence, and observed several subjects running through the backyard. Officers located 34 year old Michael Lenhart Anderson hiding in the backyard, and arrested him for 2 warrants for violating probation. Officers also located the stolen bicycle and the suspect, identified as 26 year old Scott Leon Franks, and arrested him for burglary and conspiracy. The bicycle was returned to its owner. 13-2174
