Statistics

Arrests included: 11 warrant arrests, 6 for public intoxication, 4 for shoplifting, 3 for violating probation, 2 for being under the influence of a controlled substance and/or possessing drug paraphernalia, 2 for domestic violence, and 1 each for: burglary, theft, stolen vehicle, possessing methamphetamine, prowling, and possessing a weapon. Probation or parole holds were placed on 2 of these arrests.

Officers investigated 1 DUI traffic collision. Two vehicles were impounded for 30 days due to the drivers being unlicensed or suspended.

Officers took reports of: 5 child neglect, 5 fraud, 5 thefts, 3 found property, 3 elder abuse, 3 burglaries, 2 animal bite, 2 vandalisms, 2 identity theft, 2 domestic violence, and 1 each of; battery, sexual battery, kidnapping, threats, and rape.

Highlights for the Week

On September 27th at about 9:40 PM Ukiah Police responded to the 200 block of Observatory Avenue for a traffic collision. Arriving officers found a blue Nissan Maxima had been traveling east and collided with the rear of a parked white Chevrolet Malibu, causing damage to both vehicles. The driver of the Maxima, 33 year old Victor Hugo Mora, admitted to driving the vehicle, and had been drinking. Mora was found too intoxicated to drive and was arrested for DUI. 13-2579

On September 29th at about 4:15 PM Ukiah Police contacted 23 year old James Alan Scott Morris, of Willits, inside Taco Bell, at 1201 North State Street, pursuant to Morris' probation. Morris was with 26 Danyel Michelle Robinson, also of Willits. Morris had used methamphetamine recently, and was subsequently arrested for drug influence and for violating probation and parole. Robinson had discarded a methamphetamine smoking pipe before talking with officers, and was arrested for possessing drug paraphernalia. 13-2593

On September 30th at about 2:45 PM Ukiah Police responded to the area of Church and State Street for a vehicle theft that had just occurred. Officers were informed a utility truck had been left parked nearby and the keys left in the vehicle. While the employee-driver of the vehicle was performing utility work in the area, he saw the truck being driven away and chased after it. The vehicle stopped and the employee opened the door and demanded the suspect exit the vehicle, which he did and ran towards Alex Thomas Plaza. Officers located the suspect, 45 year old Robert Peter Thomas, of San Francisco, who denied stealing the vehicle but was positively identified by the victim. Thomas had been drinking, and was determined to be too intoxicated to drive. Officers had dealt with Thomas earlier that day, and the day prior, and noticed he was wearing different and brand new appearing, clothing. Officers determined Thomas had stolen the clothing from Rainbow Ag, at 235 East Perkins Street, shortly before stealing the truck. Thomas was arrested for auto theft, possessing stolen property, DUI, and violating probation. 13-2605

On October 1st at about 1:00 PM Ukiah Police Detectives were on Talmage Road near Cunningham Street, and saw 33 year old David Michael Johnson near the railroad tracks. Johnson was a parolee at large and wanted for violating his registration requirements as a sex offender. Johnson ran into the creek bed, and one officer ran after him while the other entered

the creek in front of Johnson. Upon seeing the other officer Johnson tried to run the other way, but eventually surrendered. Johnson had a methamphetamine smoking pipe and hypodermic syringes in his possession, and was charged with resisting arrest and possessing drug paraphernalia and for violating parole. 13-2609

On October 2nd at about 3:45 AM a Ukiah Police Officer was in the 1300 block of Airport Road, and saw a subject inside an equipment yard enclosed by fencing. The subject was running, and the officer lost sight of the subject and entered the yard to search for him. The officer located the subject hiding near some equipment, and found he possessed a flashlight and gloves. The subject was identified as 32 year old Justin Charles Delmor Blake, and he was arrested for prowling. 13-2615
