### Statistics

**Arrests included: 10 for shoplifting, 5 warrant arrests, 5 for public intoxication, 3 for burglary, 3 for being under the influence of a controlled substance and/or possessing drug paraphernalia, 2 for battery, 2 for violating probation, and 1 each for: domestic violence, theft, possessing a narcotic, possession of a stun gun by a felon, possession of pepper spray by a felon, possessing metal knuckles, battery at school, and vandalism. Probation or parole holds were placed on 4 of these arrests.**

**Officers investigated 2 traffic collisions and 1 hit and run traffic collision. Three vehicles were impounded for 30 days due to the drivers being unlicensed or suspended.**

**Officers took reports of: 14 found property, 4 vandalisms, 3 thefts, 3 burglaries, 3 domestic violence, 2 child neglect, 2 animal bite, 2 identity theft, and 1 each of; battery, counterfeit bill, stolen vehicle, suicidal subject, and missing person.**

### Highlights for the Week

On October 3<sup>rd</sup> at about 7:40 PM Ukiah Police responded to Wal Mart, at 1155 Airport Park Boulevard, for a shoplifter. Wal Mart employees had observed a female and male subject in the store, collecting items and loading them into two shopping carts. The subjects proceeded to the cashier area, and the female entered a check-out line with a few items, while the male subject pushed both full shopping carts out of the store without paying. The male was detained and identified as 30 year old Wesley Thomas Zynda, of Ukiah, and was arrested for theft and criminal conspiracy. The shopping carts were found to contain over \$500.00 worth of stolen items. The female was later identified as 30 year old Elizabeth Mae McAllister, of Willits, and she was also arrested for theft and criminal conspiracy. 13-2638

On October 4<sup>th</sup> at about 3:45 PM Ukiah Police stopped a vehicle being driven by 26 year old Scot Daellenbach, of Willits, in the 400 block of South Dora Street. Daellenbach was on probation and was found to be driving without a drivers license. A stun gun was located inside the vehicle, and Daellenbach was determined to have been previously convicted of a felony. Daellenbach was arrested being a felon in possession of a stun gun, driving unlicensed and violating probation. 13-2650

On October 4<sup>th</sup> at about 4:20 PM Ukiah Police responded to Wal Mart, at 1155 Airport Park Boulevard, for a shoplifter. Officers learned 24 year old Corisa Jean Gralak-Allen, of Willits, had been observed exiting the store with over \$100.00 of stolen merchandise. Gralak-Allen was arrested for shoplifting. 13-2649

On October 4<sup>th</sup> at about 4:20 PM Ukiah Police responded to Wal Mart, at 1155 Airport Park Boulevard, for a theft. Responding officers were advised the suspect had fled the store and was leaving in a vehicle. An officer located the vehicle near-by and contacted the suspect, 31 year old Christopher Patrick Geurts, of Willits. Geurts had been observed selecting clothing inside the store, and then tried to exchange the clothing for over \$13.00 in refunds. Geurts fled the store when confronted. Officers arrested Geurts for shoplifting. 13-2651

On October 5<sup>th</sup> at about 2:00 AM Ukiah Police stopped a vehicle being driven by 53 year old Maurice Joe Roper, of Windsor, in the 100 block of North Orchard Avenue. Roper had been drinking and had difficulty standing, and was found too intoxicated to drive. Roper was on

probation and prohibited from driving after drinking, and was arrested for DUI and violating probation. 13-2664

On October 5<sup>th</sup> at about 10:40 AM Ukiah Police respond to Kohl's, at 437 North Orchard Avenue, for a shoplifter. Officers learned 18 year old Joseph Louis Rocanella, of Chico, had been observed entering the store and selecting a wallet valued at over \$25.00. Rocanella removed the wallet from its packaging and placed the wallet inside his pocket, and exited the store without paying. Rocanella was arrested for burglary. 13-2665

On October 5<sup>th</sup> at about 6:40 PM Ukiah Police received a call regarding a large fight in the area of Perry and Rupe Streets, and that at least one person was seriously injured and numerous suspects had fled after being possibly involved in some sort of theft. The caller was following the suspect vehicle, which was eventually located traveling in the 100 block of Washington Street. A high risk stop was performed on the vehicle, and officers began detaining numerous occupants of the vehicle one at a time. Suddenly one of the occupants exited the vehicle and began running, ignoring commands to stop. A short foot pursuit ensued, and with the assistance of a police K9, the suspect was captured and taken into custody. The 16 year old male juvenile suspect was found to be on probation and to possess metal knuckles, and was arrested for resisting arrest, possessing an illegal weapon, and violating probation. 13-2669

On October 5<sup>th</sup> at about 11:00 PM Ukiah Police stopped a vehicle being driven by 52 year old Robert David McCoey, in the 1200 block of Helen Avenue. There were three passengers in the vehicle, one of which was 23 year old Kala Dawn Smith, of Clearlake. Smith displayed symptoms of having used methamphetamine recently, and was found to be under the influence of a controlled substance and was arrested. McCoey was found in possession of pepper spray and as a convicted felon, is prohibited from having the weapon. McCoey was arrested for illegally possessing pepper spray. 13-2671

On October 6<sup>th</sup> at about 2:25 AM Ukiah Police stopped a vehicle being driven by 21 year old Brandon Lee Lucas, of Laytonville, in the 300 block East Perkins Street. Lucas had been drinking, and was found too intoxicated to drive and was arrested for DUI. 13-2449

On October 6<sup>th</sup> at about 9:30 PM Ukiah Police responded to a business in the 100 block of West Standley Street for a reported burglary. Officers found a large object had been thrown through the front window of the business and later determined nearly \$3000.00 in clothing had been stolen. Officers learned the suspect was seen walking across State Street at Standley Street by two off-duty tribal police officers, who noticed the suspect was carrying a very large amount of clothing still with the hangers. Believing the suspect may have stolen the clothing, the officers pursued the suspect, who dropped the clothing and ran. The officers caught up to and detained the suspect near the 200 block of North Main Street. It is believed the suspect, identified as 18 year old Guadalupe Garcia, of Ukiah, was carrying the clothing to a waiting vehicle which had since left. Garcia was arrested for burglary, grand theft, vandalism, and criminal conspiracy. 13-2680

On October 9<sup>th</sup> at about 11:15 AM Ukiah Police responded to the 100 block of North Main Street for a reported battery. The victim reported he was walking towards the library and noticed 32 year old Paul Bittner, pacing back and forth talking angrily on his cell phone. As the victim passed Bittner, whom he did not know, Bittner punched the victim in the face, then continued pacing and talking angrily into his cell phone. Bittner provided no explanation to the victim or the officers, and was placed under citizen's arrest for battery. 13-2707
