Statistics

Arrests included: 11 for shoplifting, 8 warrant arrests, 5 for public intoxication, 3 for being under the influence of a controlled substance and/or possessing drug paraphernalia, 3 for possessing methamphetamine, 2 for possessing a narcotic, 2 for burglary, 2 for violating probation, 2 for resisting arrest, and 1 each for: domestic violence, and theft. Probation or parole holds were placed on 3 of these arrests.

Officers investigated 2 traffic collisions, 1 hit and run traffic collision, and 2 deaths from apparent natural causes. Two vehicles were impounded for 30 days due to the drivers being unlicensed or suspended.

Officers took reports of: 8 found property, 6 child neglect, 5 burglaries, 3 abandoned vehicles, 3 thefts, 2 domestic violence, 2 stolen vehicles, and 1 each of; animal bite, identity theft, suicidal subject, rape, assault with a dangerous weapon, and elder abuse.

Highlights for the Week

On October 11th at about 7:30 PM Ukiah Police responded to Wal Mart, at 1155 Airport Park Boulevard, for two shoplifters. Store employees had observed 19 year olds Mickey Ryan Johnson and Chauncy Allen Everett, both of Illinois, replaced their worn shoes for new shoes. Both subjects left their old shoes behind and exited the store wearing the new shoes, without paying. The two pairs of shoes were valued at over \$25.00. It was determined Johnson and Everett entered the store intending to steal the shoes, and both were arrested for burglary. 13-2726

On October 11th at about 10:45 PM a Ukiah Police Officer observed a male subject urinating in the 200 block of East Perkins Street. The subject saw the officer, and ran into some nearby bushes. The officer contacted 23 year old Anthony Scott Pinola, of Ukiah, who had been drinking and was very intoxicated. Pinola raised his fists and took a fighting stance, and challenged the officer to fight. The officer took ahold of Pinola who pulled away and resisted being taken into custody, and was eventually arrested for public intoxication and resisting arrest. 13-2729

On October 12th at about 9:30 AM Ukiah Police took a report of a bike theft from the 200 block of Seminary Avenue. Officers were told witnesses had seen 26 year old Justin Malugani riding the bicycle. At about 3:10 PM Ukiah Police responded to the Vinewood Park, at 1260 Elm Street, and located Malugani and the stolen bicycle. The bicycle's serial numbers had been scraped off, and Malugani was arrested for possessing stolen property and the removal of identifying numbers. 13-2734

On October 12th at about 10:30 AM Ukiah Police contacted 26 year old Jessica Ann Chambers, of Florida, in the 300 block of North Orchard Avenue for panhandling. Chambers had a warrant for her arrest for trespassing on railroad property, and was taken into custody. 13-2735

On October 13th at about 1:30 AM Ukiah Police stopped a vehicle being driven by 24 year old Daron Oak Carter, of Willits, on East Perkins Street near US 101. Carter was found to possess several Oxycontin tablets, and was arrested. A further search of Carter revealed several

tablets of Valium, and a substance believed to be Fentanyl. Carter was arrested for possessing narcotics. 13-2743

On October 13th at about 7:05 PM Ukiah Police responded to Safeway, at 653 South State Street, for a shoplifter. Store employees had observed 40 year old Joseph Paul Lareau select over \$17.00 of merchandise and exit the store without paying. Lareau was found to be on parole in Humboldt County, and was arrested for shoplifting. 13-2751

On October 14th at about 7:00 PM Ukiah Police responded to the Wal Mart parking lot, at 1155 Airport Park Boulevard, for subjects drinking alcohol. The arriving officer located a group seated on the ground, and recognized 23 year old Travis Humphrey seated in the middle of the group. Humphrey raised an open alcohol container towards the officer in a "cheers" type of fashion. Humphrey had previously been on probation and prohibited from being on Wal Mart property as a term of that probation, but that probation had been terminated. Humphrey told the officer he knew he could not be arrested for being on the Wal Mart property, and began calling the officer derogatory names. Humphrey had been drinking and was too intoxicated to care for himself, and the officer began to take him into custody. Humphrey pulled away and physically resisted, and was taken into custody after a brief struggle. Humphrey was arrested for public intoxication and resisting arrest. 13-2760
