Statistics

Arrests included: 6 warrant arrests, 6 for public intoxication, 3 for shoplifting, 3 for domestic violence, 3 for being under the influence of a controlled substance and/or possessing drug paraphernalia, 2 for burglary, and 1 each for: resisting arrest, possessing methamphetamine, battery, sexual assault, assault with a dangerous weapon, robbery, failure to register as a sex offender, possessing methamphetamine for sale while armed with a stolen firearm, and prowling. Probation or parole holds were placed on 2 of these arrests.

Officers investigated 2 hit and run traffic collisions, and 1 death from apparent natural causes. Four vehicles were impounded for 30 days due to the drivers being unlicensed or suspended.

Officers took reports of: 15 child neglect, 12 found property, 11 thefts, 3 animal bites, 3 burglaries, 2 vandalisms, and 1 each of; recovered stolen vehicle, domestic violence, suicidal subject, and assault with a dangerous weapon.

Highlights for the Week

On October 16th at about 12:55 PM Ukiah Police stopped a vehicle being driven by 63 year old Rudy Berain, of Santa Rosa, in the 500 block of North State Street. Berain was on probation in Sonoma County for drug possession, and was driving with a suspended driver's license. A search of the vehicle revealed over a gram of methamphetamine, which was determined to belong to Berain's passenger, 48 year old Julie Ann Calkins, of Upper Lake. Berain was arrested for driving with a suspended driver's license and violating probation and Calkins for possessing methamphetamine. 13-2779

On October 16th at about 4:30 PM Ukiah Police responded to Kohl's, at 437 North Orchard Avenue, for a shoplifter. Store employees had determined 26 year old Bridgette Marie Maple, of Chico, had concealed over \$100.00 of clothing and left the store without paying for the items. Maple was arrested for shoplifting. 13-2784

On October 17th at about 5:20 PM Ukiah Police responded to Kohl's, at 437 North Orchard Avenue for a shoplifter. Store employees had observed 19 year old Dennis John Ultsch, of Upper Lake, conceal a wallet worth \$10.00 in his pocket, and leave the store without paying. Ultsch was arrested for shoplifting. 13-2796

On October 17th at about 7:45 PM Ukiah Police responded to McGarvey Park, at 300 South Dora Street, for a reported sexual assault. Officers were told the 14 year old female victim had been "hanging out" with a group at Alex Thomas Plaza, which included 19 year old Guadalupe Garcia, of Ukiah. The victim left the Plaza, and Garcia offered to walk with the victim and they reached the area of McGarvey Park. Garcia started kissing the victim, and began forcing his hands under her clothing while holding and hugging her, preventing her from escaping. Garcia had his arms around the victim and exposed his penis, and tried to physically force the victim to touch it. The victim was able to get away from Garcia, and the police were notified soon after. Garcia was spotted returning to the area, and was then seen by witnesses running away and entering a vehicle. Officers soon located the vehicle near School and Mill Streets and subsequently took Garcia into custody. Garcia was charged with assault with intent to commit rape, sexual battery with restraint, and sexual assault. 13-2797

On October 19th at about 11:35 PM Ukiah Police responded to the 200 block of North School Street for a subject threatening others with a knife. Arriving Officers located 18 year old Joseph Louis Rocanella still holding the knife. Rocanella was detained at gunpoint, and was safely taken into custody. Officers learned Rocanella was seen going through the barrier fence around the giant slide that had been erected for the Pumpkinfest. Rocanella was seen at the top of the slide and was yelled at by the ride's employees to get down. Rocanella rode his skateboard down the slide, then removed a large knife from his side and advanced towards one of the employees. Rocanella moved the knife in stabbing motions while saying he was going to stab the victim. Rocanella was arrested for threats and with assault with a dangerous weapon.

On October 20th at about 2:05 AM a Ukiah Police Officer observed 2 males, both not wearing shirts, fighting each other in the roadway in the 200 block of East Standley Street. As the officer approached, one of the subjects began to walk away and ignored the officer's commands to stop. The officer could see the subject had a large gang related tattoo prominently displayed, and he continued to ignore the officer's commands. The subject then clenched his fists and advanced towards the officer aggressively, and was taken to the ground by a second officer and arrested. The subject was identified as 25 year old Cristian Miguel Mendez, of Ukiah, who was on parole. Mendez was charged with public intoxication, resisting arrest, and violating parole. 13-2819

On October 20th at about 5:45 AM Ukiah Police responded to the 400 block of East Gobbi Street for a prowler. Officers located 27 year old Vannessa Marie Quintana, of Napa, seated on steps and very drunk. Quintana had apparently become lost, and was arrested for public intoxication. 13-2820

On October 20th at about 10:30 AM Ukiah Police responded to the 400 block of North State Street for a male and female fighting. Officers contacted the victim who reported 45 year old Juan Zepeda had been arguing with the victim, and was seen holding her arm and preventing her from leaving. Zepeda grabbed the victim's purse, and forcefully removed it from her, and ran away with the purse. At about 11:30 AM Zepeda was spotted in the passenger seat of a vehicle in the 1000 block of South State Street. Officers stopped the vehicle, and Zepeda

told the officer he was not Zepeda, and that his name was Antonio. Zepeda was arrested for domestic violence, robbery, and for providing false identity to law enforcement. 13-2822

On October 20th at about 12:55 PM Ukiah Police responded to the Tractor Supply Company, at 1248 Airport Park Boulevard, for a shoplifting. Store employees had observed 23 year old Travis Joseph Humphrey in the shoe department, and saw Humphrey put on a new pair of boots worth over \$180.00. Humphrey urinated on the floor, and then left the store without paying. Humphrey was located in the 700 block of Talmage Road, and arrested for shoplifting. 13-2728

On October 22nd at about 2:20 PM Ukiah Police stopped a vehicle in the 200 block of Garrett Avenue. A passenger in the vehicle, 35 year old Jose Alfredo Martinez, had two warrants for his arrest from Sacramento County for violating probation, and was arrested. 13-2850

On October 22nd at about 7:45 PM Ukiah Police responded to Safeway, at 653 South State Street, for an intoxicated subject. Officers contacted 36 year old Joaquin Santiago DeLaCruz, of Madera, seated outside and arrested him for public intoxication. DeLaCruz had several warrants for his arrest from Madera County. 13-2852

On October 22nd at about 9:40 PM Ukiah Police stopped a vehicle being driven by 27 year old Robert John Norman Stinnett, of Hayfork, in the 100 block of Washington Avenue. Stinnett had been drinking and was on probation and prohibited from driving after drinking. Stinnett's driver's license was suspended, and he was required to drive vehicles equipped with an ignition interlock device. Stinnett was found to be too intoxicated to drive, and was arrested for DUI, violating probation, and driving with a suspended drivers license. 13-2853

On October 22nd at about 11:50 PM Ukiah Police responded to South Street and Observatory Avenue for a fight. Responding officers found the fight had dispersed, and began checking the area for participants. A Mendocino County Sheriff's Deputy found 19 year old Roy Medina Sanchez in a near-by yard crouched near the house, and he was subsequently arrested. Sanchez had been drinking in violation of his probation and was charged with prowling and violating probation. Ukiah Police Officers located 18 year old Miguel Marin near-

by, who had minor injuries consistent with being in a fight, and was very drunk. Marin was arrested for public intoxication. It appears one of the subjects may have contacted the other, requesting help as they were being “jumped”, and the incident is believed to be gang related. 13-2855
