### **Patrol Division Weekly Activity Report 10/24/13 to 10/30/13**

### **Statistics**

**Arrests included: 5 for public intoxication, 3 for domestic violence, 3 warrant arrests, 2 for shoplifting, 2 for being under the influence of a controlled substance and/or possessing drug paraphernalia, 2 for vandalism, 2 for violating probation or parole, 2 for battery, and 1 each for: resisting arrest, possessing a narcotic, possessing marijuana for sale, sales of concentrated cannabis, and possessing stolen property. Probation or parole holds were placed on 2 of these arrests.**

**Officers investigated 1 injury traffic collision, and 4 traffic collisions. Two vehicles were impounded for 30 days due to the drivers being unlicensed or suspended.**

**Officers took reports of: 26 child neglect, 5 found property, 4 vandalisms, 2 thefts, 2 stolen vehicles, 2 abandoned vehicles, and 1 each of; burglary, suicidal subject, identity theft, brandishing a weapon, missing person, and threats.**

**Ukiah Police Officers assisted the Mendocino County Sheriff's Office with a reported fight involving a firearm, the Ukiah Fire Department with locating a person in medical distress, and were assisted by the Alcoholic Beverage Control with a prostitution investigation.**

### **Highlights for the Week**

On October 17<sup>th</sup> at about 12:35 AM Ukiah Police responded to a residence in the 200 block of Ford Street for a disturbance. Arriving officers heard multiple subjects running into the backyard at the location. Inside a shed in the backyard officers contacted 24 year old Lydell Allen Williams and 24 year old Nikole Margaret Wolf. Both subjects provided the officers with false identities, and after properly identifying them Williams was found to have a warrant for his arrest for violating Post Release Community Supervision. Wolf was on search probation, and was in possession of several hypodermic syringes. Wolf had used methamphetamine and heroin recently, and was arrested for being under the influence of a controlled substance and for violating probation. Three more subjects were located hiding in the backyard, and 29 year old Jesse Lee Lucas was also on probation and possessed a methamphetamine smoking pipe. Lucas was arrested for possessing drug paraphernalia and for violating probation. 30 year old Justin King had a warrant for his arrest from Missouri, and was also arrested. 13-2789

On October 19<sup>th</sup> at about 3:20 PM Ukiah Police responded to vandalism to a vehicle, which occurred earlier that morning in the 700 block of South Dora Street. The victim identified the suspect as 24 year old Jimmy Edward Vaca, and explained Vaca was jealous of the victim's relationship with his "ex". At about 1:30 AM Vaca confronted the victim who was seated in his vehicle and challenged the victim to fight. Vaca punched the victim's vehicle three times, causing over \$3000.00 in damage. On October 24<sup>th</sup> at about 4:10 PM Ukiah Police responded to a disturbance in the 700 block of El Rio Street involving Vaca, and subsequently arrested him for felony vandalism. 13-2815

On October 24<sup>th</sup> at about 9:20 PM Ukiah Police stopped a vehicle being driven by 33 year old Delgado Benito Cruz, of Jacksonville, Florida, in the 400 block of East Gobbi Street. Cruz had been drinking and he as determined to be too intoxicated to drive and was arrested for DUI. 13-2877

On October 25<sup>th</sup> at about 8:15 AM Ukiah Police responded to the Ukiah Valley Medical Center for a 15 year old student that consumed marijuana. Officers determined a 16 year old male juvenile had provided four 15 year old male juveniles with “marijuana cookies” on the bus on the way to school. Baked goods containing marijuana contain concentrated cannabis and can be very potent. The juvenile at the hospital was subsequently released to his parents with a citation for public intoxication due to his level of impairment from consuming the marijuana. The 16 year old male juvenile was later contacted at Ukiah High School, and cited for possessing marijuana on school grounds, furnishing marijuana, and contributing to minors. 13-2881

On October 26<sup>th</sup> at about 12:35 AM Ukiah Police stopped a vehicle being driven by 36 year old Manuel Perez Escalera, of Klamath, in the 600 block of Talmage Road. Escalera was very intoxicated, and was arrested for DUI and for driving with a suspended driver’s license. A passenger in the vehicle, 33 year old Javier Perez Escalera, of Ukiah, was also very intoxicated and was arrested for public intoxication. 13-2890

On October 26<sup>th</sup> at about 1:40 AM Ukiah Police responded to the Perkins Street Lounge for a disturbance. Officers observed 23 year old Gabriel Manuel Hernandez in the parking lot, and saw him fall while trying to enter a vehicle. Hernandez is a known gang member, and was arrested for public intoxication. Officers determined Hernandez had been associating with 25 year old Ryan Adam Raya, also a known gang member and on probation and prohibited from associating with other gang members. Raya was arrested for violating probation. 13-2891

On October 26<sup>th</sup> at about 2:15 AM Ukiah Police contacted 35 year old Ira Lance Ward, of Michigan, at the gas pumps at the Quest Mart on State Street at Brush Street. Ward was smoking a cigarette and going through the vehicle, and was asked to extinguish the cigarette due to the proximity to the gas pumps. Ward was very intoxicated and it was determined he had been driving the vehicle and was arrested for DUI. 13-2892

On October 26<sup>th</sup> at about 2:55 AM a Ukiah Police Officer found 41 year old Richard Gerald Super, of Yreka, passed out in the front lawn of a residence in the 100 block of North Orchard Avenue. Super was on probation in Siskiyou County for attempted robbery, and

prohibited from drinking. Super was intoxicated and was arrested for violating probation. 13-2893

On October 26<sup>th</sup> at about 4:35 PM Ukiah Police responded to the 100 block of East Gobbi Street for an assault. Officers learned the victim was walking along the sidewalk and was confronted by 25 year old Xavier Jason Hearn, of Florida, who asked the victim if he'd seen his "card". Hearn punched the victim in the face, then picked up a credit card from the ground and walked away. Hearn was located near the Super 8 Motel and was placed under citizen's arrest for battery. 13-2897

On October 28<sup>th</sup> at about 5:50 PM Ukiah Police responded to Safeway, at 653 South State Street, for a combative shoplifter. Arriving officers saw 42 year old Rachael Tera Hellmold, last of Santa Rosa, in a verbal confrontation with the security guard in front of the store. Hellmold had been observed trying to leave the store with over \$160.00 of merchandise, and became combative and struck the security guard several times after being detained. Hellmold was arrested for shoplifting and for battery. 13-2914

On October 29<sup>th</sup> at about 11:40 PM Ukiah Police responded to a residence in the 700 block of Waugh Lane for an unwanted subject. Officers learned the callers had been allowing 25 year old Grant Arthur Crossley, of Arizona, to stay at the residence, but changed their mind after finding a hypodermic syringe in their residence. Officers contacted Crossley and found him to be under the influence of a controlled substance and arrested him. Crossley had heroin, a Oxycodone tablet, a syringe, and other paraphernalia used to inject drugs. Crossley was charged with possessing a narcotic, possessing prescription medication, possessing drug paraphernalia, and being under the influence of drugs. 13-2938
