Patrol Division Weekly Activity Report 11/14/13 to 11/20/13

Statistics

Arrests included: 6 warrant arrests, 4 for domestic violence, 2 for shoplifting, 2 for violating probation or parole, 2 for possessing marijuana, and 1 each for: battery at school, public intoxication, being under the influence of a controlled substance and/or possessing drug paraphernalia, possessing methamphetamine, assault with a dangerous weapon, threats, possessing a weapon on school grounds, embezzlement, vandalism, and felony evading. Probation or parole holds were placed on 5 of these arrests.

Officers investigated 5 traffic collisions and 2 injury traffic collisions. One vehicle was stored for 30 days due to the driver being unlicensed or suspended.

Officers took reports of: 12 child neglect, 7 thefts, 6 burglaries, 6 vandalisms, 5 found property, 3 domestic violence, 2 battery, 2 elder abuse, 2 missing persons, and 1 each of; abandoned vehicle, stolen vehicle, shoplifting, animal bite, fraud, forgery, and suicidal subject.

Ukiah Police Officers were assisted by the Mendocino County Sheriff's Office and the California Highway Patrol with a traffic accident and a vehicle pursuit.

Highlights for the Week

At about 0220 hours on 11-16-2013, the Ukiah Police was dispatched to the area of Village Circle regarding an unknown disturbance. As officers arrived at the scene, Dispatch updated the officers that an involved party was reportedly armed with an ax. While the UPD officer was checking the area inside the complex, he observed the subject (Jesse Rodgers) still holding the ax, which was about 4 feet long, and Rodgers began running from the Officer. The Officer chased Rodgers through the complex and Rodgers ditched the ax over the north fence and continued running. The Officer chased Rodgers to the field just west of the Village Circle entrance and ordered him to stop at gunpoint. Other units arrived and Rodgers was taken into custody without incident. Rodgers was intoxicated. After Rodgers was taken into custody, UPD located two victims in the complex and found this was a domestic violence incident involving Rodger's girlfriend. Rodgers found the victim with another person and a confrontation ensued. Rodgers retrieved the ax and attempted to hit the victim with the sharp end and then hit the victim with the blunt end. Rodgers pounced on the Victim and began trying to eye-gouge the Victim. A friend tried to break this up and Rodgers punched her a few times in the face. UPD officers arrived as this finished. The victim's left eye was swollen shut and there was some additional swolleness and bruising above her eye. The victim was transported to UVMC. Rodgers was booked at CJ for 245(a)(1) PC, 243(d) PC, 243(e)(1) PC, and 148(a)(1) PC. 13-3127

On November 16th at about 7:15 PM Ukiah Police responded to Wal Mart, at 1155 Airport Park Boulevard, for a shoplifter that was fleeing from store employees. Officers located the suspect, identified as 22 year old Stephanie Ellen Millberger, of Stockton, in the parking lot. Millberger claimed "a friend" had put stolen gloves into her purse, and that she did not steal anything. Store employees reported observing Millberger place the gloves into her purse and leave the store without paying. Millberger was found to possess additional stolen items inside her purse, and later to possess less than one gram of methamphetamine. Millberger was booked into the County Jail for shoplifting and for possession of methamphetamine. 13-3132

On November 20th at about 8:10 PM Ukiah Police responded to the Perkins Street Lounge, at 228 East Perkins Street, for a vandalism. Officers learned witnesses had seen a rock being thrown through the front window of the business, and identified the suspect as 19 year old

Armando Llamas, of Ukiah. Llama admitted he threw the rock through the window because he was “mad at the world”. Llama was arrested for vandalism. 13-3192

On November 21st in the early morning hours a Ukiah Police Officer was handling a disturbance call at a hotel, and noticed a suspicious vehicle in the parking lot. The vehicle appeared to be running and was backed in, and there were two occupants in the vehicle. The officer noticed the vehicle again at about 12:15 AM near Washington and South Dora Street, and saw the vehicle fail to stop completely at the intersection, and that the vehicle was weaving. The officer attempted to stop the vehicle near the Observatory Avenue intersection, and the vehicle sped away northbound on South Dora Street, refusing to yield to the officer’s lights and siren. The officer pursued the vehicle as it reached speeds of over 60 miles per hour and failed to stop for stop signs. The vehicle turned right onto Grove Avenue then left and headed north on Oak Street to Low Gap Road. The vehicle pursuit continued east to State Street, and proceeded north with the vehicle reaching speeds of 80 miles per hour.

As the pursuit reached the Orr Springs Road intersection the vehicle attempted to turn left onto Orr Springs Road and lost control, and spun around one and half times coming to rest in the roadway facing south and approaching pursuing patrol vehicles. Pursuing officers saw the driver was a woman, who regained control of the vehicle and proceeded west on Orr Springs Road at a high rate of speed.

Mendocino County Sheriff’s Deputies had joined the pursuit, which continued on Orr Springs Road for close to 30 minutes. Officers from the California Highway Patrol also became involved with the pursuit, which had traversed onto Low Gap Road and was headed east and back towards Ukiah. After over 50 total minutes the suspect vehicle became disabled and stopped on Low Gap Road, several miles from Ukiah. The driver, 29 year old Bobbi Lee Maki, was taken into custody without incident.

Maki was seen throughout the pursuit reaching into different areas of the vehicle’s passenger area, and repeatedly throwing suspected drugs out the window. Officers found approximately 1 pound of marijuana inside the vehicle, several grams of methamphetamine, a methamphetamine smoking pipe, and powdered methamphetamine all over the driver’s door panel and window sill where Maki had been discarding the drug through the window. Maki had been drinking and was

driving with a suspended driver's license, and had a warrant for her arrest for violating Post Community Release Supervision.

Maki was booked into the County Jail for transportation of methamphetamine and marijuana, possessing drug paraphernalia, DUI, vehicular evasion, driving with a suspended driver's license, violating probation, and the warrant. 13-3195
