Patrol Division Weekly Activity Report 11/28/13 to 12/4/13

Statistics

Arrests included: 9 for public intoxication, 8 warrant arrests, 6 for shoplifting, 3 for domestic violence, 2 for violating probation or parole, 2 for possessing methamphetamine, and 1 each for: possessing a knife at school, being under the influence of a controlled substance and/or possessing drug paraphernalia, battery, resisting arrest, burglary, and possessing an illegal weapon. Probation or parole holds were placed on 5 of these arrests.

Officers investigated 1 traffic collision. One vehicle was stored for 30 days due to the driver being unlicensed or suspended.

Officers took reports of: 7 found property, 6 child neglect, 4 thefts, 3 burglaries, 3 vandalisms, 3 stolen vehicles, and 1 each of; recovered stolen vehicle, domestic violence, missing person, stolen vehicle, animal bite, forgery, violation of probation, child molest, identity theft, and suicidal subject.

Highlights for the Week

On November 17th at about 11:50 AM Ukiah Police responded to the FoodMaxx parking lot, at 1235 Airport Park Boulevard, for a subject talking to himself. The responding officer was waived down by 42 year old Michael Shannon Early, of Willits. Early told the officer his vision was blurry and he needed help getting eyeglasses, and that he felt like he was going to mentally explode. Early had injected himself with methamphetamine, and was arrested for being under the influence of a controlled substance. 13-3134

On November 20th at about 3:30 PM Ukiah Police responded to the parking lot at Applebee's, at 1201 Airport Park Boulevard, for a domestic violence incident. The victim reported having gone to lunch with her fiancé, 28 year old Ismael Raul Ceja-Reyes, of Ukiah, when they began arguing about their relationship. Ceja became enraged, and the victim retreated to the women's bathroom. Ceja eventually entered the women's restroom and demanded the victim exit the stall, and then crawled under the partition and forced the victim from the stall. Ceja physically blocked the victim's path from leaving the restroom, and the victim eventually returned to their table where Ceja sat on the same side of the bench to keep the victim from leaving. The victim eventually told Ceja she would leave with him, then quickly left through a separate exit and sought refuge inside a friend's vehicle. Ceja eventually left and the police arrived soon after. On November 22nd at about 5:25 AM a Ukiah Police Officer spotted Ceja driving in the 300 block of East Gobi Street and stopped him. Ceja was arrested for domestic violence, forced imprisonment, and driving without a driver's license. 13-3188

On November 21st at about 10:50 AM Ukiah Police responded to a residence in the 400 block of Eastlick Street for a burglary in progress. Officers contacted 35 year old Ryan Glen Loomis who was waiting outside the residence, and who told officers he'd fled the house because he believed people had entered while he was inside. Officers checked the interior of the residence and found no indications of a burglary or forced entry. Officers spoke further with Loomis who explained he'd been watching his parents' house while they were away, and he'd been having various visitors to the house using methamphetamine. Loomis said he had been inside when he thought he heard some of the visitors enter the house and talk about burglarizing the residence. Loomis locked himself in the bedroom, then fled the house and called police.

Loomis was found to have used methamphetamine and was arrested for being under the influence of a controlled substance, and for violating his probation. 13-3197

On November 22nd at about 11:35 AM Ukiah Police responded to the maternity ward at the Ukiah Valley Medical Center, at 275 Hospital Drive, for a domestic battery. Officers learned 19 year old Logan Dwayne Schulze, of Willits, and the victim were with their newborn baby in one of the rooms. Schulze apparently became angry with the victim, and slapped the victim's face while the victim was in bed. Schulze grabbed the victim's face with his hands, digging his thumb into the victim's eye. Schulze left and returned a short time later, and again slapped and grabbed the victim's face, and also the victim's arm. The victim sustained visible injuries on her face and arm. Schulze admitted to the domestic violence, and was found to have less than one gram of methamphetamine hidden in his sock. Schulze was arrested for domestic battery and possessing methamphetamine. 13-3210

On November 22nd at about 9:40 PM Ukiah Police responded to Wal Mart, at 1155 Airport Park Boulevard, for a shoplifter. Officers learned 21 year old Allyssa Dawn Stafford, of Canada, was observed concealing underwear in her purse and exit the store without paying. Stafford was detained, and stated she entered the store without money intending to steal underwear, that she didn't believe in paying for things and didn't believe items should have a value attached to them. Stafford was arrested for burglary. 13-3216

On December 2nd at about 2:05 PM Ukiah Police stopped a vehicle being driven by 47 year old Joseph Emile Severin, of Los Angeles, in the 900 block of North State Street. Severin was on probation in Los Angeles County, and had a warrant for his arrest from Lake County for possessing a controlled substance. The passenger in the vehicle, 33 year old James Alexander States, of Fair Oaks, had two warrants for his arrest from Placer County for DUI. A search of the vehicle revealed around 50 grams of marijuana "hash", which belonged to Severin, and he was charged additionally with possessing concentrated cannabis. 13-3308

On December 2nd at about 8:20 PM Ukiah Police responded to an apartment complex in the 500 block of South Main Street for a male subject yelling and causing a disturbance near the garages. The responding officer contacted 49 year old Anthony Ray Price, of Palo Alto, who was charging his cell phone with one of the exterior outlets. Price denied being on probation or

parole, but was later found to be on parole out of San Jose. Price stated he had some knives in his possession, and the officer located 3 fixed bladed throwing knives in his back pocket. Price also had several more folding blade knives, all of which had blades in excess of the length parolees are allowed to possess. Price had several baggies with drug residue in them, a hypodermic syringe, a methamphetamine smoking pipe, and a glass pipe used to smoke rock cocaine. Prices also had a warrant for his arrest for violating parole, and was arrested for possessing an illegal weapon, possessing drug paraphernalia, violating parole, and the warrant. 13-3314
