### **Patrol Division Weekly Activity Report 1/9/14 to 1/15/14**

#### **Statistics**

**Arrests included: 11 for public intoxication, 5 warrant arrests, 5 for shoplifting, 3 for being under the influence of a controlled substance and/or possessing drug paraphernalia, 2 for marijuana sales, and 1 each for: possessing methamphetamine, domestic violence, burglary, possessing a knife at school, hit and run while DUI, possession of a stun gun by a felon, resisting arrest, and forgery. Probation or parole holds were placed on 4 of these arrests.**

**Officers investigated 1 hit and run DUI traffic collision, and 1 death by apparent natural causes. Two vehicles were stored for 30 days due to the drivers being unlicensed or suspended.**

**Officers took reports of: 9 child neglect, 5 found property, 3 burglaries, 3 thefts, 3 vandalisms, 2 domestic violence, 2 transportation of marijuana, and 1 each of; battery, violating a court order, fraud, annoying telephone calls, public intoxication, forgery, passing a counterfeit bill, stolen vehicle, dependent adult abuse, and animal bite.**

**Officers were assisted by the California Highway Patrol with locating and recovering a stolen vehicle.**

### Highlights for the Week

On January 9<sup>th</sup> at about 4:00 PM Ukiah Police responded to Wal-Mart, at 1155 Airport Park Boulevard, for two shoplifters. Store employees observed 30 year old Michael Duane Deaton and 32 year old Evelyn Alice Partridge, both of Willits, inside the store together. Deaton was seen putting new shoes on, and returning his old ones to the shelf. Partridge concealed a package of shirts, and both left the store without paying for the items. Deaton and Partridge were arrested for shoplifting. 14-0076

On January 9<sup>th</sup> at about 10:05 PM Ukiah Police responded to 998 South State Street for a female blocking the doorway and refusing to leave. Officers contacted 22 year old Jennifer Rae Kachur, of Yuba City, who was standing in the business' doorway. Kachur refused to move and was unresponsive to the officers. Kachur had 3 warrants for her arrest from Yuba City for trespassing, burglary, and battery upon a peace officer, and a warrant from Sutter County for failing to appear in court. Kachur was arrested and booked into the County Jail for the warrants. 14-0081

On January 11<sup>th</sup> at about 3:30 AM Ukiah Police responded to the 100 block of Observatory Avenue for an in-progress vandalism. Officers from the California Highway Patrol responded to assist, and saw a 17 year old male juvenile running from the area, and detained him. The juvenile was intoxicated, and became belligerent with the officers before charging towards a CHP Officer. The juvenile was restrained, and he continued to struggle and pull away and was arrested for resisting arrest and public intoxication. The juvenile later spit at an officer and was charged with battery upon a peace officer. 14-0089

On January 11<sup>th</sup> at about 8:00 PM Ukiah Police responded to the 100 block of Clara Avenue for a hit and run traffic collision with injuries. Officers learned the 47 year old female victim had been unloading groceries from a parked vehicle and was standing near the open doors when the vehicle was struck from behind. The collision caused the parked vehicle to move forward and strike another parked vehicle, and the doors struck the victim and knocked her to the ground. Witnesses described the suspect vehicle as a white passenger car, which fled the scene. Officers located a white 1998 Plymouth Breeze with front end damage parked in the 600 block of North Orchard Avenue, and soon located the driver; 27 year old Daniel Fox, of

Clearlake. Fox was intoxicated, and was arrested for DUI and felony hit and run causing injuries. 14-0097

On January 12<sup>th</sup> at about 11:00 PM Ukiah Police responded to the 1000 block of North State Street for a suspicious subject. Officers contacted 33 year old Vaughn Alden Oseth, of Colorado, who had been drinking heavily and appeared to have urinated on himself. Oseth was belligerent and was arrested for public intoxication. 14-0099

On January 12<sup>th</sup> at about 2:15 AM Ukiah Police responded to the area of Clara and Myron Streets for a disturbance with multiple people in the roadway. One of the involved subjects was contacted and identified as 32 year old William Andrew Boyce, of Ukiah. Boyce had a stun gun which was incorporated into a flashlight, and as a convicted felon was prohibited from possessing such weapons. Boyce was arrested for being a felon in possession of a stun gun. 14-0100

On January 13<sup>th</sup> at about 3:30 PM Ukiah Police responded to DFM Car Stereo, at 1080 North State Street, for check forgery. Officers learned 36 year old David Lee Waltz, of Lancaster, had purchased over \$750.00 of stereo equipment on January 2<sup>nd</sup>, and paid using checks written on a closed account. The store employees learned Waltz had since been arrested for other charges and booked into jail, and utilized the on-line booking photo system to view Waltz' photo and confirm his identity. Waltz was still in custody and was charged with burglary and passing fraudulent checks. Waltz was on probation in Yolo County for possessing drugs for sale, and was also charged with violating that probation. 14-0124

On January 13<sup>th</sup> at about 7:50 PM Ukiah Police responded to the 1000 block of South State Street for the report of a subject possibly armed with a firearm, near a hotel. The suspect was then reported to have left in a vehicle, which officers located parked in the 100 block of Talmage Road. Officers contacted 39 year old Charles Dale Maxfield and 28 year old Christopher Michael Gonsman, both of Ukiah, neither of whom had a firearm. Officers did locate a knife with a large wooden handle inside the vehicle, as well as numerous bags of loose marijuana, some bud marijuana, and over \$8000.00 in what was later determined to be counterfeit US Currency. After obtaining statements from both suspects and witnesses, officers determined Maxfield and Gonsman had sold an unknown amount of marijuana to two subjects

from Texas at a nearby hotel. Maxfield and Gonsman left but soon determined they had been paid with counterfeit money, and returned to the hotel to find the buyers had left. Maxfield and Gonsman were seen leaving the hotel and one of them likely had the knife in his waistband, the large handle of which was likely mistaken for the handle of a firearm. Maxfield and Gonsman were arrested for sales of marijuana and criminal conspiracy, and Maxfield also with possessing counterfeit money. 14-0126

On January 15<sup>th</sup> at about 2:15 PM Ukiah Police responded to Kohl's, at 437 North Orchard Avenue, for a shoplifter. Store employees had observed 28 year old Edward Taylor Esquivel, of Willits, conceal several shirts and leave without paying. Esquivel was returned to the store and the merchandise recovered. Esquivel stated he was shopping for two nice shirts as he was preparing to visit his girlfriend out of town. Esquivel realized the shirts were too expensive and stole them. Esquivel was arrested for shoplifting. 14-0137
