Statistics

Arrests included: 12 for public intoxication, 6 warrant arrests, 4 for domestic violence, 4 for being under the influence of a controlled substance and/or possessing drug paraphernalia, 4 for violating probation, 3 for possessing methamphetamine, 3 for battery, 2 for shoplifting, and 1 each for: burglary, vehicle pursuit, prowling, and indecent exposure. Probation or parole holds were placed on 5 of these arrests.

Officers investigated 1 traffic collision, 1 injury traffic collisions, and 1 death by apparent natural causes. Two vehicles were stored for 30 days due to the drivers being unlicensed or suspended.

Officers took reports of: 8 found property, 4 burglaries, 3 vandalisms, 2 child neglect, 2 domestic violence, and 1 each of; suicidal subject, missing person, battery, fraud, stolen vehicle, and transporting marijuana.

Highlights for the Week

On January 24th at about 12:10 AM a Ukiah Police sergeant was patrolling in the Oak Manor area, and saw a gray BMW speeding east on Perkins Street through the Oak Manor Drive intersection. The sergeant began pursuing the vehicle, which was traveling at over 50 miles per hour in violation of the 35 miles per hour speed limit.

The vehicle turned north onto Redemeyer Road, then east on Vichy Springs Road in excess of speeds of 50 miles per hour refusing to yield to the officer's emergency lighting. The sergeant recognized the vehicle as possibly belonging to 38 year old Jeremy Lee Simms, who was wanted by the Mendocino County Sheriff's Office related a robbery which occurred several days prior, on January 21st.

The vehicle turned onto Medicine Way and continued at speeds in excess of 50 miles per hour in violation of the 15 miles per hour speed limit. The vehicle slowed at the end of the street and turned into a front yard, and Simms exited the vehicle while it was still moving. The vehicle rolled into a cyclone fence and stopped, and Simms ran from the officer changing direction several times, apparently looking for an opening in the fence.

Simms eventually gave up and was taken into custody without further incident. Simms was found to have several hydrocodone tablets in his possession. Simms' vehicle and the fence were damaged from the collision. Simms was arrested for evading in a vehicle and possessing a narcotic, and was released to the custody of the Sheriff's Office for questioning pursuant to their robbery investigation. 14-0219

On January 24th at about 2:05 PM Ukiah Police were at the police station, at 300 Seminary Avenue, when a domestic violence situation occurred outside the station. Officers learned the victim had arrived at the police department to conduct a safe child visitation exchange with 41 year old Jenny Rebecca Shakman. Officers learned the victim was videotaping the contact, and recorded an argument between he and Shakman because she failed to be tested for substance abuse before arriving to pick up the children. Shakman was recorded approaching the victim and swinging at the camera, and striking the victim's upper body. Shakman was arrested for domestic battery. 14-0226

On January 24th at about 8:45 PM Ukiah Police Officers were patrolling in the 600 block of North Orchard Avenue, and saw 25 year old Ryan Adam Raya, who was wanted by parole. Raya was joined by 30 year old Ricky Lee Renick, and both ran upon seeing the officers. Officers pursued the subjects, and Raya ran into a residence. Renick was ordered to stop and did so, and was taken into custody for violating his probation by having consumed alcohol. Raya eventually exited the residence and was arrested for violating parole. 14-0233

On January 25th at about 8:40 PM a Ukiah Police Officer observed a vehicle traveling at a high rate of speed northbound in the 100 block of North Orchard Avenue. The officer attempted to catch up the vehicle, and saw the vehicle “spin out” completing a full circle near Clara Avenue, then pull into a nearby parking lot. As the officer parked behind the vehicle, the driver and passenger were seen switching seating positions. The driver was identified as 24 year old Pablo Alexander Reyes-Sanchez, of Willits, who was intoxicated and arrested for DUI and for driving with a suspended driver’s license. The passenger, 21 year old Carlos Ochoa Valdovinos, of Washington, was arrested for public intoxication. 14-0245

On January 26th at about 12:50 AM Ukiah Police contacted two subjects in the 800 block of Waugh Lane. One of the subjects was identified as 23 year old Gabriel Robin Kragler, of Ukiah, and the other was later identified as 35 year old Bret Alcott Bengston. Kragler displayed symptoms of recent drug use, and was in possession of a hypodermic syringe which contained liquid methamphetamine. Kragler was eventually arrested for possessing methamphetamine and drug influence. Bengston had provided a false name to officers, and was in possession of several small devices commonly used in the theft of vehicles. Upon confirming Bengston had provided false identity, the officers began to arrest him and he tried to pull away and struggled, resisting arrest. Bengston was taken into custody, and was found to possess less than one gram of methamphetamine. While Bengston was being walked toward the patrol vehicle he again tried to run away and had to be further restrained. Bengston was arrested for possessing methamphetamine, providing false identity, resisting arrest, and attempted escape. 14-0247

On January 27th at about 9:50 AM Ukiah Police responded to the Jack in the Box parking lot, at 1115 Airport Park Boulevard, for a fight. Officers found 23 year old Jacob Warren Hopkins, of Washington, being consoled, and learned Hopkins had been assaulted after using

racial slurs towards a subject. Hopkins had been drinking heavily and was arrested for public intoxication. 14-0257

On January 27th at about 10:40 AM Ukiah Police responded to Starbucks, at 1212 Airport Park Boulevard, for a subject causing a disturbance and refusing to leave. Officers located 32 year old Aaron Michael Still, of Willits, nearby and determined he had for warrants for his arrest for drug use, trespassing, and violating probation. Still was arrested for warrants. 14-0258
