### Patrol Division Weekly Activity Report 2/6/14 to 2/12/14

### Statistics

Arrests included: 10 for public intoxication, 10 warrant arrests, 4 for possessing methamphetamine, 4 for shoplifting, 4 for burglary, 3 for domestic violence, 2 for being under the influence of a controlled substance and/or possessing drug paraphernalia, 2 for possessing marijuana for sale, 2 for fighting at school, and 1 each for: violating probation, violating a court order, and indecent exposure. Probation or parole holds were placed on 4 of these arrests.

Officers investigated 2 traffic collisions and 2 hit and run traffic collisions. Two vehicles were stored for 30 days due to the drivers being unlicensed or suspended.

Officers took reports of: 7 burglaries, 7 vandalisms, 5 found property, 4 thefts, and 1 each of; suicidal subject, fraud, rape, battery, and abandoned vehicle.

### Highlights for the Week

On February 10<sup>th</sup> at about 9:55 AM Ukiah Police responded to Mendocino Farm Supply, at 303 Talmage Road, for a theft. Officers learned two suspects gathered clothing worth several hundred dollars and fled the store without paying. A description of the suspects and their vehicle was obtained, and an officer recognized one of the suspects as 25 year old Juan Carlos Lopez, who is a parolee at large. At about 3:15 PM that afternoon officers responded to a disturbance in the 700 block of El Rio Street, and observed the suspect vehicle parked near-by. Officers contacted 21 year old Esteban Jorge Camarillo at the location, who was wearing clothing resembling what was stolen and who matched the other suspect description. A store employee responded and confirmed Camarillo was observed committing the theft, and additional clothing was recovered from the vehicle. Camarillo was arrested for possessing stolen property, burglary, and criminal conspiracy. Juan Carlos Lopez was not located and is being sought for these charges and for a parole warrant. 14-0418

On February 10<sup>th</sup> at about 5:40 PM Ukiah Police responded to a residence in the 100 block of Rupe Street for a reported vandalism. Officers learned the victim was inside and observed 18 year old Brittany Ann Pinola and 19 year old Gabriella Darlene Pinola using a chair and a baseball bat to break the windows of the victim's vehicle. The victim believed the suspects were angry and jealous of a shared relationship with a subject currently incarcerated in prison. On February 11<sup>th</sup> the suspects were contacted and agreed to come to the Ukiah Police Department and provide a statement. At about 2:45 PM both suspects were interviewed and initially denied involvement, but eventually partially admitted culpability. Brittany and Gabriella Pinola were arrested for vandalism and criminal conspiracy. 14-0422

On February 11<sup>th</sup> at about 1:55 PM Ukiah Police responded to a motel in the 600 block of South Orchard Avenue to serve four felony arrest warrants on 23 year old Jordan Gary Bright. Upon answering the door and observing the officers, Bright attempted to close the door on the officers and had to be taken to the ground where he continued to physically resist and struggle before being taken into custody. Officers located over a pound of marijuana in Bright's room and a computer determined to have been stolen in the Redwood Valley area in October of 2013. The computer was released to the Mendocino County Sheriff's Office and Bright was arrested for possessing stolen property, resisting arrest, and 4 arrest warrants which included charges of violating probation. 14-0428
