Statistics

Arrests included: 10 for public intoxication, 8 warrant arrests, 6 for being under the influence of a controlled substance and/or possessing drug paraphernalia, 4 for domestic violence, 4 for shoplifting, 3 for possessing a knife at school, and 1 each for; resisting arrest, violating probation or parole, and possessing a narcotic. Probation or parole holds were placed on 4 of these arrests.

Officers investigated 1 traffic collision. One vehicle was impounded for 30 days for the driver being unlicensed or suspended.

Officers took reports of: 5 vandalisms, 4 thefts, 4 child neglect, 3 burglaries, 2 found property, 2 missing persons, 2 animal bites, and 1 each of; battery, arson, threats, domestic violence, stolen vehicle recovery, and suicidal subject.

Highlights for the Week

On March 16th at about 10:25 AM Ukiah Police responded to a residence in the 500 block of South Spring Street for multiple unwanted subjects occupying the house. Officers contacted the subjects, one of whom was later identified as 30 year old Mark Mina Gabriel. The subject provided a different name to officers, but was unable to remain consistent with his identifying information leading the officers to believe he was providing a false identity. Gabriel's identity was confirmed and he was found to have a warrant for his arrest from Sonoma County, and 6 warrants for his arrest from Mendocino County for possessing a firearm and drug related charges. Gabriel was arrested for the warrants, and charges of providing another's identity are being sought with the District Attorney's Office. 14-0773

On March 17th at about 11:35 PM Ukiah Police were patrolling the area of Vinewood Park due to a recent increase in damage and destruction to the City's parks at night. The officer observed a subject rummaging through the garbage cans in the park, which is in violation of several city ordinances. When the officer attempted to contact the subject, the suspect fled on a bicycle and refused to cooperate or stop. The officer drove after the bicyclist, who changed directions several times and yelled to the officer several times, that she would not stop for the officer. The bicyclist fled to Magnolia Street, then turned onto Elm Street where the officer was able to block the bicyclist's path and had to forcefully remove the suspect from the bicycle. The suspect physically resisted and tried to get away, and proceeded to scream loudly, stating she could not return to jail. The suspect was taken into custody and identified as 30 year old Jessica Misty Ewing, who was on probation and had 3 warrants for her arrest for drug related charges. Ewing had less than a gram of methamphetamine and a methamphetamine smoking pipe in her possession. Ewing was arrested for the warrants, for violating probation, possessing methamphetamine and drug paraphernalia, and resisting arrest. 14-0791

On March 18th at about 7:35 PM Ukiah Police responded to the intersection of Talmage Road and Airport Park Boulevard for a vehicle stopped in the intersection, with a non-responsive driver. Witnesses had observed the vehicle stopped on Talmage Road at the stoplight, and that it failed to proceed for the green light. The vehicle finally slowly entered the intersection and stopped, and the driver was seen slouched over the steering wheel and passed out. The officer was able to awaken the driver, identified as 51 year old Evan Matt Morris, who had been drinking. Morris was on probation and prohibited from drinking alcohol, and was found too intoxicated to drive and was arrested for DUI and for violating probation. 14-0802
