Patrol Division Weekly Activity Report 4/3/14 to 4/9/14

Statistics

Arrests included: 7 warrant arrests, 7 for public intoxication, 4 for domestic violence, 4 for possessing methamphetamine, 3 for shoplifting, 3 for violating probation or parole, 3 for possessing methamphetamine for sale, 2 for possessing stolen property, and 1 each for; being under the influence of a controlled substance and/or possessing drug paraphernalia, burglary, battery, vandalism, threats, and violating a court order. Probation or parole holds were placed on 4 of these arrests.

Officers investigated 4 traffic collisions and 2 hit and run traffic collisions. One vehicle was impounded for 30 days due to the driver being unlicensed or suspended.

Officers took reports of: 11 found property, 2 thefts, 2 abandoned vehicles, 2 domestic violence, 2 stolen vehicles, and 1 each of; battery, burglary, suicidal subject, identity theft, vandalism, missing person, and sexual battery.

Officers assisted the DEA and US Marshalls with service of a search warrant and prisoner transport, the Mendocino Major Crimes Task Force with service of a search warrant, and hosted a presentation on fraud.

Highlights for the Week

On April 5th at about 1:40 AM a Ukiah Police Officer was driving east in the 200 block of East Perkins Street. A vehicle ran the stop sign on Mason Street and turned right onto East Perkins Street, driving west in the eastbound lane directly at the police vehicle. The officer had to stop suddenly to avoid being hit by the vehicle, which corrected its lane passing within 5 feet of the police vehicle. The officer caught up to the vehicle in the 300 block of South Main Street, and stopped it. The driver was identified as 21 year old Neftali Cervantez Solis, who had been drinking. Solis was found too intoxicated to drive and was arrested for DUI. 14-0965

On April 5th at about 4:30 PM Ukiah Police contacted two occupants of a parked vehicle behind Home Depot, at 350 North Orchard Avenue. Officers identified 61 year old Rudy Berain, of Santa Rosa, who had two warrants for his arrest from Sonoma County for drug related charges. Berain was arrested, and was found to possess several grams of methamphetamine in separate packaging. Officers identified 59 year old Sue Anne Arnold, of Novato, who displayed symptoms of having used methamphetamine recently and was arrested for drug influence. Arnold possessed less than a gram of methamphetamine, and a pipe used to smoke methamphetamine. Berain and Arnold were arrested for possessing and transporting methamphetamine for sale. 14-0967

On April 6th at about 12:25 AM Ukiah Police responded to the Redwood Tree Car Wash parking lot, at 859 North State Street, for a disturbance. Officers contacted four subjects and learned there had been an altercation with several other subjects, and two vehicles had been damaged. The first victim reported he was conversing and socializing with the other subjects, and they were approached by 22 year old Andrew James Wiley, of Willits, and another subject. The group was conversing about an incident earlier that evening wherein there had been a fight and a vehicle vandalized at the Redwood Empire Fairgrounds, in which the California Highway Patrol had investigated and made an arrest. A vehicle occupied by 21 year old Daniel Kevin Pierce and 20 year old Tevin Durell Marizette then arrived in the lot, and Pierce confronted the victim while Wiley, Marizette, and the other subject encircled him. Pierce challenged the victim about the earlier fairgrounds incident, and Marizette then punched the victim who was backing away towards his parked vehicle. The victim was trying to enter his vehicle and Pierce punched him several times and pulled on the driver's door to prevent the victim from closing it.

Marizette apparently punched the victim's vehicle several times, causing several dents. The victim was able to start his vehicle and drive to safety.

The second victim reported seeing the confrontation begin with the first victim, and approached hoping to diffuse it. Marizette apparently punched the second victim before proceeding to punch the first victim's vehicle. Marizette then followed the second victim to his vehicle, and proceeded to punch and kick the second victim's vehicle before it drove away. The suspects then drove away from the location. Neither victim was seriously injured during the attack but both vehicles sustained several thousand dollars in damage.

At about 3:30 AM Ukiah Police Officers went to a residence in the 1700 block of Talmage Road and contacted Pierce and Wiley. Pierce was arrested for vandalism, battery, and criminal conspiracy. Wiley was arrested for a warrant for failing to appear for traffic related charges. Marizette was not located and is still being sought. 14-0972

On April 6th at about 1:35 AM a Ukiah Police Officer was in the checkout line at Safeway, at 653 South State Street, and saw 24 year old Nolan Lee Bowers enter the store. Bowers had two warrants for his arrest for drug related charges, and the officer contacted Bowers. The officer saw Bowers reach into his pocket, who then started to pull away and a struggle ensued, with the officer having to take Bowers to the ground where he was taken into custody. Bowers had several hypodermic syringes in his possession, one of which contained liquid methamphetamine. Bowers was arrested for the warrant, for possessing methamphetamine, and for resisting arrest. 14-0973

On April 6th at about 11:15 AM Ukiah Police responded to the Jack in the Box parking lot, at 1115 Airport Park Boulevard, for sales of drugs. Officers contacted an off-duty peace officer from out of county, who was eating at Jack in the Box. The officer observed a subject seated in the driver's seat of a parked white Ford Explorer, and saw multiple subjects approach the driver and converse briefly, then leave. The officer saw the driver and others exchange items, and believed the driver was selling drugs. Officers contacted the driver identified as 53 year old Michael Izell Brown, also known as Michael Seals. Officers determined Brown was on parole, and a search of his vehicle revealed marijuana, and "kief" marijuana which is a form of concentrated cannabis. Officers also located multiple baggies containing both

methamphetamine and cocaine, totaling more than several grams. Brown was arrested for possessing methamphetamine and cocaine for sale, and for violating parole. 14-0976

On April 6th at about 10:45 PM Ukiah Police were contacted in the 500 block of South Orchard Avenue by a victim of domestic violence. The victim reported a history of domestic violence, and that this evening 28 year old Carlos Reyes Ramirez reached over their 5 year old child and struck the victim numerous times. The victim showed officers a visible injury but declined medical treatment. Officers proceeded to a residence in the 500 block of Peach Street and arrest Ramirez for domestic violence and child endangerment. 14-0983

On April 7th at about 10:50 PM Ukiah Police responded to the pay phone at 1099 South State Street for a 911 call of a burglary in progress. Officers contacted 47 year old Jeffrey Jones who was with his dog, and reported his motorhome was being broken into in the 300 block of Talmage Road. Officers located Jones' motor home and found it secure, and re-contacted Jones. Officers observed Jones was sweating and displaying symptoms of having used methamphetamine recently, and made non-sensical statements about a woman who had drugged him and was breaking into his motorhome. Jones was arrested for being under the influence of a controlled substance. Jones' dog was released to the care of Mendocino Animal Control. 14-0998
