Statistics

Arrests included: 11 for public intoxication, 7 warrant arrests, 5 for shoplifting, 3 for burglary, 3 for possessing a controlled substance, 2 for violating probation or parole, 2 for being under the influence of a controlled substance and/or possessing drug paraphernalia, 2 for domestic violence, 2 for resisting arrest, and 1 each for; battery, possessing stolen property, possessing burglary tools, assault with serious injury, child endangerment, and threats. Probation or parole holds were placed on 6 of these arrests.

Officers investigated 1 traffic collision. Three vehicles were impounded for 30 days due to the drivers being unlicensed or suspended.

Officers took reports of: 9 burglary, 6 thefts, 6 found property, 5 child neglect, 3 vandalisms, 2 suicidal subjects, 2 domestic violence, 2 abandoned vehicles, and 1 each of; missing person, animal bite, battery, rape, stolen vehicle, and forgery.

Highlights for the Week

On April 17th at about 9:20 PM Ukiah Police responded to a residence in the 1100 block of Mulberry Street for a juvenile male destroying the residence. The officers arrived to find the interior of the residence in shambles; there was a hole kicked in the wall, photos and mirrors had been removed from the walls and thrown about the floor and shattered, and furniture had been toppled over. The resident reported her 13 year old grandson had become enraged when she confronted him about hanging around gang members, and he proceeded to cause the damage. The residence requested her grandson be prosecuted, and the 13 year old juvenile male was arrested for vandalism. 14-1109

On April 18th at about 5:10 PM a Ukiah Police Officer saw 35 year old James Robert Lane riding a bicycle in the 200 block of East Gobbi Street. The officer had been investigating Lane recently and determined he had a no-bail warrant for his arrest. The officer stopped Lane, who identified himself with a different name and date of birth, which was later determined to belong to a family member. Lane was behaving in a very nervous fashion, and was found to possess two methamphetamine smoking pipes and was arrested. A search of Lane's belongings revealed several credit cards in others' names, and several shaved keys commonly used to steal vehicles. Lane was arrested for the warrant, and charged with falsifying his identity, possessing drug paraphernalia, possessing burglary tools, and unlawful possession of credit cards. 14-1124

On April 19th at about 1:45 AM Ukiah Police responded to the 200 block of East Perkins Street for subjects fighting, and one reportedly swinging a belt. A vehicle window had also apparently been broken out by the same subject. Upon arriving officers observed a male wearing no shirt and with blood on his face running in the middle of Perkins Street. Numerous people were pointing at the subject, who refused commands to stop and ran into the alley between the Perkins Street Grill and Curry's Furniture. The officer pursued the subject who continued running then began climbing a fence. A police K9 caught up to the subject and assisted the officer in capturing and subduing the subject, who was identified as 19 year old William Cody Wolfe. It was determined Wolfe and 22 year old Christopher Robert Ashurst had been ejected from the Perkins Street Grill earlier in the evening, and proceeded to become involved in fighting several other people in the parking lot. The fight ended up in the street and a motorist had to stop, and Wolfe swung his belt at the motorist's window, shattering it. The involved subjects then quickly dispersed upon hearing the police sirens. Wolfe was charged with resisting arrested and vandalism. While investigating this incident, Ashurst was observed walking in the area, yelling and staggering and obviously intoxicated. Ashurst approached a group of people and was contacted by an officer, who observed injuries on Ashurst consistent with being in a fight recently. Ashurst was on probation and prohibited from consuming alcohol, and was arrested for public intoxication and violating probation. 14-1129

On April 20th at about 7:55 PM Ukiah Police responded to a parking lot in the 600 block of North Orchard Avenue for a DUI driver with a child in the car. Officers spoke to several witnesses and learned 25 year old Reina Alma Ramirez was seen driving her vehicle into the lot at a high rate of speed. One of the witnesses confronted Ramirez about her driving, and noticed Ramirez was intoxicated and her 1 year old child was in the car. Ramirez became confrontational and a yelling match ensued, and several other residents became involved in the incident. Ramirez' child was eventually taken to a place of safety, and Ramirez was convinced to park her vehicle and was last seen walking away from the area. An officer located Ramirez in the 200 block of North Orchard Avenue, and confirmed she had been drinking. Ramirez was found too intoxicated to drive and was arrested for DUI and child endangerment. 14-1144

On April 21st at about 11:25 AM Ukiah Police stopped a vehicle in the 100 block of Washington Avenue. The driver verbally identified himself with what was determined to be a false name, and upon further investigation was identified as 25 year old Juan Carlos Lopez. The officer had investigated Lopez in February when he had been identified in the theft of clothing from the Mendocino County Farm Supply. Lopez had a suspended driver's license, and six warrants for his arrest some of which were related to the theft investigation and parole violations. Lopez was arrested for the warrants, for driving on a suspended driver's license, and for providing false identity to law enforcement. 14-1151/14-0418
