### Patrol Division Weekly Activity Report 5/1/14 to 5/7/14

### Statistics

**Arrests included: 9 warrant arrests, 9 for public intoxication, 7 for being under the influence of a controlled substance and/or possessing drug paraphernalia, 3 for shoplifting, 2 for domestic violence, and 1 each for; burglary, possessing an inhalant, possessing methamphetamine, possessing a prohibited weapon, and resisting arrest. Probation or parole holds were placed on 3 of these arrests.**

**Officers investigated 5 traffic collisions and 1 injury traffic collision. One vehicle was impounded for 30 days due to the driver being unlicensed or suspended.**

**Officers investigated and took reports of: 6 found property, 4 thefts, 4 vandalisms, 2 suicidal subjects, 2 identity theft, 2 abandoned vehicles and 1 each of; missing person, burglary, threats, violation of a court order, explosive device, stolen vehicle, and assault with a deadly weapon.**

**Officers assisted the California Highway Patrol with a narcotics investigation and a hit and run traffic collision, and the Mendocino County Sheriff's Office with a combative subject, and were assisted by the Healdsburg Police Department with an assault investigation.**

### Highlights for the Week

On May 1st at about 5:00 PM Ukiah Police stopped a vehicle being driven by 33 year old Daniel Amos Zook, of South Lake Tahoe, in the 100 block of East Gobbi Street. The officer immediately smelled marijuana from within the vehicle, and Zook admitted to having marijuana. Zook displayed symptoms of having used drugs recently, and initially refused to exit the vehicle. Upon being searched Zook pulled away and resisted the officer. Zook was physically restrained, and found to possess a hypodermic syringe in his pocket. A narcotics detection K9 was used to assist in locating over 100 grams of concentrated cannabis within the vehicle. Also located were items consistent with the processing and packaging of concentrated cannabis. Zook was arrested drug influence and for possessing concentrated cannabis. 14-1257

On May 2nd at about 11:30 AM a Ukiah Police Officer saw 40 year old Mark Aaron Beardslee, of Santa Rosa, walking in the 200 block of Perry Street. Beardslee approached a parked vehicle and stopped, and peered into the window of the vehicle. The Ukiah Police Department has investigated a very large number of car burglaries recently, and the officer went to contact Beardslee. As Beardslee saw the officer approach, he began walking away then broke into a run refusing commands to stop. After a short foot pursuit Beardslee was captured and taken into custody for resisting arrest. Beardslee displayed symptoms of drug use, and was additionally charged with drug influence. 14-1261

On May 3rd at about 10:05 AM Ukiah Police received a report of 23 year old Heather Renee Christiansen driving a blue SUV on North Dora Street while intoxicated. Ukiah Police received a second report of the vehicle being driven at a high rate of speed on North State Street. Officers located the vehicle in the 1300 block of North State Street and stopped it. Christiansen had been drinking, and was found too intoxicated to drive and was arrested for DUI. 14-1273

On May 5th at about 10:20 AM Ukiah Police responded to the 200 block of Mason Street for a subject reportedly walking along the railroad tracks inhaling an intoxicant, and talking about shooting people at the hospital. The responding officer observed 36 year old Jai Chandler Kamke, of Los Angeles, inhaling the contents of a white canister. Kamke mentioned something about a gun and referred to people that were not present, and was arrested for inhalation of an

intoxicant. Kamke was found to have 5 arrest warrants from out of county for public intoxication and possessing inhalants, and was additionally arrested for the warrants. 14-1292

On May 6th at about 5:00 PM Ukiah Police responded to a stabbing in the 200 block of Observatory Avenue. Officers found the 41 year old male victim had suffered multiple stab wounds to the upper body area, and he was flown to an out of the area hospital with serious injuries. The incident remains under investigation and anyone with information is asked to call the Ukiah Police Department at 463-6262. 14-1311

On May 6th at about 10:30 PM Ukiah Police responded to a room at the Sunrise Inn, at 650 South State Street, for a female reporting the lights had flickered in her room while her boyfriend was in the shower. The female stated she was now afraid to check on her boyfriend fearing he had committed suicide. Responding officers contacted 39 year old Shawn Carolyn Balictar, of Fort Bragg, who displayed obvious symptoms of having used methamphetamine recently. No other subjects were located inside the room and Balictar could not explain her call to police. Balictar was arrested for being under the influence of a controlled substance. 14-1313

On May 7th at about 9:20 PM Ukiah Police stopped a vehicle being driven by 23 year old Asia Marexlina Noel, of Sacramento, in the 100 block of North State Street. The passenger in the vehicle provided verbal identification and was released from the scene. Noel's driver's license was suspended, she was on probation in Sacramento County, and she had two warrants for her arrest from Solano and Sacramento Counties and was arrested. Officers soon discovered the passenger had lied about his identity, and determined he was 23 year old Frank Shigezo Lacy, from Sacramento, and he had a no-bail warrant for his arrest for violating his Post Community Release Supervision. Lacy was soon located in the 600 block of South Orchard Avenue and arrested. 14-1321

On May 8th at about 4:20 AM Ukiah Police responded to the area of the 700 block of Yosemite Drive to assist the California Highway Patrol search for a subject that had fled from them. In the 600 block of Kings Court officers contacted 32 year old Jesse James Vickers who resembled the description of the wanted subject. Vickers was determined not to have fled from law enforcement earlier, but was found to possess a concealed fixed blade knife and was arrested for illegal weapons possession. 14-1232
