Statistics

Arrests included: 7 warrant arrests, 7 for domestic violence, 6 for being under the influence of a controlled substance and/or possessing drug paraphernalia, 4 for public intoxication, 3 for possessing methamphetamine, 2 for possessing marijuana, 2 for prowling, 2 for shoplifting, and 1 each for; resisting arrest, possessing marijuana at school, and possessing stolen property. Probation or parole holds were placed on 5 of these arrests.

Officers investigated 1 traffic collision, and 2 deaths by apparent natural causes. One vehicle was impounded for 30 days due to the driver being suspended or unlicensed.

Officers investigated and took reports of: 13 child neglect, 7 found property, 4 animal bites, 4 burglaries, 3 thefts, 3 vandalism, 3 suicidal subjects, 2 elder abuse, and 1 each of; stolen vehicle, stolen vehicle recovery, missing person, domestic violence, abandoned vehicle, shoplifting, and rape.

Highlights for the Week

On June 6th at about 1:40 AM Ukiah Police responded to the Ukiah Valley Medical Center Emergency Room, at 275 Hospital Drive, for a disturbance. Arriving officers saw hospital security running after 23 year old Michael Evan Eldredge, into the parking lot. An officer ran after Eldredge who ran behind the hospital then jumped several fences and headed towards Perkins Street. Another officer saw Eldredge inside the fenced area of the old Wendy's restaurant, and found him hiding in the tall grass in the corner of the lot. Eldredge was intoxicated, and stated he ran when he saw the police arriving. Eldredge was arrested for public intoxication and resisting arrest. 14-1633

On June 7th at about 1:05 AM Ukiah Police stopped 41 year old Randall Lee Gensaw, who was riding one bicycle and pushing another, in the 700 block of South State Street. Gensaw displayed symptoms of having used a controlled substance recently, and was determined to be under the influence of a drug and was arrested. Gensaw had several baggies of methamphetamine in his possession, and was charged with possessing methamphetamine. A check of the serial number of the bicycle Gensaw was riding revealed it to have been reported stolen in March, and Gensaw was additionally charged with possessing stolen property. 14-1646

On June 7th at about 11:50 PM Ukiah Police responded to Safeway, at 653 South State Street, for a subject passed out in front of the store. Officers contacted 28 year old Daniel Arjuna De Lucia, of Upper Lake, and were able to awaken and talk with him. Lucia became increasingly nervous and anxious, and displayed symptoms of drug influence. Lucia was found to be under the influence of a controlled subject and arrested. Lucia had a methamphetamine smoking pipe and less than one gram of methamphetamine, and a set of metal knuckles in his possession. Lucia was charged with possessing methamphetamine and drug paraphernalia, and with possessing a prohibited weapon. 14-1657

On June 8th at about 10:50 PM Ukiah Police attempted to stop a bicyclist in the 300 block of East Gobbi Street. The bicyclist fled and turned into the trailer park at 460 East Gobbi Street, and pedaled rapidly from officers. The bicyclist suddenly jumped from his bike and into some dense foliage, and eluded officers for several minutes. The subject was soon found seated on the steps of a residence, and he was identified as 30 year old Justin Ellis King, who had a warrant for his arrest for transporting a controlled substance. King initially told officers he had seen another subject jump from a bicycle and flee over a fence. King later admitted he had fled from officers knowing he had a warrant. King was found to possess two baggies of methamphetamine, and was charged with drug possession and for resisting arrest. 14-1665

On June 9th at about 9:05 PM Ukiah Police responded to a residence in the 700 block of El Rio Court for an intruder damaging the interior of the residence. Arriving officers detained 56 year old Jose Felix Cruz as he exited the residence. Officers learned Cruz had entered the residence and began punching and striking the interior walls with sticks causing numerous holes. The resident was familiar with Cruz and declined to have him prosecuted for the damage. However, Cruz displayed numerous symptoms of having used a controlled substance recently and was arrested. Cruz had a methamphetamine smoking pipe and was also charged with possessing drug paraphernalia and for violating probation. 14-1677

On June 10th at about 12:05 PM Ukiah Police responded to the 400 block of North State Street for a subject attempting to register a stolen vehicle. Officers learned 29 year old Ashley LaForge was attempting to register a silver 1997 Acura, which was determined to have been stolen from Antioch. LaForge claimed she traded her vehicle for the Acura and didn't know the Acura was stolen. LaForge was arrested for possessing a stolen vehicle and possessing stolen property. 14-1682

On June 10th at about 2:45 PM Ukiah Police responded to the Pear Tree Center, at 500 East Perkins Street, for a theft. Officers learned 21 year old Daniel Travis Sublet had been observed loading bags of growing soil into his vehicle, that he hadn't paid for. Sublet left and was followed by the witness, who flagged down a passing Sheriff's Deputy who stopped and detained Sublet. Police arrested Sublet for theft, and found he had several different narcotic medications in his possession without a prescription. Sublet was also charged with possessing a narcotic. 14-1691

On June 12th at about 12:50 AM Ukiah Police observed a subject looking into a closed business in the 200 block of North State Street, and contacted him. The subject was identified as 28 year old Richard Casey Townsend, and he displayed symptoms of having used a controlled substance recently. The officer saw Townsend was carrying a duffle bag and noticed a set of nunchaku protruding from a side pocket. Townsend was arrested for drug influence and for possessing an illegal weapon. 14-1706
