### **Statistics**

**Arrests included: 6 for public intoxication, 11 warrant arrests, 5 for being under the influence of a controlled substance and/or possessing drug paraphernalia, 5 for possession of a controlled substance, 3 for possession of a dangerous weapon, 3 for shoplifting, 2 for resisting arrest and 1 each for; domestic violence, violation of a court order, assault with a deadly weapon, burglary, and possession of stolen property.**

**Officers investigated 3 traffic collisions two of which were DUI related where the drivers were arrested and 1 death by apparent natural causes.**

**Officers investigated and took reports of: 4 found property, 3 abandoned vehicles, 3 thefts, 1 burglary, 3 elder abuse, 4 vandalisms, 2 traffic related reports and 1 each of; missing person, counterfeit money, arson, vehicle theft, rape and City code violation.**

**Officers were assisted numerous times by the Mendocino County Sheriff Office's and California Highway patrol with numerous in-progress calls.**

### **Highlights for the Week**

On June 26<sup>th</sup> at about 5:00 PM Ukiah Police contacted 33 year old Brandy Allen on the railroad tracks near Cherry St. During this contact officers observed a methamphetamine pipe protruding from under her shirt. When officers went to arrest Allen she resisted and was taken into custody. Allen was booked into the Mendocino County jail for possession of drug paraphernalia and resisting arrest. 14-1875

On June 27<sup>th</sup> at about 1:40 AM Ukiah Police contacted 21 year old Jaime Gonzalez in the 900 block of N. State St. During this contact officers found that Gonzalez was displaying symptoms commonly associated with being under the influence of a controlled substance. Officers conducted an evaluation and determined that Gonzalez was under the influence of methamphetamine and arrested him without incident. During a search of Gonzalez's person a hypodermic syringe was found on his person. This hypodermic syringe was found to contain methamphetamine. Gonzalez was charged with being under the influence of a controlled substance and possession of a controlled substance. 14-1881

On June 27<sup>th</sup> at about 7:30 AM Ukiah Police responded to Helen Ave regarding a theft of a bicycle. Later this same date at about 9:50 Am the officer observed 35 year old William Matthews walking in the 600 block of S. Orchard Ave. Matthews was pushing a bicycle that matched the stolen bicycle. Upon contact with Matthews the officers confirmed the bicycle was in fact the one reported stolen earlier. During this contact officers found that Matthews was displaying symptoms commonly associated with being under the influence of a controlled substance. Officers conducted an evaluation and determined that Matthews was under the influence of methamphetamine and arrested him without incident. During a search incident to his arrest a lock pick was also found on his person. Matthews was booked into the Mendocino County jail for possession of stolen property, being under the influence of a controlled substance and possession of burglary tools. 14-1883

On June 27<sup>th</sup> at about 1:56 AM Ukiah Police responded to Elm St regarding a male subject branding a firearm. Upon officers arrival they located and contacted 24 year old Mason

McGee. McGee was seen going through a parked vehicle by residents. When confronted McGee reportedly brandished a small black semi auto from his waist, racked the slide and pointed it at the reporting party. McGee held the reporting party at bay while he walked away. McGee was located in the area by officers and arrested without incident. McGee was later booked into the Mendocino County jail for prowling, felon in possession of a firearm, and public intoxication. 14-1894

On June 29<sup>th</sup> at about 8:05 AM Ukiah Police responded to Low Gap park regarding an assault. Upon officers arrival they learned that 38 year old Scott McGann attacked to hikers within the park with a rock. One suffered injury to his head and was transported to the Ukiah Valley Medical Center for treatment. The other victim sought treatment on their own. McGann was arrested and booked into the Mendocino County jail for assault with a deadly weapon. 14-1901

On June 30<sup>th</sup> at about 11:46 PM Ukiah Police responded to the intersection of N. State St and Scott St for a single vehicle traffic collision into a utility pole. Upon officers arrival they contacted 19 year old Damion Sanchez. Sanchez was determined to be the driver and found to be under the influence of alcohol. Sanchez was arrested and booked into the Mendocino County Jail. 14-1915

On July 2<sup>nd</sup> at about 12:19 PM Ukiah Police responded to the 900 block of S. State St regarding a vehicle versus a bicyclist. Upon officers arrival and based on interviews from witnesses the bicyclists was seen riding his bicycle erratically southbound on S. State St. As vehicle traffic passed by the bicyclist swerved into traffic colliding with a passing vehicle. This impact caused the bicyclist to lose control of the bicycle and fall onto the pavement. Witnesses reported to officers that the bicyclist displayed symptoms of alcohol intoxication. Due to injuries sustained the bicyclist was flown to Santa Rosa Memorial Hospital for treatment. 14-1935
