Statistics

Arrests included: 5 for domestic violence, 5 for violating probation or parole, 4 warrant arrests, 4 for shoplifting, 3 for public intoxication, 3 for being under the influence of a controlled substance and/or possessing drug paraphernalia, 3 for possessing methamphetamine, 2 for resisting arrest, and 1 each for; burglary, violating a court order, prowling, possessing stolen property, and vandalism. Probation or parole holds were placed on 7 of these arrests.

Officers investigated 6 traffic collisions, 1 injury traffic collisions, and 1 hit and run traffic collision.

Officers investigated and took reports of: 8 found property, 5 elder abuse, 4 thefts, 3 stolen vehicles, 3 burglaries, 2 abandoned vehicles, 2 vandalisms, 2 batteries, 2 domestic violence, and 1 each of; animal bite, stolen vehicle recovery, sales of marijuana, possessing a loaded firearm in public, forgery, fraud, prowling, missing person, and perjury.

Highlights for the Week

On July 31st at about 4:45 PM Ukiah Police responded to the Savings Bank, at 414 East Perkins Street, for an altered check. Officers determined 25 year old Fabian Reyes Rosales had attempted to cash a check that appeared to have been “washed”, and the payee and dollar amount changed. Further investigation revealed the check had been stolen from the mail earlier the same day. Rosales was arrested for burglary, forgery, identity theft, and violating probation. 14-2277

On August 1st at about 1:35 AM a Ukiah Police Officer noticed a vehicle parked in the 1400 block of North State Street, and noticed the vehicle’s lights were on but nobody was in the vehicle. The vehicle was a BMW, but the license plates belonged on a different brand of vehicle. Further investigation revealed the vehicle was stolen from Clearlake several days prior. Several items of evidence were located within the vehicle, and the case remains under investigation. 14-2279

On August 1st at about 2:15 PM Ukiah Police responded to a residence in the 100 block of Observatory Avenue for a violation of a restraining order and the suspect refusing to leave. Officers learned that 39 year old Zebulon Couthern had a restraining order against him, prohibiting him from being within 100 yards of the victim. Couthern was located seated outside the residence and had been drinking. Couthern was arrested for violating the court order, and once handcuffed became belligerent and repeatedly tried to physically get away from the arresting officer. Couthern continued to twist his body and try to pull away from the officer, nearly spit on the officer, and made several threats. Couthern was also charged with resisting arrest. On August 6th at about 8:20 AM officers returned to the residence for Couthern having damaged the front door. Officers learned Couthern had returned to the residence at about 7:00 AM after being released from jail, and had again been drinking and tried to push his way into the residence, damaging the door. Couthern was located near-by, and placed under citizen’s arrest for vandalism. 14-2344

On August 1st at about 3:00 PM Ukiah Police responded to the 600 block of South Orchard Avenue for a subject with an arrest warrant at location. Officers learned a fugitive recovery agent had spotted 25 year old Jody Allen McCoy, who had a warrant for his arrest

from Lake County for failing to appear in court. McCoy was located and arrested at the location. 14-2284

On August 2nd at about 3:15 AM Ukiah Police responded to the area of North Court Road to assist the Mendocino County Sheriff's Department with a large party with people fleeing and running through yards. Responding officers saw subjects fleeing the area, and could heard the suspects breaking fence boards as they ran through various yards. An officer was near a residence in the 2300 block of South Dora Street and was alerted by the residents, who had a subject detained in their back yard. The officer located a 17 year old male juvenile being detained by the residents, and arrested the juvenile for prowling. 14-2289

On August 2nd at about 8:35 PM a Ukiah Police Officer saw 33 year old Charlene Mae Martinez in the 100 block of Luce Street. Martinez had a warrant for her arrest for possessing methamphetamine, and ran when the officer attempted to contact her. After a short foot pursuit the officer caught up to Martinez behind a building and Martinez physically struggled, attempting to get away, and kicked the officer in the upper body. Martinez was taken into custody and charged with resisting arrest and battery upon a police officer. A search of Martinez' belongings revealed several hypodermic syringes containing methamphetamine, and baggies containing less than a gram of methamphetamine. Martinez was on probation for drug sales, and was additionally charged with possessing a controlled substance and for violating probation. 14-2290

On August 3rd at about 2:25 AM Ukiah Police responded to the area of Safeway, at 653 South State Street, for a stabbing victim. Officers located a 16 year old intoxicated male juvenile stumbling on the sidewalk of State Street, and saw his arms were bloody. The juvenile had a slash wound to one of his arms, and claimed members of an opposing criminal street gang attacked him. The juvenile was taken to the hospital for treatment, where he had to be physically restrained as he remained combative with medical personnel. The juvenile was then booked into Juvenile Hall for public intoxication. 14-2294

On August 5th at about 12:10 AM Ukiah Police responded to a residence in the 300 block of West Perkins Street for a physical domestic fight. Responding officers knocked numerous times on the door of the residence, and receiving no response, eventually forced entry. Officers

located the victim and 29 year old Rodger Brent Sellars inside the residence, and determined the two had argued about texts on the victim's telephone. Sellars apparently pushed the victim during the arguments, and was in violation of a domestic violence related court order requiring only peaceful contact. Sellars was arrested for domestic battery and for violating the court order. 14-2324

On August 5th at about 8:40 PM Ukiah Police stopped a vehicle being driven by 33 year old Joseph Guido Venturi, in the 500 block of North Pine Street. An odor of marijuana was detected within the vehicle's interior, and Venturi displayed symptoms of having recently used drugs including a noticeable fresh injection site on his arm. As Venturi retrieve the vehicle documentation, an officer saw a hypodermic syringe in the storage console. A search of the vehicle revealed additional hypodermic syringes, one of which contained liquid heroin, a methamphetamine smoking pipe, a baggie of heroin and another baggie of methamphetamine, and other items used to inject drugs. Venturi was found to be under the influence of a controlled substance, and was arrested for drug influence, and for possessing drug paraphernalia, heroin, and methamphetamine. 14-2338

On August 6th at about 2:30 AM Ukiah Police responded to a residence in the 100 block of Evans Street for a physical domestic fight with the female who had been seen naked lying in the street, and the male had apparently kicked the female. Officers were met at the front door by 27 year old Ashley Ryan Lenhart, who was intoxicated and belligerent and refused to allow officers inside. Officers eventually forced their way into the residence while Lenhart physically resisted, and she was eventually arrested for interfering with an officer. Officers located 27 year old Robert Frederick Fackrell inside the residence, who was trying to calm Lenhart and coax her into cooperating with the officers. Fackrell had two warrants for his arrest for violating probation and driving with a suspended driver's license. After speaking with numerous witnesses it was determined there had been a physical altercation between Lenhart and Fackrell, and he was arrested for the warrant sand for domestic violence. 14-2340
