Statistics

Arrests included: 8 warrant arrests, 8 for public intoxication, 6 for being under the influence of a controlled substance and/or possessing drug paraphernalia, 4 for shoplifting, 4 for violating probation or parole, 2 for possessing marijuana, and 1 each for; possessing a narcotic, child abuse, possessing stolen property, illegal weapons possession, and domestic violence. Probation or parole holds were placed on 11 of these arrests.

Officers investigated 1 traffic collision, 1 hit and run traffic collision, and 1 death by apparent natural causes.

Officers investigated and took reports of: 5 vandalisms, 4 found property, 2 suicidal subjects, 2 burglaries, 2 batteries, 2 missing persons, 2 domestic violence, and 1 each of; abandoned vehicle, theft, rape, robbery, assault with injury, and animal bite.

Officers assisted the Mendocino County Sheriff's Office with a vehicle stop pursuant to a shots fired call, wherein a convicted felon was found to possess an assault rifle.

Highlights for the Week

On October 9th at about 10:25 AM Ukiah Police received a report of a possible child neglect occurring within the City of Ukiah. Officers were told at about 9:50 AM, 31 year old Maia Oak Atkinson was found passed out in her room at a shared residence, and her 1 year old child was awake and crying. Atkinson was found to have been drinking and was very intoxicated. Officers determined Atkinson had earlier left the child alone for approximately 1 hour. Atkinson was arrested for child abuse. 14-3098

On October 12th at about 3:20 AM a Ukiah Police Officer was driving north in the 600 block of North Oak Street, and observed a vehicle stopped, facing south and straddling the roadway. The vehicle suddenly accelerated around the patrol vehicle squealing its tires, and drove east on Scott Street at a high rate of speed. The officer caught up to the vehicle as it stopped in the 500 block of North School Street and saw its headlights turn off. The officer approached the driver's side of the vehicle and saw an open beer can in the console, and contacted the driver identified as 19 year old Michael Donovan Martinez Pearson. The officer noticed marijuana smoking paraphernalia in the vehicle, and Pearson stated he thought he was parked near Vinewood Park. The officer noticed Pearson had been drinking and asked him to exit the vehicle. Pearson responded by trying to start the vehicle, and he had to be removed from the driver's seat to stop him from fleeing again. Pearson was found too intoxicated to drive and was arrested for DUI and possessing alcohol by a minor. A large number of unopened beers were located inside the trunk of the vehicle. 14-3130
