### **Statistics**

**Arrests included: 8 for public intoxication, 7 warrant arrests, 7 for possessing methamphetamine, 5 for resisting arrest, 5 for fighting in public, 4 for shoplifting, 3 for being under the influence of a controlled substance and/or possessing drug paraphernalia, 3 for domestic violence, 2 for violating probation or parole, and 1 each for; vandalism, battery on a police officer, vehicle pursuit, sales of marijuana, and possessing marijuana. Probation or parole holds were placed on 7 of these arrests.**

**Officers investigated 1 traffic collision and 1 hit and run traffic collision.**

**Officers investigated and took reports of: 5 found property, 2 thefts, 2 vandalisms, 2 missing persons, 2 abandoned vehicles, 2 animal bite, 2 threats, and 1 each of; burglary, suicidal subject, domestic violence, and assault with a dangerous weapon.**

**The Patrol Division's average response time to in-progress calls was a little over 4 ½ minutes. The average response time to all other calls was a little less than 12 minutes.**

### **Highlights for the Week**

On October 29th at about 9:20 PM a Ukiah Police Sergeant observed a vehicle traveling at a high rate of speed east on Brush Street. The Sergeant caught up to the vehicle as it turned into the apartment complex at 610 North Orchard Avenue and attempted to stop the vehicle. The vehicle sped through the parking lot, and headed west on Clara Avenue with the Sergeant in pursuit. The vehicle continued south on Mason Street at over 60 miles per hour, ran the stop sign at Perkins Street nearly colliding with another vehicle, then fled south on Leslie Street exceeding 70 miles per hour. The pursuit continued to Gobbi Street then south on Waugh Lane before heading west on Talmage Road with the vehicle continuing at high speeds, and failing to stop for stop signs. The vehicle turned north onto Cunningham Street, west on Thomas Street, then crossed State Street and onto Observatory Avenue at a high rate of speed and without stopping for stop signs. The vehicle drove into the Surgery Center parking lot, at 271 Observatory Avenue, and the driver and two occupants fled on foot. The driver jumped a fence and was able to elude officers.

One of the passengers, a 15 year old male juvenile was captured after a foot pursuit to the 1100 block of Observatory Avenue. A variety of weapons were located in the vehicle including a meat cleaver and a baseball bat, and it is believed the occupants of the vehicle may have been seeking members of an opposing street gang. The 15 year old juvenile was arrested for possessing illegal weapons, resisting arrest, and violating probation. The owner of the vehicle arrived and reported the owner's 16 year old son and 15 year old male juvenile companion had taken the vehicle without permission earlier that evening. The owner reported the vehicle stolen, and it was returned after the weapons were removed.

The following day, October 30th, Mendocino County Deputy Probation Officers arrested the other 15 year old male juvenile suspect who was then questioned by Ukiah Police Detectives. The 15 year old male juvenile was charged with possessing illegal weapons, resisting arrest, stolen vehicle, and violating probation. On December 7<sup>th</sup> at about 12:30 PM Ukiah Police Officers responded to Vinewood Park, at 1260 Elm Street, for a group of subjects, one of whom brandished a knife. The arriving officers observed three subjects seated at a table, who began running and refused officers' commands to stop. One of the subjects slipped and fell, and the remaining subjects stopped and were all arrested for resisting arrest. One of the subjects was identified as the 16 year old male juvenile wanted in connection with the stolen vehicle and

vehicle pursuit in October. This juvenile had a warrant for his arrest and was on probation, and was booked into Juvenile Hall for resisting arrest, stolen vehicle, vehicular evasion, weapons possession, violating probation, and the outstanding warrant. 14-3662

On December 8<sup>th</sup> at about 11:50 PM Ukiah Police responded to the area of 600 North Orchard Avenue for a loud disturbance. Arriving officers located a 14 year old, a 16 year old, and a 17 year old male juveniles and a 14 year old female juvenile involved in a mutual struggle. All subjects were intoxicated and were arrested for fighting in public and public intoxication. A short time later a 13 year old male juvenile called the police requesting a ride home from the area near Kohl's, at 437 North Orchard Avenue. The arriving officer found the male juvenile very intoxicated and determined he was involved with the other 4 subjects prior to police arrival. The 13 year old male juvenile became extremely belligerent and was arrested for public intoxication, and proceeded to try and spit on officers. 14-3667

On December 8<sup>th</sup> at about 9:45 AM Ukiah Police responded to Pomolita Middle School regarding the sales of marijuana. Offices learned on December 5<sup>th</sup> a 12 year old male juvenile student had offered to sell other students marijuana cookies, and had sold at least one to another student. The 12 year old male juvenile was arrested for sales of marijuana. 14-3671
