Statistics

Arrests included: 11 warrant arrests, 5 for public intoxication, 5 for fighting at school, 4 for drug possession, 2 for domestic violence, 2 for being under the influence of a controlled substance and/or possessing drug paraphernalia, 2 for assaulting an officer, and 1 each for; shoplifting, assault with great bodily injury, vehicle pursuit, possession of a dangerous weapon, and violation of a court order. Probation or parole holds were placed on 3 of these arrests.

Officers investigated 4 traffic collisions.

Officers investigated and took reports of: 12 found property, 2 missing persons, 2 battery, 2 domestic disputes, 2 vandalisms, 2 fraud, 4 thefts, and 1 each for; elder abuse, suspicious circumstance, mental health evaluation, , burglary, robbery, assault with a deadly weapon, animal cruelty, death investigation and one abandoned vehicle.

The Patrol Division's average response time to in-progress calls was a little less than 5 minutes. The average response time to all other calls was a little less than 16 minutes.

Highlights for the Week

On 02/12/2015 at about 1010 PM, Ukiah Police Department Officers located a vehicle behind a closed business located at 701 Talmage Rd. When Officers went to investigate the driver, later identified as 47 year old Alan Crow, fled in the vehicle, which was determined to be stolen. Officers pursued the vehicle as it failed to yield driving into the Norgard orchard on Hastings Rd. A perimeter was established and the vehicle was observed driving south through the orchard. The vehicle was then observed driving west in the orchard where it was seen crashing through a fence and onto Hastings Rd. going north.

As the vehicle went north it attempted make a right turn, losing control and crashing into a fence on Hastings Frontage Rd. Due to the amount of damage to the vehicle the driver, Crow, was unable to exit out of the driver side door. Crow was ordered to exit out the passenger side door and stated he was unable to do so due to injuries. Crow was assisted out of the vehicle and taken into custody without further incident. Crow was transported to Ukiah Valley Medical Center (UVMC) for a medical treatment and later booked into the county jail for evading arrest and a warrant for violation of his PRCS terms. 15-0474

On 02/14/2015 at about 430 AM, Ukiah Police Department responded to Ukiah Valley Medical Center (UVMC) for a possible assault. Upon Officers arrival an adult male victim was contacted. The victim explained he was walking eastbound in the 300 block of E. Gobbi St. on the north sidewalk when 4 to 5 subjects approached him asking for money. The victim told the subjects that he did not have any money and continued walking away from the group. As the victim walked away he was struck in the back of his head multiple times causing him to fall to the ground. While on the ground subjects surrounded the victim and continued to strike him with their hands and feet. The victim claimed to have lost consciousness during which time his wallet was taken and the subjects fled the area. The victim then walked to the ER at which time UPD was notified. 15-0487

On 02/14/2015, at about 852 AM, Ukiah Police Department responded to the Gardens Ave. area regarding a male who had vandalized a car. The male was later identified as 25 year old Jesus Alvarez. Alvarez was located at an address on Gardens Ave. When Officers contacted Alvarez, he immediately began cursing at them and threatened the Officers. Officers attempted to calm Alvarez but were unable to do so as he became more hostile towards them. Given the

Officers were attempting to conduct an investigation in which Alvarez was a possible suspect, they went to detain. Alvarez resisted by struggling to free himself and kicking one of the officers in the knee causing injury. Alvarez was taken into custody and booked in the county jail for assault on an officer and resisting arrest. 15-0490

On 02/15/15 at about 923 PM, Ukiah Police Department responded to 1105 Airport Park Bl., Quick Stop, for a report of a male subject striking a vehicle with a bat and armed with a knife. This subject was later identified as 53 year old Thomas Collins. On arrival, Officers observed Collins on the roof of a green Jeep Cherokee parked in the parking stall in front of the Quick Stop convenience store. When Officers went to contact Collins they observed that he was armed with the bat and a knife.

Officers attempted to order Collins to put down these weapons several times Collins refused to drop either the knife or bat and told them "Shoot me" and "You're gonna have to kill me". Collins then jumped off the roof of the vehicle onto the pavement and began approaching the officers with the bat raised in left hand and holding the knife upward in front of him. Collins was ordered to stop, to drop the weapons in his hands and lay down on the ground away from the weapons.

Based on Collins demeanor, his statements, along with that he was armed with the bat and a knife and refusing to drop them that he presented a very credible threat of serious injury or death to Officers and those in the area. An Officer discharged a Taser at Collins' upper body. This Taser deployment allowed Officers enough time to disarm Collins and take him into custody without further incident.

Collins was taken to the Ukiah Valley Medical Center for treatment due to the Taser Deployment and later booked into the county jail. Collins was booked for possession of a dangerous weapon, resisting/delaying an officer, and branding a weapon. 15-0512

On 02/16/15, at about 221 PM, Ukiah Police Department responded to the intersection of S. Orchard and E. Gobbi St regarding a male adult lying in the middle of the roadway. Upon Officers arrival they observed several vehicles stopped in the roadway in the 700 block of S. Orchard Ave. and a male sitting in the roadway in front of the vehicles. This subject was later identified as 24 year old Jorge Lombera.

Officers went to make contact with Lombera to determine if he was okay and to have him remove himself from the roadway. During this contact Lombera displayed symptoms of drug intoxication and his demeanor fluctuated without reason. Lombera was asked to remove himself from the roadway and he refused. After asking Lombera to move several times, Lombera became agitated and approached the Officer. When Lombera reached the Officer, he was agitated and his demeanor was hostile towards the Officer. Lombera then appeared to start to hit the Officer causing the Officer to take hold of Lombera's arm and force him to the ground.

While on the ground Lombera continued to struggle with the Officer as the Officer requested additional Officers to assist. As the Officer struggled with Lombera several attempts were made to gain control of him, but Lombera continued to struggle striking the Officer in the face. Due to Lombera's behavior and his continual resistance a Taser was deployed on Lombera. This Taser deployment incapacitated Lombera long enough for Officers now on scene to gain control of him and place him under arrest. Lombera was taken to the Ukiah Valley Medical Center where he was treated for the Taser deployment and later booked into the county jail for assault on an Officer and resisting an Officer. 15-0517
